LIMITATION AND DISCLOSURE OF FINANCE CHARGES ACT, 1968 (ACT 73 OF 1968)

REGULATIONS REGARDING MAXIMUM FINANCE CHARGE RATES

Under the powers vested in me by section 16 of the Limitation and Disclosure of Finance Charges Act, 1968 (Act 73 of 1968), and section 2 (2) of the Limitation and Disclosure of Finance Charges Amendment Act, 1974 (Act 62 of 1974), I, Nicolaas Diederichs, Minister of Finance, hereby make the following regulations:

1. For the purposes of paragraph (a) of section 2 (1) of the Limitation and Disclosure of Finance Charges Act, 1968 (hereinafter referred to as the Act), I prescribe a percentage of twenty-one with effect from 28 October 1974.

2. For the purposes of paragraph (b) of section 2 (1) of the Act, I prescribe a percentage of seventeen and one-half with effect from 28 October 1974.

3. For the purposes of paragraph (c) of section 2 (1) of the Act, I prescribe a percentage of fourteen with effect from 14 August 1974.

4. For the purposes of section 2 (2) of the Act, I prescribe a percentage of twenty-one with effect from 28 October 1974.

Kragtens die bevoegdheid my verleen by artikel 16 van die Wet op Beperking en Bekendmaking van Finansieringskoste, 1968 (Wet 73 van 1968), en artikel 2 (2) van die Wysigingswet op Beperking en Bekendmaking van Finansieringskoste, 1974 (Wet 62 van 1974), vaardig ek, Nicolaas Diederichs, Minister van Finansies, hierby die volgende regulasies uit:

1. Vir die doeleindes van paragraaf (a) van artikel 2 (1) van die Wet op Beperking en Bekendmaking van Finansieringskoste, 1968 (hierna die Wet genoem) skryf ek 'n persentasie voor van een-en-twintig met ingang van 28 Oktober 1974.

2. Vir die doeleindes van paragraaf (b) van artikel 2 (1) van die Wet skryf ek 'n persentasie voor van sewentien-en-'n-half met ingang van 28 Oktober 1974.

3. Vir die doeleindes van paragraaf (c) van artikel 2 (1) van die Wet skryf ek 'n persentasie voor van veertien met ingang van 14 Augustus 1974.

4. Vir die doeleindes van artikel 2 (2) van die Wet skryf ek 'n persentasie voor van een-en-twintig met ingang van 28 Oktober 1974.
