No. R. 774 18 April 1975

STATE AIRPORT REGULATIONS, 1963

The Minister of Transport has, in terms of section 22 of the Aviation Act, 1962 (Act 74 of 1962), as amended, made the regulations contained in the Schedule hereto.

SCHEDULE 11

The State Airport Regulations, 1963, as promulgated under Government Notice R. 1974 of 20 December 1963, and as amended*, are hereby further amended as follows with effect from 1 May 1975:

1. The following regulation is inserted after regulation 13:

"AIRPORT CHARGES"

13A. (1) Subject to subregulations (2) and (3), the scale of landing and parking charges shall be as prescribed in Annex E.

(2) At the B. J. Vorster (Kimberley), Ben Schoeman (East London), H. F. Verwoerd (Port Elizabeth), J. G. H. van der Wath (Keetmanshoop) and Upington Airports, in respect of an aircraft with a maximum certificated mass of not more than 1 500 kg which is not being operated in terms of an air carrier's licence issued under the Air Services Act, 1949 (Act 51 of 1949), a landing charge of R1,50 per landing shall apply.

(3) When a landing is carried out solely for aircrew training, the landing charge shall be 20 per cent of the appropriate charge prescribed in Annex E: Provided that and notwithstanding subregulation (2), at the B. J. Vorster (Kimberley), Ben Schoeman (East London), H. F. Verwoerd (Port Elizabeth), J. G. H. van der Wath (Keetmanshoop) and Upington Airports, in respect of all landings during a training flight carried out solely for aircrew training and while the same person is acting as pilot of the aircraft one charge of R1,00 shall apply when the aircraft has a maximum certificated mass of not more than 500 kg, and one charge of R1,25, R1,50 and R2,00 when the aircraft has a maximum certificated mass of not more than 1 000, 1 500 and 2 000 kg, respectively.".

(3) Wanneer 'n landing uitsluitlik vir lugbemanningsopleiding uitgevoer word, is die landingsgeld 20 persent van die toepaslike heffing voorgeskryf in Aanhangsel E: Met dien verstande dat, en ondanks subregulasie (2), by die B. J. Vorster- (Kimberley), Ben Schoeman- (Oos London), H. F. Verwoerd- (Port Elizabeth), J. G. H. van der Wath- (Keetmanshoop) en Upingtonlughawe, ten opsigte van alle landings gedurende 'n opleidingsvlug wat uitsluitlik vir lugbemanningsopleiding uitgevoer word en terwyl dieselfde persoon as vlieënier van die lugvaartuig optree een heffing van R1,00 van toepassing is waar die lugvaartuig 'n maksimum gesertifiseerde massa van hoogstens 500 kg het, en een heffing van R1,25, R1,50 en R2,00 waar die lugvaartuig 'n maksimum gesertifiseerde massa van hoogstens, respektiewelik 1 000, 1 500 en 2 000 kg het".

SCHEDULE 34

The Air Navigation Regulations, 1963, as promulgated by Government Notice R. 1779 of 15 November 1963, and as amended*, are hereby further amended as follows with effect from 1 May 1975:

1. Regulation 22.10 is amended—
