EDUCATION AND TRAINING FUND AGREEMENT

I, Marais Viljoen, Minister of Labour, hereby—

(a) in terms of section 48 (1) (a) of the Industrial Conciliation Act, 1956, declare that all the provisions of the Agreement which appears in the Schedule hereto and which relates to the Iron, Steel, Engineering and Metallurgical Industries, shall be binding, with effect from the first Monday after the date of publication of this notice and for the period ending five years from the said Monday upon the employers' organisations and the trade unions which entered into the said Agreement and upon the employers and employees who are members of the said organisations or unions;

(b) in terms of section 48 (1) (b) of the said Act, declare that the provisions of the said Agreement, excluding those contained in clauses 1 and 2, shall be binding, with effect from the first Monday after the date of publication of this notice and for the period ending five years from the said Monday, upon all employers and employees other than those referred to in paragraph (a) of this notice, who are engaged or employed in the said Industries in the Republic of South Africa; and

(c) in terms of section 48 (3) (a) of the said Act, declare that in the Republic of South Africa and with effect from the first Monday after the date of publication of this notice and for the period ending five years from the said Monday, the provisions of the said Agreement, excluding those contained in clauses 1 and 2, shall *mutatis mutandis* be binding upon all Bantu employed in the said Industries by the employers upon whom any of the said provisions are binding in respect of employees and upon those employers in respect of Bantu in their employ.

being parties to the National Industrial Council for the Iron, Steel, Engineering and Metallurgical Industry.

## 1. PERIOD OF OPERATION OF THE AGREEMENT

This Agreement shall come into operation on such date as may be fixed by the Minister of Labour in terms of section 48 of the Industrial Conciliation Act, 1956, and shall remain in force for a period of five years or for such period as the Minister may determine.

## 2. SCOPE OF APPLICATION OF AGREEMENT

The terms of this Agreement shall be observed throughout the Republic of South Africa by employers in the Iron, Steel, Engineering and Metallurgical Industry who are members of the employers' organisations.

## 1. GELDIGHEIDSDUUR VAN OOREENKOMS

Hierdie Ooreenkoms tree in werking op die datum wat deur die Minister van Arbeid kragtens artikel 48 van die Wet op Nywerheidsversoening, 1956, vasgestel word en bly van krag vir 'n tydperk van vyf jaar of vir die tydperk wat die Minister kan bepaal.

## 2. TOEPASSINGSBESTEK VAN OOREENKOMS

Hierdie Ooreenkoms moet oral in die Republiek van Suid-Afrika nagekom word deur werkgewers in die Yster-, Staal-, Ingenieurs- en Metallurgiese Nywerheid waf lede van die werkgewersorganisasie is.

### 3. DEFINITIONS

Any expressions used in this Agreement which are defined in the Industrial Conciliation Act, 1956, shall have the same meaning as in that Act, and any reference to an Act shall include any amendments to such Acts; further, unless inconsistent with the context—

“Act” means the Industrial Conciliation Act, 1956;

“Council” means the National Industrial Council for the Iron, Steel, Engineering and Metallurgical Industry;

“Fund” means the Metal and Engineering Industries Education and Training Fund;

“Iron, Steel, Engineering and Metallurgical Industries”, or “Industries” means (subject to the provisions of the Demarcation Determinations published under Government Notices R. 1971 of 30 November 1962, R. 260 of 3 March 1967 and R. 2238 of 10 December 1971), the industries concerned with the production of iron and/or steel and/or alloys and/or the processing and/or recovery and/or refining of metals (other than precious metals) and/or alloys from dross and/or scrap and/or residues; the maintenance, fabrication, erection or assembly, construction, alteration, replacement or repair of any machine vehicle (other than a motor vehicle) or article consisting mainly of metal (other than a precious metal), or parts or components thereof and structural metal work, including steel reinforcement work; the manufacture of metal goods, principally from such iron and/or steel and/or other metals (other than precious metals), and/or alloys and/or the finishing of metal goods, the building and/or alteration and/or repair of boats and/or ships, including the scraping, shipping and/or scaling and/or painting of the hulls of boats and/or ships and general woodwork undertaken in connection with ship repairs, and includes the Electrical Engineering Industry, Lift and Escalator Industry and Plastics Industry but does not include the Motor Industry;

“Electrical Engineering Industry” means—

(a) the manufacture and/or assembly for component parts of electrical equipment, namely generators, motors, converters, switch and control gear (including relays, contactors, electrical instruments and equipment associated therewith), electrical lighting, heating, cooking, refrigeration and cooling equipment, transformers, furnace equipment, signalling equipment, radio or electronic equipment and other equipment utilising the principles used in the operation of radio and electronic equipment, incandescent lamps and electrical cables and domestic electrical appliances, and includes the manufacture of component parts of the aforementioned equipment;

(b) the installation, maintenance and repair of the equipment referred to in paragraph (a) above in the Province of the Transvaal, but does not include the Electrical Contracting Industry;

“Electrical Contracting Industry” means the design, preparation (other than manufacture for sale) and erection of electrical installations forming an integral and permanent portion of buildings and the repair and/or maintenance of such installations, including any cable jointing and electrical wiring associated therewith;

“Lift and Escalator Industry” means the manufacture and/or assembly and/or installation and/or repair of electrical lifts and escalators;

“Plastics Industry” means the manufacture of articles or parts of articles wholly or mainly from plastics, but does not include the manufacture of the following articles made from plastic sheeting material, viz.—wearing apparel, bags and handbags, boots, shoes, overshoes, upholstery coverings and plastic venetian blinds;

“plastics” means any one of the group of materials which consists of or contains as an essential ingredient an organic substance of a large molecular mass and which while solid in the finished state, at some stage in its manufacture has been or can be forced, i.e. cast, calendered, extruded or moulded into various shapes, by flow, usually through the application, singly or together, of heat and pressure;

“precious metals” means the precious metals, gold, silver, platinum and/or palladium and/or any alloy containing the said precious metals or any of these in such proportion with any other metals as to be the greater part in value of such alloy;

“Motor Industry” means (subject to the provisions of the Demarcation Determinations published under Government Notices R. 1971 of 30 November 1962 and R. 2238 of 10 December 1971)—

(a) assembling, erecting, testing, remanufacturing, repairing, adjusting, overhauling, wiring, upholstering, spraying, painting and/or reconditioning carried on in connection with—

(i) chassis and/or the bodies of motor vehicles;

(ii) internal combustion engines and transmission components of motor vehicles;

(iii) the electrical equipment connected with motor vehicles, including radios;

### 3. WOORDOMSKRYWINGS

Alle uitdrukking wat in hierdie Ooreenkoms gebesig en in die Wet op Nywerheidsversoening, 1956, omskryf word, het dieselfde betekenis as in daardie Wet, en alle verwysings na 'n Wet moet alle wysigings van sodanige Wet insluit; voorts, tensy dit onbestaanbaar met die samehang is, beteken—

“Wet” die Wet op Nywerheidsversoening, 1956;

“Raad” die Nasionale Nywerheidsraad vir die Yster-, Staal-, Ingenieurs- en Metallurgiese Nywerheid;

“Fonds” die Opvoedkundige en Opleidingsfonds van die Metaal- en Ingenieursnywerheid;

“Yster-, Staal-, Ingenieurs- en Metallurgiese Nywerheid”, of “Nywerheid” (behoudens die Afbakeningsvasselling gepubliseer by Goewermentskennisgewings R. 1971 van 30 November 1962, R. 260 van 3 Maart 1967 en R. 2238 van 10 Desember 1971), die nywerhede wat hulle self toelê op die produksie van yster en/of staal en/of legerings en/of die verwerking en/of herwinning en/of raffinering van metale (uitgesonderd edelmetale) en/of legerings uit metaalskuim en/of afvalmetaal en/of residu's; die onderhoud, vervaardiging, oprigting of montering, bou, verandering, vervanging of herstel van of aan enige masjiën, voertuig (uitgesonderd 'n motorvoertuig) of artikel wat hoofsaaklik uit metaal bestaan (uitgesonderd 'n edelmetale), of gedeeltes of onderdele daarvan en struktuurmetaalwerk, met inbegrip van staalwapeningwerk; die vervaardiging van metaalgoedere hoofsaaklik uit sodanige yster en/of staal en/of ander metale (uitgesonderd edelmetale), en/of legerings en/of die afwerking van metaalgoedere, die bou en/of verandering en/of herstel van bote en/of skepe, met inbegrip van die afskraap, afbik en/of afskaal en/of verf van die rompe van bote en/of skepe en algemene houtwerk wat in verband met skeepsherstelwerk onderneem word, en sluit in die Elektrotegniese Ingenieursnywerheid, die Hyser- en Roltrapnywerheid en die Plastieknywerheid maar nie die Motornywerheid nie;

“Elektrotegniese Ingenieursnywerheid”—

(a) die vervaardiging en/of inmekaarsit uit samstellende dele van elektriese uitrusting, nl. generators, motore, konvertors, skakel- en beheergerei (met inbegrip van relês, kontakters, elektriese instrumente en uitrusting wat daar mee gepaard gaan), elektriese verligtings-, verwarmings-, kook-, vries- en koel-uitrusting, transformators, oonduitrusting, seinuitrusting, radio- of elektroniese uitrusting en ander uitrusting wat gebruik maak van die beginsels toegepas by die bediening van radio- en elektroniese uitrusting, gloeilampe en elektriese kabels en huis-houlike elektriese toestelle, en sluit in die vervaardiging van samstellende dele van genoemde uitrusting;

(b) die installering, onderhoud en herstel van die uitrusting vermeld in paragraaf (a) hierbo in die provinsie Transvaal, maar nie die Elektrotegniese Aannemingsnywerheid nie;

“Elektrotegniese Aannemingsnywerheid” die ontwerp, bereiding (uitgesonderd vervaardiging vir verkoop) en oprigting van elektriese installasies wat 'n integrerende en permanente deel van geboue uitmaak en die herstel en/of onderhoud van sodanige installasies, met inbegrip van alle kabellaswerk en elektriese bedrading wat daar mee gepaard gaan;

“Hyser- en Roltrapnywerheid” die vervaardiging en/of inmekaarsit en/of installering en/of herstel van elektriese hysers en roltrappe;

“Plastieknywerheid” die vervaardiging van artikels of gedeeltes van artikels hoofsaaklik of gedeeltelik uit plastiek, maar nie die vervaardiging van ondergenoemde artikels wat van dun plastiek-plaatmateriaal gemaak word nie, nl. kledingstukke, sakke en handsakke, stewels, skoene, oorskoene, stofferoortreksels en plastiese hortjiesbindings;

“plastiek” enigeen van die groep materiale wat 'n organiese stof van groot molekulêre massa as 'n noedsaaklike bestanddeel bevat of daaruit bestaan en wat, hoewel dit in die afgewerkte stadium solied is, in een of ander stadium gedurende die vervaardiging daarvan geforseer is, of geforseer kan word; dit wil sê gegiet, gekalandeer, uitgedruk of in verskillende vorms gegiet is of gegiet kan word deur middel van vloeiing, gewoonlik deur die aanwending, hetsy alleen of gesamentlik, van hitte en druk;

“edelmetale” die edelmetale goud, silwer, platinum en/of palladium en/of enige legering wat genoemde edelmetale of enige daarvan in sodanige verhouding tot 'n ander metaal bevat dat dit, wat waarde betref, die grootste gedeelte van sodanige legering uitmaak;

“Motornywerheid” (behoudens die Afbakeningsvassellings gepubliseer by Goewermentskennisgewings R. 1971 van 30 November 1962 en R. 2238 van 10 Desember 1971)—

(a) montering, bou, toetsing, hervervaardiging, herstel, verstel, opknapping, bedrading, stoffeer, bespuiting, verf en/of vernuwing uitgevoer in verband met—

(i) onderstelle en/of bakke van motorvoertuie;

(ii) binnebrandenjins en transmissie-onderdele van motorvoertuie;

(iii) elektriese uitrusting in verband met motorvoertuie, met inbegrip van radio's;

- (b) automotive engineering;
- (c) repairing, vulcanising and/or retreading tyres;
- (d) repairing, servicing and reconditioning batteries for motor vehicles;
- (e) the business of parking and/or storing motor vehicles;
- (f) the business conducted by filling and/or service stations;
- (g) the business carried on mainly or exclusively for the sale of motor vehicles or motor vehicle parts and/or spares and/or accessories (whether new or used) pertaining thereto, whether or not such sale is conducted from premises which are attached to a portion of an establishment wherein is conducted the assembly of or repairs to motor vehicles;
- (h) the business of motor graveyards;
- (i) the business of assembly establishments;
- (j) the business of manufacturing establishments wherein are fabricated motor vehicle parts and/or spares and/or accessories and/or components thereof;
- (k) vehicle body building.

For the purpose of this definition—

“automotive engineering” means the reconditioning of internal combustion engines or parts thereof for use in motor vehicles in establishments mainly or exclusively so engaged whether such establishment is engaged in the dismantling and repair of motor vehicles or not;

“motor vehicle” means any wheeled conveyance propelled by electrical or mechanical power (other than steam) and designed for haulage and/or for the transportation of persons and/or goods and/or loads, including trailers and caravans, but shall not include any equipment designed to run on fixed tracks, trailers designed to transport loads of 18 144 kg or over or aircraft;

“vehicle body building” means any or all of the following activities carried on in a vehicle body building establishment:

- (a) The construction, repair or renovation of cabs and/or bodies and/or any superstructures, for any type of vehicle;
- (b) the manufacture or repair of component parts for cabs and/or bodies and/or any superstructure and the assembling, adjusting and installation of parts in cabs, bodies or on the superstructure of vehicles;
- (c) fixing cabs and/or bodies and/or any superstructure to the chassis of any type of vehicle;
- (d) coating and/or decorating cabs and/or bodies and/or any superstructure with any preservative or decorative substance;
- (e) equipping, furnishing and finishing off the interior of cabs and/or bodies and/or superstructures;
- (f) building of trailers, but not including the manufacture of wheels or axles therefor;
- (g) all operations incidental to or consequent upon the activities referred to in paragraphs (a), (b), (c), (d), (e) and (f).

For the purpose of this definition “vehicle” does not include an aircraft, and “motor industry” as defined above shall not include the following:

- (a) The manufacture of motor vehicle parts and/or accessories and/or spares and/or components thereof in establishments laid out for and normally producing metal and/or plastic goods of a different character on a substantial scale;
- (b) the assembling, erecting, testing, repairing, adjusting, overhauling, wiring, spraying, painting and/or reconditioning of agricultural tractors except where carried on in establishments rendering similar service in respect of motor cars, motor lorries or motor trucks;
- (c) the manufacture and/or maintenance and/or repair of—

- (i) civil and mechanical engineering equipment and/or parts thereof whether or not mounted on wheels;
- (ii) agricultural equipment or parts thereof; or
- (iii) equipment designed for use in factories and/or workshops: Provided that for the purposes of (a), (b) and (c) above “equipment” shall not be taken to mean motor cars, motor lorries and/or motor trucks;
- (iv) motor vehicles or other vehicle bodies and/or superstructure and/or parts of components thereof made of steel plate of 3,5 mm thickness or thicker when carried on in establishments laid out for and normally engaged in the manufacture and/or maintenance and/or repair of civil and/or mechanical engineering equipment on a substantial scale;

“machine” means any appliance, irrespective of the material of which it is made, but does not include an agricultural tractor; “metal goods” does not include agricultural tractors;

“Region A” means the Magisterial Districts of Beaufort West, Bellville, Bredasdorp, Caledon, Calvonia, The Cape, Carnarvon, Clanwilliam, Ceres, Fraserburg, George, Goodwood, Heidelberg (Cape), Hermanus, Hopefield, Knysna, Kuils River, Ladismith (Cape), Laingsburg, Malmesbury, Montagu, Mossel Bay,

- (b) motoringenieurswerk;
- (c) die herstel, vulkaniseer en/of versool van buitebande;

#### 4. METAL AND ENGINEERING INDUSTRIES EDUCATION AND TRAINING FUND

(1) The Council having been advised of the establishment of the Metal and Engineering Industries Education and Training Fund hereby authorises for the purpose of implementing the objects set forth in the Constitution of the Fund the collection of levies in accordance with the procedure detailed hereunder.

(2) (a) As from the date of the coming into force of this Agreement, each employer shall, in respect of each employee referred to in paragraph (c) hereunder, pay to the Fund a monthly levy.

(b) The total amount of the levy payable each month shall be calculated on the basis of R7,80 multiplied by the number of employees, mentioned in paragraph (c), on the employer's payroll and/or hired out by him on the last Friday of the calendar month to which payment of the levy refers.

(c) For purposes of the above, "employee" shall mean any person, other than an apprentice, employed on work specified at Rate A in the Main Agreement or employed by an employer falling within the Iron, Steel, Engineering and Metallurgical Industries as defined in section 3 of this Agreement on trades

(5) Indien enige bedrag wat ingevolge hierdie klousule, verskuldig is, nog nie deur die Raad ontvang is teen die 15de dag van die maand wat volg op die maand waarvoor dit betaalbaar is nie, moet die werkewer rente betaal op sodanige bedrag of kleiner bedrag as wat onbetaald oorby, bereken teen 1 persent per maand of deel daarvan vanaf sodanige 15de dag tot op die dag waarop betaling in kontant werklik deur die betrokke Streeksraad ontvang is: Met dien verstaande dat die Raad na sy eie absolute goedvindie dieregsbevoegdheid het om die betaling van sodanige rente of 'n deel daarvan kwyt te skeld.

(6) Kopieë van die konstitusie en van die geoudiere jaarlike rekenings en balansstate van die Fonds moet aan die Raad en die Sekretaris van Arbeid voorgele word. Vir die toepassing van hierdie subklousule omvat die uitdrukking "konstitusie" alle wysigings van die konstitusie wat van tyd tot tyd aangeneem word.
