PRICE CONTROL.—MAXIMUM PRICES OF FERTILIZER

I, Elias George de Beer, Deputy Price Controller, acting under the power assigned to me by the Price Controller in terms of section 3 of the Price Control Act, 1964 (Act 25 of 1964), do hereby, in terms of section 4 of the said Act, amend Government Notice R. 115 (*Government Gazette* 4969) of 23 January 1976 by the substitution of paragraph 7 thereof by the following:

“7. The following Government Notices relating to the maximum prices of fertilizers are hereby withdrawn:

Nos. R. 313 of 14 February 1975 and R. 1626 of 15 August 1975.”
