PROCLAMATION

by the State President of the Republic of
South Africa

No. R. 73, 1977

DESCRIPTION OF THE AREA WITHIN WHICH
THE SOUTH AFRICAN RAILWAYS AND HAR-
BOURS ADMINISTRATION HAS JURISDICTION
AT THE HARBOUR OF WALVIS BAY

Under the powers vested in me by section 1 (1) (ii) of
the Railways and Harbours Control and Management
(Consolidation) Act, 1957 (Act 70 of 1957), I hereby—

- (a) repeal Proclamation 125 of 1917, as amended by
Proclamations 170 of 1932 and R. 70 of 1971; and
(b) proclaim the area described below as a harbour
within the jurisdiction of the Administration of the
South African Railways and Harbours:

WALVIS BAY HARBOUR

The area bounded—

(a) on the south by a line drawn west (true) from a
point (A) on the high water mark of the Atlantic
Ocean through a point in position $22^{\circ} 57' 38.0''$ S;
 $14^{\circ} 28' 55.7''$ E (which is the intersection of the S.A.R.
boundary produced in a south-westerly direction and the
south-western boundary of the Esplanade produced in
a north-westerly direction), to a point (B) on the high
water mark of the Atlantic Ocean on the western side of
the Walvis Peninsula;

(b) on the west by—

(i) the high water mark of the Atlantic Ocean from
the last mentioned point (B) to the point of intersection
(C) of the high water mark of the Atlantic Ocean with
a line drawn north (true) from the Pelican Point Light-
house; and

(ii) a line draw north (true) from the said point of
intersection (C) to a point (D) 4 km from the Pelican Point Lighthouse;

(c) on the north by a line drawn east (true) from the
last mentioned point (D) to a point (E) on the high
water mark of the Atlantic Ocean on the mainland; and

(d) on the east by the high water mark of the Atlan-
tic Ocean from the last mentioned point (E) to the
first mentioned point (A), except within the Fishing

tot by die eersgenoemde punt (A), behalwe binne-in die

Harbour Area where it shall be the old high water mark of the Atlantic Ocean, according to Municipal Proclamation 79 of 1968;

inclusive of the islands, jetties, harbour works and harbour lands vested in the Government of the Republic of South Africa.

SOUTH AFRICAN RESERVE BANK

In terms of Proclamation R. 184, 1967, the regulations made under Government Notice R. 438 of 19 March 1976, are hereby withdrawn with effect from 1 April 1977 and replaced by the following:

Every banking institution, except a discount house, which is registered or provisionally registered under the Banks Act, 1965 (Act 23 of 1965), as amended, shall ensure—

(1) that the total amount of its discounts, loans and advances which, for purposes of this notice, are defined as asset items 10, 11, 12, 13 (f), 14 and 15 in its quarterly statement BA Form 9 rendered to the Registrar of Banks in terms of paragraph (b) of subsection (1) of section 13 of the above-mentioned Act, as at 30 April 1977 and the end of each subsequent calendar month does not exceed 109,5 (one hundred and nine and one-half) per cent of the total amount of the said asset items appearing in its quarterly statement for 31 December 1975, unless any excess is or has been authorised by the South African Reserve Bank by notice in the *Government Gazette* or in writing;

(2) that the total amount of its investments which, for purposes of this notice, are defined as asset items 9 (j), 9 (k) and 9 (o) (i) and 9 (o) (ii) in its quarterly statement BA Form 9 rendered to the Registrar of Banks in terms of paragraph (b) of subsection (1) of section 13 of the above-mentioned Act, as at 30 April 1977 and the end of each subsequent calendar month does not exceed 107,5 (one hundred and seven and one-half) per cent of the amount of the said asset items appearing in its quarterly statement for 31 December 1975, unless any excess is or has been authorised by the South African Reserve Bank by notice in the *Government Gazette* or in writing; and

(3) that within 31 (thirty-one) days after 30 April 1977 as well as after the end of every subsequent calendar month, certified statements are submitted to the South African Reserve Bank in such form and detail as required by the South African Reserve Bank.

MENTAL HEALTH ACT, 1973**AMENDMENT OF THE GENERAL REGULATIONS**

The Minister of Health has, in terms of the provisions of section 77 (1) of the Mental Health Act, 1973 (Act 18 of 1973), further amended the General Regulations made in Government Notice R. 565 dated 27 March 1975, as amended by Government Notice R. 1000, dated 11 June 1976, by deleting the words "excluding the psychiatrist" in subregulation (3) of General Regulation 1.

THE SOUTH AFRICAN MEDICAL AND DENTAL COUNCIL

The Minister of Health hereby makes the following regulations, on the recommendation of the South African Medical and Dental Council, in terms of section 24 (1) of the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), in substitution for the regulations published under Government Notice R. 2328 of 3 December 1976:

REGULATIONS RELATING TO THE QUALIFICATIONS WHICH ENTITLE PSYCHOLOGISTS TO REGISTRATION**1. In these regulations—**

"industrial psychology" means industrial psychology, including personnel psychology and/or psychometrics and/or personnel selection and/or military psychology;

"clinical psychology" means psychological diagnosis and therapy;

"research psychology" means psychological research;

"counselling psychology" means vocational counselling and/or marriage counselling and/or pastoral psychology.

2. Any of the following qualifications, provided it is obtained in psychology, shall entitle the holder thereof to registration as a psychologist in any of the categories of Industrial Psychology, Clinical Psychology, Research Psychology and Counselling Psychology: Provided that—

(1) such person produces evidence to the satisfaction of the council that before or in connection with or after the acquisition of the qualification in question (but in any event after completion of five years' study in psychology approved by the council for this purpose) he has had at least 12 months' practical experience in psychological procedures in the particular category in which he desires registration and in such institutions and on such conditions as may be determined by the council, to the satisfaction of the council: Provided further that, until 31 December 1977, the 12 months' practical experience may be undergone and completed directly after the obtaining of an honour's degree in psychology of a university recognised by the council;

(2) any such qualification shall entitle the holder thereof to registration only if he commenced studies for such qualification before 31 December 1977;

(3) until 31 December 1977 the holder of any such qualification may be exempted by the council from the prescribed 12 months' practical experience if the council is satisfied that the practical experience in

Die Minister van Gesondheid vaardig hierby, op aanbeveling van die Suid-Afrikaanse Geneeskundige en Tandheelkundige Raad, die volgende regulasies uit kragtens artikel 24 (1) van die Wet op Geneeshere, Tandartse en Aanvullende Gesondheidsdiensberoep, 1974 (Wet 56 van 1974), ter vervanging van die regulasies afgekondig by Goewermentskennisgewing R. 2328 van 3 Desember 1976:

REGULASIES BETREFFENDE DIE KWALIFIKASIES WAT DIE REG OP REGISTRASIE AS SIELKUNDIGES VERLEEN**1. In hierdie regulasies beteken—**

"bedryfsielkunde" bedryfsielkunde, insluitende personeelsielkunde en/of psigometrika en/of personeelkeuring en/of militêre sielkunde;

"kliniese sielkunde" sielkundige diagnose en terapie;

"navorsingsielkunde" sielkundige navorsing;

"voorligtingsielkunde" beroepsvoorligting en/of huwelijsvoorligting en/of pastorale sielkunde.

REGULASIES VIR DIE HAWENS VAN DIE REPUBLIEK VAN SUID-AFRIKA EN VAN SUIDWEST-AFRIKA

Dit het die Staatspresident behaag om kragtens artikel 3 van die Konsolidasiewet op die Beheer en Bestuur van Spoorweë en Hawens, 1957 (Wet 70 van 1957), goedkeuring te verleen aan die vervanging van regulasie 48

the Harbours of the Republic of South Africa and of South-West Africa published under Government Notice R. 290 of 2 March 1962, of the following regulation:

GANGWAYS

48. (a) The master of every ship whether alongside a wharf, quay or jetty, or outside another ship, or lying at buoys, or at anchor, must provide a safe and proper gangway so arranged as to admit of free and safe passage to or from the deck of the ship, and such gangway must be sufficiently lighted and be placed under control of a competent person who shall be in attendance at all times. A proper safety net must be rigged and secured below a gangway as soon as the gangway is in position to safeguard persons using the gangway from falling into the water or onto the wharf. The said person must also regulate the number of persons allowed on the gangway at any one time when boarding or leaving the ship. A notice indicating the maximum number of persons to be allowed on the gangway at any one time must be clearly displayed on each end of the gangway. A lifebuoy with a line attached thereto must be placed near each gangway and kept ready for immediate use. When lighters are being worked alongside a ship at an outer anchorage the ship's side shall be kept clear of all obstructions, the gangway ladder being lowered only as and when required. In addition to complying with the requirements of this regulation the master of every ship whilst within a harbour under the Administration's jurisdiction shall comply with any applicable regulation made under the provisions of the Merchant Shipping Act, 1951.

(b) The master shall ensure that a gangway is at all times so positioned that it does not obstruct or foul rail or crane tracks or constitute a hazard to the safe movement of trucks and cranes.

(c) In relation to any place where the Administration itself provides and operates a telescopic gangway between ship and shore, the Administration may in writing exempt the master of any ship from the obligation to comply with the requirements of this regulation regarding the provision of a gangway, and when any such exemption has been granted no liability shall attach to the master or the owners of such ship on account of the death of or injury to any person using such telescopic gangway, and/or loss of or damage to property, except where such death, injury, loss or damage is due to over-extension of or other unsafe condition in such gangway attributable directly to a negligent act or omission on the part of a member of the crew of such ship or of any other person for whom the said owners are responsible.

(d) The master shall take such precautions as are necessary to prevent damage to quay surfaces by ship's gangways.

(e) For the purpose of this regulation—

"gangway" shall be any means of access between ship and shore and vice versa.

van die Regulasies vir die Hawens van die Republiek van Suid-Afrika en van Suidwes-Afrika, aangekondig by Goewermentskennisgewing R. 290 van 2 Maart 1962, deur die volgende regulasie:

LOOPPLANKE

48. (a) Afgesien daarvan of 'n skip langs 'n kaai, hawehoof, ander kant 'n ander skip, aan boei of voor anker lê, moet die kaptein van die skip 'n veilige en behoorlike loopplank op sodanige wyse verskaf dat dit vrye en veilige toegang tot die dek van die skip, of omgekeerd, verleen. Sodaanige loopplank moet voldoende verlig wees en onder die toesig van 'n bevoegde oppasser wat te alle tye daar op diens moet wees. Soos die loopplank in posisie geplaas is moet 'n behoorlike veiligheidsnet op so 'n wyse onder die loopplank aangebring word dat dit sal verhoed dat persone wat die loopplank gebruik in die water of op die kaai val. Die genoemde persoon moet ook die aantal persone wat gelyktydig op die loopplank toegelaat kan word, terwyl hulle aan boord gaan of land, beheer. 'n Kennisgewing wat die maksimum getal persone aandui wat die loopplank gelyktydig mag gebruik moet aan beide ente van die loopplank aangebring word. 'n Reddingsboei met 'n tou daaraan moet naby elke loopplank gereed gehou word vir onmiddellike gebruik. Wanneer lighters langs 'n skip by 'n buiteankerplek bedien word, moet die kant van die skip vry van alle versperrings gehou word, en die lere moet neergelaat word net wanneer dit nodig is. Onderwyl 'n skip in 'n hawe onder die jurisdiksie van die Administrasie is, moet die kaptein nie alleen die vereistes van hierdie regulasie nakom nie maar ook enige toepaslike regulasie wat opgestel is kragtens die bepalings van die Handelskeepvaartwet, 1951.

(b) Die kaptein van die skip moet verseker dat 'n loopplank te alle tye so geplaas is dat dit nie 'n trein- of kraanspoor versper nie of dat dit 'n gevaar vir die veilige beweging van trokke en krane inhoud nie.

(c) In verhouding tot 'n plek waar die Administrasie self 'n teleskopiese loopplank tussen skip en land verskaf en bedien, kan die Administrasie die kaptein van 'n skip skriftelik vrystel van die verpligting om aan die bepalings van hierdie regulasie te voldoen vir sover dit die verskaffing van 'n loopplank betrek, en wanneer sodanige vrystelling verleent is, sal geen aanspreeklikheid op die kaptein of die eienaars van sodanige skip rus van weë die dood van of besering aan 'n persoon wat van sodanige teleskopiese loopplank gebruik maak en/of vanweë verlies of skade aan eiendom nie, behalwe waar sodanige dood, besering, verlies of skade te wye is aan die ooruit trekking van of ander onveilige toestand in sodanige loopplank, wat regstreeks toegeskryf kan word aan 'n nalatige handeling of versuum van die kant van 'n lid van die bemanning van die skip of van enige ander persoon waarvoor die genoemde eienaars aanspreeklik is.

(d) Die kaptein moet sodanige voorsorgmaatreëls neem as wat nodig is om te verhoed dat skeepsloopplanke die kaaioppervlaktes beskadig.

(e) Vir die doel van hierdie regulasie beteken—

"loopplank" enige manier van toegang tussen skip en land en omgekeerd.
