PRICES OF FLOUR, MEAL, SEMOLINA AND
SELF-RAISING FLOUR.—AMENDMENT

In terms of section 79 (b) of the Marketing Act, 1968 (No. 59 of 1968), I, Hendrik Stephanus Johan Schoeman, Minister of Agriculture, hereby make known that the Wheat Board, referred to in section 6 of the Winter Cereal Scheme, published by Proclamation R. 162 of 1974, as amended, has, under section 37 of that Scheme, with my approval and with effect from the date of publication hereof, further amended the prohibition published by Government Notice R. 1798 of 1 October 1976, as amended, as set out in the Schedule hereto.

SCHEDULE

The Schedule to Government Notice R. 1798 of 1 October 1976, as amended, is hereby further amended by—

- (a) the substitution in clause 1 (2) for the expression “25 kg” of the expression “12,5 kg”;
- (b) the substitution in clause 1 (2A) for the expression “12,5 kg” of the expression “5 kg”;
- (c) the substitution in clause 2 (2) for the expression “25 kg” of the expression “12,5 kg”;
- (d) the substitution in clause 2 (2A) for the expression “12,5 kg” of the expression “5 kg”;
- (e) the substitution for the table under paragraph (a) of clause 4 (1) of the following table:
