## SCHEDULE

1. In this notice, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the Marketing Act, 1968, shall have a corresponding meaning, and—

“farm feeds manufacturer” means a person who manufactures any farm feeds registered under the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, 1947 (Act 36 of 1947);

“oil cake” means the residue of ground nuts, sunflower seed, soya beans and cotton seed (whether decorticated or not), after the oil has been extracted;

“oil cake meal” means milled oil cake;

“producer”, in relation to oil cake, means any person concerned in the manufacture of oil cake;

“Republic” excludes the Territory;

“written proof”, in relation to clause 4, means a certified copy of the consignment note or conveyor's invoice if the oil cake or oil cake meal has been conveyed by a third party, or an affidavit by the seller if he has conveyed the oil cake or oil cake meal by own means.

2. No person shall, subject to the provision of clauses 3, 4 and 5, sell oil cake or oil cake meal to the classes of persons specified below at a price above the maximum price indicated hereunder for the particular class of persons:

## BYLAE

1. In hierdie kennisgewing, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan in die Bemarkingswet, 1968, 'n betekenis geheg is, 'n ooreenstemmende betekenis, en beteken—

“oliekoek” die residu van grondbone, sonneblomsaad, sojabone en katoensaad (het sy gepel of nie) nadat die olie daaruit verwyder is;

“oliekoekmeel” gemaalde oliekoek;

“produsent”, met betrekking tot oliekoek, iemand wat betrokke is by die vervaardiging van oliekoek; “Republiek” nie ook die Gebied nie;

“skriftelike bewys”, met betrekking tot klousule 4, 'n gesertifiseerde afskrif van die vragbrief of karweiersfaktuur indien die oliekoek of oliekoekmeel deur 'n derde persoon vervoer is, of 'n beëdigde verklaring deur die verkoper indien hy die oliekoek of oliekoekmeel met eie middele vervoer het;

“veevoedselvervaardiger” iemand wat veevoedsel, geregistreer kragtens die Wet op Misstowwe, Veevoedsel, Landboumiddels en Veemiddels, 1947 (Wet 36 van 1947), vervaardig.

3. (1) The maximum prices specified in clause 2 shall include the price of the containers in which oil cake or oil cake meal is delivered in pursuance of a sale.

(2) The said maximum prices shall be reduced by an amount of R4,50 per metric ton if oil cake or oil cake meal is—

(a) sold in bulk;

3. (1) Die maksimum prysse in klousule 2 vermeld, sluit die prys van die houers waarin oliekoek of oliekoekmeel uit hoofde van 'n verkoop gelewer word, in.

(2) Bedoelde maksimum prys moet met 'n bedrag van R4,50 per metriekie ton verminder word indien oliekoek of oliekoekmeel—

(b) delivered in pursuance of a sale in containers supplied by the purchaser;

(c) sold subject to a term of sale that ownership of the containers in which the oil cake or oil cake meal is delivered in pursuance of the sale shall not be transferred to the purchaser.

4. The amount of the transport costs actually incurred by a seller, other than a producer of oil cake, to obtain delivery of oil cake and oil cake meal at his premises, may, notwithstanding the provisions of clause 2, be added to the purchase price of the oil cake or oil cake meal concerned, provided the seller furnishes written proof of such costs to the purchaser within a period of 30 days from the date of sale.

5. The provisions of this notice shall not apply to the sale of oil cake and oil cake meal if the total quantity sold by a seller to a particular purchaser during a period of any seven consecutive days does not exceed 100 kg.

6. This notice shall come into operation on the date of publication thereof and repeals Government Notice R. 1057 of 1979 with effect from the same date.

### AMENDMENT OF THE STATUTE AND REGULATIONS OF THE UNIVERSITY OF THE WESTERN CAPE

The Minister of Coloured Relations has, under section 33 of the University of the Western Cape Act, 1969 (Act 50 of 1969), approved the amendment by the Council of the said University of the Statute and Regulations of the University, published under Government Notice R. 713 of 14 April 1978, as amended, by further amending Schedules A and B as set out in the Schedule hereto.

### SCHEDULE

A. Amend Chapter V of Schedule A (Designation of Degrees) as follows:

(1) Insert the following new paragraph after paragraph 23 (a) (v):

"(vi) In Human Ecology:

(2) Substitute "Economic and Management Sciences:" for "Commerce and Law:" in regulation 23 (d) and delete "(i) In Economic and Management Sciences:" and "(ii) in Law:

4. Die bedrag van die transportkoste werklik deur die verkoper, anders as 'n produsent van oliekoek, aangegaan om die oliekoek of oliekoekmeel by sy perseel gelewer te kry, kan, ongeag die bepalings van klosule 2, by die verkoopprys van die betrokke oliekoek of oliekoekmeel gevoeg word, mits die verkoper die koper binne 30 dae na die datum van verkoop van skriftelike bewys van sodanige koste voorsien.

5. Die bepalings van hierdie kennisgewing is nie van toepassing nie op die verkoop van oliekoek of oliekoekmeel indien die totale hoeveelheid deur 'n verkoper aan 'n bepaalde koper gedurende 'n tydperk van sewe agtereenvolgende dae verkoop nie 100 kg oorskry nie.

6. Hierdie kennisgewing tree in werking op die datum van publikasie daarvan en herroep Goewermentskennisgewing R. 1057 van 1979 met ingang vanaf dieselfde datum.

**POWERS OF GOVERNING BODIES OF INSTITUTES**

36. A body created for the management of an institute of the University shall, subject to the authority of the council and the senate, and in the manner provided in its constitution, have power—

(i) to determine the policy and programme of the institute and to exercise control over the execution thereof, and in particular, and without derogating from the generality of the foregoing, to undertake research, publication, training and the rendering of services to the University or to the community, and to undertake such further or other functions as may be combined with all or any of the activities of the said institute;

(ii) to make recommendations in relation to the creation of posts and the appointment of staff;

(iii) to prepare estimates of revenue and expenditure for the institute and control the application of its funds;

(iv) to undertake such further matters as may be necessary for the more effective management of the institute.”

(ii) aanbevelings oor die skep van poste en die aanstel van personeel te doen;

(iii) die begroting van die instituut op te stel en die aanwending van sy fondse te beheer;

(iv) sodanige ander aangeleenthede te behartig as wat nodig is vir die doeltreffende bestuur van die instituut.”

D. Add the following new Chapter XI and XII in Schedule A after Chapter X:

**"CHAPTER XI**  
**RECTOR, VICE-RECTOR**

*Rector*

**1. Appointment.**

Subject to the provisions of section 7 (1) of the Act, the rector shall be appointed by the council from a list of three names submitted by the senate, by a resolution taken by a majority of the members of the council holding office at the date of the meeting.

**2. Term of office.**

The rector shall be appointed until the end of the year in which he attains the age of sixty-five years, or for a period of five years, which shall be renewable: Provided that—

2.1 he may resign at any time by giving six months' notice to the council;

2.2 subject to the provisions of section 14 (2) of the Act, his appointment may be terminated at any time by the council by a resolution passed at a meeting thereof by a majority consisting of not less than three-quarters of the number of members present and not less than half of the members holding office at the date of the meeting:

Provided further that in the event of the termination of an appointment by the council in terms of proviso 2.2 hereof, other than on the ground of grave misconduct, the council shall, in consultation with the Minister and the Minister of Finance, determine an amount to be paid to the rector in lieu of notice, which amount shall be not less than six months' salary.

**3. Powers, duties and functions.**

3.1 The rector shall, *ex officio*, be a member of the council, chief administrative officer of the council, chairman and chief executive officer of the senate, and a member of all committees of the council and of the senate.

3.2 The rector shall, subject to the council's direction, exercise general supervision over the University.

3.3 The rector shall, in his capacity as vice-chancellor, and in the absence of the chancellor, or at his request, exercise and perform the functions of the chancellor.

*Vice-rector*

**4. Appointment.**

Subject to the provisions of section 7 (A) of the Act, the vice-rector shall be appointed by the council from a list of three names submitted by the senate, by a resolution taken by a majority of members of the council holding office at the date of the meeting.

**5. Term of office.**

The vice-rector shall hold office for a period of five years, which shall be renewable: Provided that—

5.1 he may resign at any time by giving six months' notice to the council;

5.2 subject to the provisions of section 14 (2) of the Act, the council may at any time terminate his appointment by giving him six months' notice.

**6. Powers, duties and functions.**

6.1 The vice-rector shall, *ex officio*, be a member of the council and of the senate of all committees of the senate, and he shall act as chairman of the senate in the absence of the rector.

*Rektor*

**1. Aanstelling.**

Behoudens die bepalings van artikel 7 (1) van die Wet word die rektor uit 'n groslys van drie persone wat deur die senaat voorgestel word, deur die raad aangestel by wyse van 'n besluit geneem deur 'n meerderheid van die lede van die raad wat hulle amp op die datum van die vergadering beklee.

**2. Ampstermyn.**

Die rektor word aangestel tot aan die einde van die jaar waarin hy die ouderdom van vyf-en-sestig jaar bereik, of vir 'n tydperk van vyf jaar, wat hernieubaar is: Met dien verstande dat—

2.1 hy te eniger tyd kan bedank deur aan die raad ses maande kennis te gee;

2.2 behoudens die bepalings van artikel 14 (2) van die Wet, sy aanstelling te eniger tyd deur die raad beëindig kan word by wyse van 'n besluit geneem op 'n vergadering van die raad deur 'n meerderheid bestaande uit minstens driekwart van die getal lede wat aanwesig is en minstens een helfte van die lede wat hulle amp op die datum van die vergadering beklee:

Met dien verstande verder dat ingeval 'n aanstelling deur die raad ingevolge bepaling 2.2 hiervan beëindig word, behalwe weens ernstige wangedrag, die raad, in oorleg met die Minister en die Minister van Finansies, 'n bedrag vasstel wat aan die rektor betaal moet word in plaas van kennisgewing, welke bedrag minstens die salaris vir ses maande moet wees.

**3. Bevoegdhede, pligte en werksaamhede.**

3.1 Die rektor is ampshalwe 'n lid van die raad, hoof administratiewe beampete van die raad, vooritter en hoof uitvoerende beampete van die senaat en lid van alle komitees van die raad en van die senaat.

3.2 Behoudens die raad se aanwysing hou die rektor algemene toesig oor die Universiteit.

3.3 In sy hoedanigheid van vise-kanselier en in die afwesigheid van die kanselier of op sy versoek oefen die rektor die funksies van die kanselier uit.

*Vise-rector*

**4. Aanstelling.**

Behoudens die bepalings van artikel 7 (A) van die Wet word die vise-rector uit 'n groslys van drie persone wat deur die senaat voorgestel word, deur die raad aangestel by wyse van 'n besluit geneem deur 'n meerderheid van die lede van die raad wat hul amp op die datum van die vergadering beklee.

**5. Ampstermyn.**

Die vise-rector beklee sy amp vir 'n tydperk van vyf jaar, wat hernieubaar is: Met dien verstande dat—

5.1 hy te eniger tyd kan bedank deur aan die raad ses maande kennis te gee;

5.2 behoudens die bepalings van artikel 14 (2) van die Wet, die raad te eniger tyd sy aanstelling kan beëindig deur aan hom ses maande kennis te gee.

**6. Bevoegdhede, pligte en werksaamhede.**

6.1 Die vise-rector is ampshalwe 'n lid van die raad en van die senaat en van alle komitees van die senaat, en hy tree op as vooritter van die senaat in die afwesigheid van die rektor.

6.2 The duties of the vice-rector shall be to assist and represent the rector from time to time, as directed by the rector, in consultation with the council.

6.3 The vice-rector shall act as rector in the absence of the rector.

## CHAPTER XII

### CONVOCATION, DONORS, SCHOOL PRINCIPALS

#### *Convocation*

##### 1. Secretary and roll of the convocation.

1.1 The registrar shall act as secretary of the convocation.

1.2 The secretary of the convocation shall keep the roll thereof, and a member shall be required to register his name and address with the secretary and to notify him of any change of address.

1.3 The said roll shall be conclusive evidence that a person whose name appears therein at the time of an election by the convocation is entitled to vote thereat and that a person whose name does not appear therein is not so entitled.

##### 2. President.

2.1 The president of the convocation shall be appointed by the convocation from amongst its own members at an annual meeting and shall hold office from the close of the meeting at which he is elected until the close of the second annual meeting thereafter.

2.2 In the event of the death or resignation of the president, a successor shall be appointed at a meeting of the convocation called by the secretary for that purpose, to fill the office for the unexpired period of service.

##### 3. Chairman.

The president shall be chairman at all meetings of the convocation, but in his absence the members present shall appoint from amongst their number a chairman for that meeting.

##### 4. Annual meeting.

4.1 The convocation shall hold an annual meeting, which shall be convened by the secretary in consultation with the president, at the seat of the University.

4.2 Notice of a motion or matter for discussion at a meeting must be given to the secretary in writing by 15 February annually.

##### 5. Special meetings.

5.1 A special meeting of the convocation may be convened by the president at any time, and shall be convened by him within two months of the receipt of a requisition signed by not less than the number of members required to form a quorum for such meeting, stating in the form of specific motions the subjects for consideration at such meeting.

5.2 No business other than that for which the meeting was convened may be dealt with at a special meeting.

##### 6. Notice of meetings.

Notice of a meeting of the convocation, with a statement of the business to be considered, shall be sent to each member at his registered address at least fourteen days before the day appointed for such meeting.

##### 7. Quorum and procedure.

7.1 One hundred members shall form a quorum.

6.2 Die pligte van die vise-rektor is om die rektor by te staan en te verteenwoordig soos die rektor in oorleg met die raad van tyd tot tyd kan gelas.

6.3 Die vise-rektor tree op as waarnemende rektor in die afwesigheid van die rektor.

## HOOFTUK XII

### KONVOKASIE, DONATEURS, SKOOLHOOFDE

#### *Konvokasie*

##### 1. Sekretaris en konvokasieliks.

1.1 Die registrateur tree op as sekretaris van die konvokasie.

1.2 Die sekretaris van die konvokasie hou die konvokasieliks, en 'n lid moet sy naam en adres by die sekretaris indien en hom van enige adresverandering in kennis stel.

1.3 Gemelde lys is afdoende bewys dat iemand wie se naam ten tyde van 'n verkiesing deur die konvokasie daarin verskyn, geregtig is om in sodanige verkiesing te stem en dat iemand wie se naam nie daarin verskyn nie, nie aldus geregtig is nie.

##### 2. President.

2.1 Die president van die konvokasie word deur die konvokasie uit eie geledere aangestel op 'n jaarvergadering en hy beklee sy amp vanaf die einde van die vergadering waarop hy verkies is tot aan die einde van die tweede jaarvergadering daarna.

2.2 In die geval van die dood of die bedanking van die president word 'n opvolger om die amp vir die onverstreke ampstermyn te beklee, gekies op 'n vergadering van die konvokasie wat die sekretaris vir dié doel belê.

##### 3. Voorsitter.

Die president is voorsitter op alle vergaderings van die konvokasie, maar in sy afwesigheid kies die aanwezige lede iemand uit hulle geledere om op daardie vergadering voor te sit.

##### 4. Jaarvergadering.

4.1 Die konvokasie hou by die setel van die Universiteit 'n jaarvergadering, wat deur die sekretaris in oorleg met die president belê word.

4.2 Kennis van 'n mosie of saak vir bespreking op 'n vergadering moet jaarliks voor 15 Februarie skriftelik aan die sekretaris gegee word.

##### 5. Buitengewone vergaderings.

5.1 'n Buitengewone vergadering van die konvokasie kan te eniger tyd deur die president belê word, en moet deur hom belê word binne twee maande na ontvangst van 'n skriftelike versoek wat deur minstens die getal lede wat 'n kworum op sodanige vergadering uitmaak, geteken is, en waarin die sake vir oorweging op sodanige vergadering in die vorm van bepaalde mosies gestel word.

5.2 Geen ander sake as dié waarvoor die vergadering belê word, word op 'n buitengewone vergadering behandel nie.

##### 6. Kennisgewing van vergaderings.

Kennis van 'n konvokasievergadering met 'n opgawe van die sake wat behandel moet word, word aan elke lid na sy geregistreerde adres gestuur minstens veertien dae voor die vasgestelde dag van die vergadering.

##### 7. Kworum en prosedure.

7.1 Een honderd lede vorm 'n kworum.

7.2 In the event of there being no quorum 15 minutes after the time fixed for the meeting, the meeting may proceed with such formal business as the chairman of the meeting may deem necessary for the continuity of the convocation's activities.

7.3 Subject to the provisions of paragraphs 7.1 and 7.2 hereof, the procedure at all meetings of the convocation shall, *mutatis mutandis*, be that prescribed in paragraphs 7 and 8 of Chapter III (The Council) of the Statute of the University for meetings of the Council.

#### 8. Powers and duties.

8.1 Subject to the provisions of the Act, the convocation shall elect such number of members of the council as the convocation may be entitled to elect.

8.2 The convocation shall deal with such matters as the council may from time to time refer to it, and with any matter deemed by the convocation to be in the interests of the University.

#### 9. Submission of resolutions to the council and the senate.

A copy of all resolutions of the convocation, and a statement of such other matters as the convocation may decide, duly certified by the chairman and by the secretary, shall be sent to the chairman of the council for the information of the council, and to the rector for the information of the senate.

#### 10. Council: Election by the convocation.

10.1 Whenever the convocation may elect a member of the council, the secretary of the convocation shall, by way of written notice, which shall be posted not less than three months before the date set by the council for the election, invite each member of the convocation to nominate in writing persons for election as a member of the council.

10.2 Each nomination, signed by not less than five members, and countersigned by the member nominated to signify his acceptance of nomination, shall be lodged with the secretary not less than two months before the date set for the election.

10.3 In the event of the number of persons nominated not exceeding the number of vacancies, the secretary shall immediately declare that such person or persons are duly elected.

10.4 In the event of more persons being nominated than may be elected, the secretary shall, not later than one month prior to the date set for the election, post to each member of the convocation a printed ballot paper, in the form prescribed by the council, bearing the names of the candidates in alphabetical order.

10.5 A voting paper which is not completed in accordance with the instructions on such paper shall be invalid.

10.6 The secretary shall act as returning officer at all elections, and he shall be assisted by two scrutineers who shall be appointed by the president of the convocation or, in his absence, by the rector.

#### Donors

##### 11. Definition and list of donors.

11.1 Every person or body, with the exception of the local authority referred to in section 8 (1) (g) of the Act, who has donated to the University an amount of not less than R500 in total, or who has made a firm promise to donate to the University an amount of not less than R500 in regular payments over a period of not more than 10 years, and who is not in arrears with such payments, shall be regarded as a donor for the purposes of section 8 (1) (f) of the Act.

7.2 Ingeval daar 15 minute na die tyd wat vir die vergadering vasgestel is, nie 'n kworum is nie, kan die vergadering voortgaan met sodanige formele sake as wat die voorstander van die vergadering vir die kontinuitet van die konvokasie se werksaamhede nodig ag.

7.3 Behoudens bepальings 7.1 en 7.2 hiervan, is die prosedure op elke vergadering van die konvokasie *mutatis mutandis* dieselfde as dié wat in paragrawe 7 en 8 van Hoofstuk III (Die Raad) van die Statuut van die Universiteit vir vergaderings van die raad voorgeskryf word.

#### 8. Bevoegdhede en pligte.

8.1 Behoudens die bepальings van die Wet verkiest die konvokasie sodanige getal lede van die raad as waarop die konvokasie geregtig is.

8.2 Die konvokasie behandel sodanige sake as wat die raad van tyd tot tyd na die konvokasie verwys, asook enige sake wat die konvokasie ag in belang van die Universiteit te wees.

#### 9. Voorlegging van besluite aan raad en senaat.

'n Afskrif van alle konvokasiebesluite en 'n verklaring oor sodanige ander sake as waaroer die konvokasie besluit, behoorlik deur die voorstander en sekretaris gewaarmerk, word aan die voorstander van die raad vir die inligting van die raad, en aan die rektor vir die inligting van die senaat, gestuur.

#### 10. Verkiezing deur konvokasie.

10.1 Wanneer die Konvokasie 'n lid van die raad moet kies, nooi die sekretaris van die konvokasie by wyse van 'n skriflike kennisgewing, wat minstens drie maande voor die verkiezingsdatum wat deur die Raad vasgestel is, gepos moet word, elke lid van die konvokasie uit om 'n persoon skriftelik vir verkiezing tot lid van die raad te nomineer.

10.2 Elke nominasie, geteken deur minstens vyf lede en mede-ondersteek deur die genomineerde ter aanduiding van sy aanvaarding van die nominasie, word minstens twee maande voor die vasgestelde verkiezingsdatum by die sekretaris van die raad ingedien.

10.3 Indien die getal genomineerde nie meer is as die getal vakature nie, verklaar die sekretaris onverwyld dat sodanige persoon of persone behoorlik verkieks is.

10.4 Indien meer persone genoem word as wat verkieks moet word, pos die sekretaris minstens 'n maand voor die vasgestelde verkiezingsdatum 'n gedrukte stembrief, in 'n vorm deur die raad voorgeskryf en met die name van al die kandidate in alfabetiese volgorde daarop, aan elke lid van die konvokasie.

10.5 'n Stembrief wat nie ingevul word volgens die voorstrikte wat daarop verskyn nie, is ongeldig.

10.6 By elke verkiezing tree die sekretaris as kiesbeambte op en word hy bygestaan deur twee stemopnemers wat deur die president van die konvokasie of, in sy afwesigheid, deur die rektor aangestel word.

#### Donateurs

##### 11. Omskrywing en lys van donateurs.

11.1 Elke persoon of liggaam, met uitsondering van die plaaslike owerheid vermeld in artikel 8 (1) (g) van die Wet, wat 'n totale bedrag van minstens R500 aan die Universiteit skenk, of wat 'n vaste belofte doen om 'n bedrag van minstens R500 in gereelde paaiemende gedurende 'n tydperk van hoogstens 10 jaar aan die Universiteit te skenk en nie agterstallig is met sy paaiemende nie, word as 'n donateur beskou vir die doeleindes van artikel 8 (1) (f) van die Wet.

11.2 The registrar shall maintain a list of donors, which shall be conclusive evidence that a person whose name appears therein at the time of an election by donors is entitled to vote at such election, and that a person whose name does not appear therein is not so entitled.

11.3 Subject to the provisions of subparagraph 11.2, the onus of proving that a person is entitled to vote at an election by donors rests on such person.

#### 12. Election by donors.

Whenever the donors may elect a member of the council, the procedure shall, *mutatis mutandis*, be the same as that provided for the election by the convocation of a member of the council.

#### School principals

##### 13. Election by school principals.

13.1 Whenever the principals of senior secondary schools under the control of the Department of Coloured Relations are required to elect a person as a member of the council in terms of section 8 (1) (h) of the Act, the Secretary of Coloured Relations shall furnish the registrar with a list containing the names and addresses of such school principals.

13.2 The said list shall be conclusive evidence that a person whose name appears therein at the time of an election by school principals is entitled to vote thereat and that a person whose name does not appear therein is not so entitled.

13.3 For such an election the procedure shall, *mutatis mutandis*, be the same as that provided for the election by the convocation of a member of the council.”

E. Amend Schedule B as follows:

(1) Substitute “At least 40 per cent” for “a pass” “50” for “40” in regulation 2.2.6.

(2) Add “and also at least 40 per cent in Biology or Physical Science, Higher Grade, or at least 50 per cent in Biology or Physical Science, Standard Grade.” after “Standard Grade” in regulation 2.3.1.

(b) the substitution for the name of the degree “Doctor of Medical Sciences . . . D.Med.Sci.” of the following name:

“Philosophiae Doctor . . . Ph.D.”

#### Skoolhoofde

### REGULATIONS IN TERMS OF SECTION 17 OF THE STATISTICS ACT, 1976 (ACT 66 OF 1976).—COLLECTION OF STATISTICS WITH REGARD TO RATES IN BILLS OF QUANTITIES COMPILED BY QUANTITY SURVEYORS

The Minister of Statistics has, in terms of section 17 of the Statistics Act, 1976 (Act 66 of 1976), read with Government Notice R. 139 of 4 February 1977, made the regulations set forth in the Schedule hereto in connection with rates in bills of quantities compiled by quantity surveyors.

## SCHEDULE

1. In these regulations, unless the context otherwise indicates—

1.1 “quantity surveyor” means a person registered as such in terms of the Quantity Surveyors’ Act, 1970 (Act 36 of 1970), or a partnership of such persons or a body employing such persons;

1.2 “bills of quantities” means a document reflecting the quality and quantity of the work set out on the drawings of and in the specification for a building project and prepared in accordance with the latest edition of the Standard System of Measuring Builders’ Work issued by the Association of South African Quantity Surveyors;

1.3 “rate” means the amount per measuring unit entered against each item in the bills of quantities;

1.4 “building project” means the contract work set out in the bills of quantities;

1.5 “quarter” means a continuous period of three months ending on 31 March, 30 June, 30 September or 31 December of each year.

## 2. Submission of returns:

2.1 Each quantity surveyor shall, within 90 days after the end of each quarter, submit returns which give all the particulars and information prescribed in regulation 3 hereof with regard to all building projects for which bills of quantities were compiled by him and for which tenders closed during the quarter concerned to the Secretary for Statistics.

### REGULASIES KRAGTENS ARTIKEL 17 VAN DIE WET OP STATISTIEKE, 1976 (WET 66 VAN 1976).—VERSAMELING VAN STATISTIEKE MET BETREKKING TOT TARIEWE IN HOEVEELHEIDSPLYSTE WAT DEUR BOUREKENAARS SAAMGESTEL IS

Die Minister van Statistiek het, kragtens artikel 17 van die Wet op Statistiek, 1976 (Wet 66 van 1976), gelees met Goewermentskennisgewing R. 139 van 4 Februarie 1977, die regulasies in die Bylae hiervan uitengesit, met betrekking tot tariewe in hoeveelheidslyste wat deur die bourekenaars saamgestel is, uitgevaardig.

## BYLAE

1. In hierdie regulasies, tensy uit die samehang anders blyk, beteken—

1.1 “bourekenaar” iemand wat as sodanig geregistreer is ingevolge die Wet op Bourekenaars, 1970 (Wet 36 van 1970), of 'n vennootskap van sodanige persone of 'n liggaam wat sodanige persone in diens het;

1.2 “hoeveelheidslyste” 'n dokument wat die gehalte en hoeveelheid werk weergee wat op die tekeninge van en in die spesifikasie vir 'n bouprojek uiteengesit is, en wat opgestel is ooreenkomsdig die jongste uitgawe van die Standaard-Stelsel vir die Opname van Bouerswerk, uitgegee deur die Vereniging van Suid-Afrikaanse Bourekenaars;

1.3 “tarief” die bedrag per meeteenheid wat teenoor elke item in die hoeveelheidslyste verskyn;

1.4 “bouprojek” die kontrakwerk in die hoeveelheidslyste uiteengesit;

1.5 “kwartaal” 'n aaneenlopende tydperk van drie maande wat eindig op 31 Maart, 30 Junie, 30 September of 31 Desember van elke jaar.

## 2. Indiening van opgawes:

2.1 Elke bourekenaar moet binne 90 dae na die einde van elke kwartaal opgawes waarin al die besonderhede en inligting verstrek word wat by regulasie 3 hiervan voorgeskryf word, ten opsigte van alle bouprojekte waarvoor hoeveelheidslyste deur hom saamgestel is en waarvoor tenders gedurende die betrokke kwartaal gesluit het, by die Sekretaris van Statistiek indien,

2.2 The questionnaire on which the information with regard to the return mentioned in subregulation 2.1 above should be submitted may be obtained from the Secretary for Statistics, Private Bag X44, Pretoria, 0001.

2.3 The Secretary for Statistics may send the questionnaire referred to in subregulation 2.2 above to a quantity surveyor but his failure to do so does not exempt any quantity surveyor from the obligation imposed on him by subregulation 2.1.

3. The following particulars and information must be given in terms of these regulations:

3.1 Particulars with regard to the building project in respect of which the return is completed, i.e.:

3.1.1 The type of building;

3.1.2 the region (according to magisterial district) in which the building site is situated;

3.1.3 the date on which the tender for the project closed;

3.1.4 the identity of the building owner;

3.1.5 the nature of any contract price adjustment provisions; and

3.1.6 the value of the tender or contract.

3.2 The rates for the various indicator items according to trade and subsection as specified in the questionnaire with regard to the contract concerned.

3.3 Particulars with regard to provisional sums and work under separate contracts, and preliminaries.

4. Failure to submit the return referred to in subregulation 2.1:

4.1 Any quantity surveyor who, without reasonable cause, fails to comply with these regulations shall be guilty of an offence and liable on conviction to a fine not exceeding R200 or, in the case of a continuing failure to comply therewith, to a fine not exceeding R10 for every day during which such failure continues.

4.2 In criminal proceedings where a quantity surveyor is accused in terms of subregulation 4.1 it shall be no defence against the accusation that such person did not receive a questionnaire on which to submit the return as prescribed in subregulation 2.1.

2.3 Die Sekretaris van Statistiek kan die vraelys genoem in subregulasie 2.2 hierbo, aan 'n bourekenaar stuur, maar sy versuim om dit te doen, onthel geen bourekenaar van die verpligting wat hom by subregulasie 2.1 hierbo opgelê is nie.

3. Die volgende besonderhede en inligting moet ooreenkomsdig die bepalings van hierdie regulasies verstrekk word:

3.1 Besonderhede met betrekking tot die bouprojek ten opsigte waarvan die opgawe ingevul word, naamlik:

3.1.1 Die tipe gebou;

3.1.2 die streek (volgens landdrosdistrik) waarin die bouterrein geleë is;

3.1.3 die datum waarop die tender vir die projek gesluit het;

3.1.4 die identiteit van die bouheer;

3.1.5 die aard van enige kontrakprysaanpassingsbepalings; en

3.1.6 die waarde van die tender of kontrak.

3.2 Die tariewe vir die onderskeie aanwyseritems volgens ambag en onderafdeling in die vraelys gespesifieer, met betrekking tot die betrokke kontrak.

3.3 Besonderhede met betrekking tot voorlopige bedrae en werk onder aparte konakte, en voorbereid-sels.

4. Versuim om die opgawe in subregulasie 2.1 bedoel, in te dien:

4.1 Enige bourekenaar wat sonder redelike oorsaak versuim om hierdie regulasies na te kom, begaan 'n misdryf en is by skuldigbevinding strafbaar met 'n boete van hoogstens R200 of, in die geval van 'n voortdurende versuim om dit na te kom, met 'n boete van hoogstens R10 vir elke dag waarop sodanige versuim voortduur.

4.2 By strafregtelike verrigtinge waarby 'n bourekenaar ingevolge subregulasie 4.1 aangekla word, is die feit dat daardie persoon geen vraelys ontvang het om die opgawe in subregulasie 2.1 omskryf, in te dien nie, geen verweer teen die aanklag nie.
