THE CENTRAL COUNCIL OF LAND SURVEYORS

In terms of section 18 of the Land Surveyors' Registration Act, 1950 (Act 14 of 1950), the rules set out in the Annexure hereto are hereby made by the Central Council of Land Surveyors with the approval of the Minister of Agriculture.

ANNEXURE**RULES**

1. Rule 3 of the rules promulgated by Government Notice 1188 of 1 July 1977 (hereinafter referred to as the rules) is hereby amended—

(a) by the addition of the following paragraph after subrule (1) (c):

“(d) the address from which he intends to practise.”; and

(b) by the insertion in subrule (2) of the words “and address” after the words “his name”.

2. The following rule is hereby substituted for rule 5 of the rules:

Registered address

5. (1) Every land surveyor shall have his registered address entered in the register by the registrar.

(2) A land surveyor may not have more than one registered address and he shall not change such address until six months after written notice of the intention to change it and of the new address has been given to the council: Provided that, if in the opinion of the council, the application of this subrule is likely to hardship, it may accept notice of a lesser period: Provided further that a land surveyor may change his registered address to another in the same town, subject to immediate notice being given to the council of such change.

DIE SENTRALE LANDMETERSRAAD

Kragtens artikel 18 van die Landmetersregistrasiewet, 1950 (Wet 14 van 1950), vaardig die Sentrale Landmetersraad met die goedkeuring van die Minister van Landbou hierby die reëls uiteengesit in die Bylae hiervan, uit.

BYLAE**REËLS**

1. Reël 3 van die reëls afgekondig by Goewermentskennisgewing 1188 van 1 Julie 1977 (hieronder die reëls genoem) word hierby gewysig—

(a) deur die byvoeging van die volgende paragraaf na subreël (1) (c):

“(d) die adres van waar hy voornemens is om te praktiseer.”; en

(b) deur die byvoeging in subreël (2) van die woorde “en adres” na die woorde “sy naam”.

2. Reël 5 van die reëls word hierby deur die volgende reël vervang:

“Geregistreerde adres

5. (1) Elke landmeter moet sy geregistreerde adres deur die registrator in die register laat aanteken.

(2) 'n Landmeter mag nie meer as een geregistreerde adres hê nie en hy mag nie sodanige adres verander nie, tensy ses maande skriftelike kennis van die voorname om dit te verander en die nuwe adres aan die raad gegee is: Met dien verstande dat indien die handhawing van hierdie subreël, na die mening van die raad, ontbering kan meebring, die raad 'n korter tydperk van kennisgewing kan aanvaar: Met dien verstande voorts dat 'n landmeter sy geregistreerde adres na 'n ander een in dieselfde dorp kan verander, onderworpe aan onmiddellike kennisgewing van die verandering aan die raad.

(3) For the purpose of computing fees for distances travelled, a land surveyor shall regard his registered address as his headquarters.

(4) When a land surveyor practises he may use no other address than his registered address.”.

3. Rule 7 of the rules is hereby amended—

(a) by the substitution for subrule (2) of the following subrule:

“(2) publishing any information about his name, professional status, practice, partners or their branch office in any directory, or permitting any person other than the council of an institute of land surveyors referred to in section 3 (1) of the Act, to publish such information;”;

(b) by deleting subrule (6) (c);

(c) by the substitution for subrule (10) of the following subrule:

“(10) charging or quoting fees for professional services in conflict with those prescribed under the Land Survey Act, 1927 (Act 9 of 1927), or in the Sectional Titles Act, 1971 (Act 66 of 1971);”;

(d) by deleting in subrule (29) all the words that follow the word “firm” where it appears for the first time; and

(e) by the addition of the following paragraphs after subrule (30) (ii) (h):

“(i) publishing his name, professional status, the name of his firm, the address and telephone number in the ordinary type used in the standard official telephone directory for the area in which his registered address is situated;

(j) permitting his name, professional status, the name of his firm, the address and telephone number to be listed in a membership list of an organisation of which he is a member;

(k) furnishing the following information in his letterhead:

(aa) The name under which the firm operates, which name shall consist of proper names and may include the names of present land surveyors in the firm and the names of present partners from professions with whom partnership may be formed and which partnership has been approved by the council in terms of rule 7 (9): Provided that a previous name of the firm may be used: Provided that the name of a past partner may be retained in the name of the firm;

(bb) a description of the service which can be rendered, such as land surveying, town planning, township planning, topographical and engineering surveying, mine surveying, sectional title surveying, photogrammetrical surveying, and property valuation: Provided that a term such as specialist or consultant may only be used if a partner or assistant at the particular office holds a qualification, diploma or degree recognised by the council, or in the opinion of the council possesses adequate experience to justify the use of such a term;

(cc) a list of names of the partners in the firm and the names of professionally registered assistants: Provided that where such partners or assistants operate from another office of the firm, this must be clearly stated with a reference to the name only of the town in which that office is situated;

(dd) the address of the office which shall be the registered address of the land surveyor or land surveyors operating from that office;

(3) Vir die berekening van gelde vir afstande afgelê, beskou 'n landmeter sy geregistreerde adres as sy hoofkwartier.

(4) Wanneer 'n landmeter praktiseer, gebruik hy geen ander adres as sy geregistreerde adres nie.”.

3. Reël 7 van die reëls word hierby gewysig—

(a) deur die vervanging van subreël (2) deur die volgende subreël:

“(2) in enige adresboek enige inligting publiseer ten opsigte van sy naam, professionele status, praktyk, vennote of hulle takkantoor, of enige persoon, uitgesonderd die raad van 'n instituut van landmeters bedoel in artikel 3 (1) van die Wet, toelaat om sodanige inligting te publiseer;”;

(b) deur die skrapping van subreël (6) (c);

(c) deur die vervanging van subreël (10) deur die volgende:

“(10) vir professionele dienste gelde vorder of noteer wat teenstrydig is met dié voorgeskryf kragtens die Opmetingswet, 1927 (Wet 9 van 1927), of die Wet op Deeltitels, 1971 (Wet 66 van 1971);”;

(d) deur die skrapping in subreël (29) van al die woorde wat volg na die woord “gebruik”, waar dit vir die eerste keer voorkom; en

(e) deur die byvoeging van die volgende paraagrafe na subreël (30) (ii) (h):

“(i) sy naam, professionele status, die naam van sy firma, die adres en telefoonnummer te publiseer in die gewone drukvorm in die standaard amptelike telefoonadresboek vir die gebied waarin sy geregistreerde adres is nie;

(j) toe te laat dat sy naam, professionele status, die naam van sy firma, die adres en telefoonnummer verskyn in 'n ledelys van 'n organisasie waarvan hy 'n lid is nie;

(k) die volgende besonderhede in sy briefhoof te verstrek nie:

(aa) Die naam waaronder die firma optree, welke naam uit eenname moet bestaan en die name mag insluit van teenswoordige landmeters in die firma en die name van teenswoordige vennote uit professies met wie vennootskap aangegaan mag word en welke vennootskap deur die raad kragtens reël 7 (9) goedgekeur is: Met dien verstande dat 'n vorige naam van die firma gebruik mag word: Met dien verstande voorts dat die naam van 'n vorige vennoot in die naam van die firma behou mag word;

(bb) 'n beskrywing van die diens wat gelewer kan word, soos landmeting, dorpsbeplanning, dorpsaanlegbeplanning, topografiese en ingenieursopmeting, mynometing, deeltitelopmeting, fotogrammetriese opmeting en eiendomswaardering: Met dien verstande dat 'n benaming soos spesialis of konsultant gebruik mag word slegs indien 'n vennoot of 'n assistent by die besondere kantoor beskik oor 'n kwalifikasie, diploma of graad deur die raad erken, of na die mening van die raad oor voldoende ondervinding beskik om die gebruik van sodanige benaming te regverdig;

(cc) 'n lys van name van die vennote in die firma en die name van professioneel geregistreerde assistente: Met dien verstande dat waar sodanige vennote of assistente uit 'n ander kantoor van die firma optree, dit duidelik so gestel moet word met 'n verwysing na slegs die naam van die dorp waarin die ander kantoor geleë is;

(dd) die adres van die kantoor, wat die geregistreerde adres is van die landmeter of landmeters wat uit daardie kantoor optree;

(ee) the postal and telegraphic address of the office;

(ff) the telephone numbers of the office and the home telephone numbers of the partners whose registered addresses are in the town where such office is situated:

Provided that nothing contained in this paragraph shall be construed as constituting a contravention of the provisions of rule 7 (6) (b)."

IMPORT AND EXPORT CONTROL.—AMENDMENT TO EXPORT REGULATIONS

I, Schalk Willem van der Merwe, Minister of Industries and of Commerce and Consumer Affairs, acting under and by virtue of the powers vested in me by section 2 of the Import and Export Control Act, 1963 (Act 45 of 1963), hereby amend Government Notice R. 637, dated 23 April 1971, as follows:

1. The substitution for the item "(d) compounds containing more than 35 per cent molybdenum (except molybdenum organic artificial colouring matters containing less than 50 per cent molybdenum);", where it appears under the heading "Molybdenum, as follows . . . NIE" in Group 3 of Schedule I, of the item "(d) compounds containing more than 5 per cent molybdenum (except molybdenum organic artificial colouring matters containing less than 50 per cent molybdenum);".

BOITHUSONG PUBLIC IN-SERVICE TRAINING CENTRE, BLOEMFONTEIN.—REPEAL OF GOVERNMENT NOTICE AND IMPOSITION, PAYMENT AND COLLECTION OF A LEVY IN TERMS OF THE BLACK EMPLOYEES' IN-SERVICE TRAINING ACT, 1976 (ACT 86 OF 1976)

I, Ferdinand Hartzenberg, Minister of Education and Training—

(a) acting in terms of section 14 (4) of the Black Employees' In-Service Training Act, 1976 (Act 86 of 1976), hereby repeal Government Notice R. 1929, dated 23 September 1977, with effect from 1 June 1980;

(b) acting in terms of section 14 (3) of the aforementioned Act, hereby impose the following levy at the request of the governing body of the Boithusong Public In-Service Training Centre, Bloemfontein, and after consultation with the Co-ordinating Council for In-Service Training of Black Employees, which shall be payable in terms of the provisions contained in the Schedule hereto; and

(c) acting in terms of section 15 (2) of the aforementioned Act, hereby authorise the Administration Board for the Southern Orange Free State Area, the Administration Board for the Orange Vaal Area and the Administration Board for the Northern Cape Area to collect the said levy on behalf of the governing body of the Boithusong Public In-service Training Centre.

To all to whom these presents shall come.

Greetings!

Whereas it is desired to grant recognition for death-defying deeds by members of the South African Prisons Service in the discharge of their duties or in the protection or saving of, or endeavour to protect or save, life or property;

And whereas it is considered fitting to honour such members in an appropriate manner:

Now, therefore, I do hereby institute, constitute and create a decoration designated "THE SOUTH AFRICAN PRISONS SERVICE CROSS FOR VALOUR (DIAMOND) : DIE SUID-AFRIKAANSE GEVANGENISDIENS SE KRUIS VIR DAPPERHEID (DIAMANT)" as an honourable tribute for such acts, and further ordain that the following rules, together with such regulations as may be made, shall govern the award of the decoration:

1. The decoration shall take precedence over any other decorations or medals awarded by the South African Prisons Service except for "THE DECORATION FOR VALOUR IN THE SOUTH AFRICAN PRISONS SERVICE" awarded before 1 December 1979.

2. Both the decoration and the bar in respect thereof shall be awarded on the recommendation of the Minister of Prisons of the Republic of South Africa, and on the recommendation of the said Minister such award may also be cancelled, annulled declared forfeited or restored.

3. The decoration shall be of gold and shall be in the form of a white Maltese Cross upon which shall be superimposed a red Maltese Cross, both bordered in gold and with a diamond in the centre. On the reverse side shall appear the words DAPPERHEID on the left point and VALOUR on the right point, with the coat of arms of the Republic of South Africa on the upper point and a serial number on the lower point. The laurel from which the decoration depends shall be minted to the bar from which it depends.

4. The watered silk ribbon from which the medal depends shall be red in colour and 32 mm in width.

5. The bar, which may be awarded in terms of rule 7, shall be of gold, 32 mm in length and 6 mm in width, with the observe of the decoration embossed in the centre. A clasp corresponding to the aforementioned description shall be issued in respect of every bar awarded.

(ii) 20 jaar diens; of

(iii) 10 jaar diens, wat nie aaneenlopend hoeft te wees nie, voltooi het en gedurende daardie tydperk troue diens gelewer en voorbeeldige gedrag aan die dag gelê het.

4. (i) Die medalje vir 30 jaar diens is van sterlingsilwer, goudgeplateerd en sirkelvormig, met die wapen van die Republiek van Suid-Afrika in die middel omring deur 'n suikerbosblomkrans. Op die keersy verskyn die woorde TROUE DIENS en FAITHFUL SERVICE met die amptelike kenteken van die Departement van Gevangenis en 'n volgnommer. Die hegstuks waaraan die medalje aan die gespe hang, is vas aan die medalje en gespe gemunt.

(ii) Die medalje vir 20 jaar diens is van sterlingsilver en sirkelvormig met die wapen van die Republiek van Suid-Afrika in die middel omring deur 'n suikerbosblomkrans. Op die keersy verskyn die woorde TROUE DIENS en FAITHFUL SERVICE met die amptelike kenteken van die Departement van Gevangenis en 'n volgnommer. Die hegstuks waaraan die medalje aan die gespe hang, is vas aan die medalje en gespe gemunt.

(iii) Die medalje vir 10 jaar diens is van brons en sirkelvormig met die wapen van die Republiek van Suid-Afrika in die middel omring deur 'n suikerbosblomkrans. Op die keersy verskyn die woorde TROUE DIENS en FAITHFUL SERVICE met die amptelike kenteken van die Departement van Gevangenis en 'n volgnommer. Die hegstuks waaraan die medalje aan die gespe hang, is vas aan die medalje en gespe gemunt.

5. (i) Die lint van gewaterde sy waaraan die medalje vir 30 jaar diens hang, is geel van kleur en 32 mm breed met twee stelle van drie vertikale groen strepe, elk 2 mm breed en 2 mm vanmekaar, met die buitenste streep van elke stel 2 mm van die kant.

(ii) Die lint van gewaterde sy waaraan die medalje vir 20 jaar diens hang, is geel van kleur en 32 mm breed met twee stelle van twee vertikale groen strepe, elk 2 mm breed en 2 mm vanmekaar, met die buitenste streep van elke stel 2 mm van die kant.

(iii) The medal for 10 years' service shall be of for 10 years' service depends shall be yellow in colour and 32 mm in width with two vertical green stripes, each 2 mm wide and 2 mm from the side.

6. The bar, which may be awarded in terms of rule 7, shall be of sterling silver, gold-plated, 32 mm in length and 6 mm in width, with the obverse of the medal embossed in the centre. A clasp corresponding to the aforementioned description shall be issued in respect of every bar awarded.

7. To a member of the Prisons Service who has been awarded "THE SOUTH AFRICAN PRISONS SERVICE MEDAL FOR FAITHFUL SERVICE" for 30 years' service and who has, after the date of such award, served as such a member for a further period of not less than 10 years, which need not be continuous, a bar may be awarded if he has continued to render faithful service and displayed exemplary conduct.

8. Both the medal and the bar in respect thereof may be awarded posthumously.

9. On the reverse of each medal shall be stamped, transversely, a serial number.

10. The name of each person to whom the medal or bar is awarded shall be published officially. A commissioned officer appointed by the Commissioner of Prisons shall maintain a register in which the following shall be recorded in respect of each medal or bar so awarded:

- (a) The serial number;
- (b) the name of the recipient; and
- (c) the date of conferment.

11. The provisions of rule 10 shall *mutatis mutandis* be applicable to the cancellation, annulment, forfeiture, loss or restoration of a medal or bar.

12. The medal shall be worn on the left breast, and the bar awarded in respect thereof shall be attached to the ribbon. When the medal is not worn, only the ribbon shall be worn on the left breast, and where a bar has been awarded, the clasp which is issued with the bar shall be attached to the ribbon as an indication of the award of such bar.

13. The conferment of the medal and of a bar, shall not entitle the recipient to any personal precedence.

14. A miniature reproduction of the medal, bar or ribbon, half the size of the original, may be worn on appropriate occasions.

15. A sealed model of the medal as well as of the bar and the ribbon in respect thereof shall, together with a model of the miniature reproduction thereof, be kept in safe custody in the Office of the Commissioner of Prisons or in such other place as the Minister may decide.

6. Die balk wat kragtens reël 7 toegeken kan word, is van sterlingsilwer, goudgeplateerd, 32 mm lank en 6 mm breed, met die voorcant van die medalje in die middel gebosseer. 'n Gespe wat met die voorafgaande beskrywing ooreenstem, word uitgereik vir die balk wat toegeken word.

7. Aan 'n lid van die Gevangenisdiens aan wie "DIE SUID-AFRIKAANSE GEVANGENISDIENS SE MEDALJE VIR TROUE DIENS" vir 30 jaar diens toegeken is en wat na die datum van sodanige toekenning vir 'n verdere tydperk van minstens 10 jaar, wat nie aaneenlopend hoef te wees nie, as so 'n lid gedien het, kan 'n balk toegeken word as hy voortgegaan het om troue diens te lewer en voorbeeldige gedrag aan die dag lê.

8. Die medalje asook die balk daarvoor kan postuum toegeken word.

9. Op die keersy van elke medalje of balk wat toegeken word, word 'n volgnommer dwars in die middel gestempel.

10. Die naam van elke persoon aan wie die medalje of balk toegeken word, word amptelik aangekondig. 'n Offisier, aangewys deur die Kommissaris van Gevangenis, moet 'n register byhou waarin die volgende aangegetekend word omtrent elke medalje of balk aldus toegeken:

- (a) Die volgnommer;
- (b) die naam van die ontvanger; en
- (c) die datum van toekenning.
