**AMENDMENT OF THE REGULATIONS IN
TERMS OF THE POPULATION REGISTRATION
ACT, 1950 (ACT 30 OF 1950)**

The State President has, in terms of section 20 of the Population Registration Act, 1950 (Act 30 of 1950), made the regulations set out in the Schedule, hereto with effect from 1 June 1980:

SCHEDULE

1. In these regulations "the Regulations" means the regulations published under Government Notice R. 748 of 5 May 1972, as amended by Government Notices R. 770 of 3 May 1974, R. 797 of 25 April 1975 and R. 924 of 27 May 1977.

**WYSIGING VAN DIE REGULASIES KRAGTENS
DIE BEVOLKINGSREGISTRASIEWET, 1950 (WET
30 VAN 1950)**

Die Staatspresident het kragtens artikel 20 van die Bevolkingsregistrasiewet, 1950 (Wet 30 van 1950), die regulasies wat in die Bylae uiteengesit is, met ingang van 1 Junie 1980 uitgevaardig:

BYLAE

1. In hierdie regulasies beteken "die Regulasies" die regulasies uitgevaardig by Goewermentskennisgewing R. 748 van 5 Mei 1972, soos gewysig by Goewermentskennisgewings R. 770 van 3 Mei 1974, R. 797 van 25 April 1975 en R. 924 van 27 Mei 1977.

2. The following regulation is hereby substituted for regulation 3 of the Regulations:

"3. An application for an identity document or a certificate of particulars of birth as included in the Population Register referred to in section 13 (1) of the Act shall be made—

(a) in the case of a person under the age of 16 years, on Form B-I 8 in the Schedule; and

(b) in the case of a person of 16 years and older, on Form B-I 9 in the Schedule."

3. The following regulation is hereby substituted for regulation 4 of the Regulations:

"4. Any person to whom an identity document or a certificate of particulars of birth as included in the Population Register, for persons under the age of 16 years has been issued, shall, after attaining that age, apply on Form B-I 11 in the Schedule for an identity document for persons of 16 years and older and shall submit, if an identity document has already been issued to him, such identity document together with the application, unless satisfactory reasons are furnished in writing why such identity document cannot be returned."

4. The following regulation is hereby substituted for regulation 5 of the Regulations:

"5. (1) Subject to the provisions of section 15 of the Act, the Secretary shall if any person has lost his identity document or if it has been damaged or stolen, or if a driver's licence contained therein has been withdrawn or cancelled or suspended or a licence to possess an arm contained therein, has been cancelled, or if the person has contracted a first or subsequent marriage, or has obtained a first or subsequent driver's licence, or if the person's particulars have been altered in terms of the Births, Marriages and Deaths Registration Act, 1963, or any other Act, issue to such person a duplicate or amended identity document, as the case may be, on receipt of—

(a) an application on Form B-I 10 in the Schedule; and

(b) the sum of R2, unless the replacement is necessitated by an amendment in respect of which an amount has already been paid in terms of the Births, Marriages and Deaths Registration Act, 1963, or any other Act, or by the amendment of the person's nationality, or by the fact that the holder contracted a first or subsequent marriage or obtained a first or subsequent driver's licence, or by the fact that the person has not received the identity document which was issued to him by the Secretary; and

(c) two copies of a recent photograph of the person; and

(d) if an identity document which has already been issued to the person, such identity document, unless satisfactory reasons are furnished in writing why such identity document cannot be returned, in which case the application must be sworn to/affirmed to in the presence of a justice of the peace, commissioner of oaths or police officer.

2. Regulasie 3 van die Regulasies word hierby deur die volgende regulasie vervang:

"3. Aansoek om 'n identiteitsdokument of 'n sertifikaat van geboortebeonderhede soos opgeneem in die Bevolkingsregister bedoel in artikel 13 (1) van die Wet, word gedoen—

(a) in die geval van 'n persoon onder die ouderdom van 16 jaar, op vorm B-I 8 in die Bylae; en

(b) in die geval van 'n persoon van 16 jaar of ouer, op vorm B-I 9 in die Bylae."

3. Regulasie 4 van die Regulasies word hierby deur die volgende regulasie vervang:

"4. Iemand aan wie 'n identiteitsdokument of 'n sertifikaat van geboortebeonderhede soos opgeneem in die Bevolkingsregister, vir persone onder die ouderdom van 16 jaar uitgereik is, moet na bereiking van daardie ouderdom op vorm B-I 11 in die Bylae aansoek doen om 'n identiteitsdokument vir persone van 16 jaar of ouer en moet, indien 'n identiteitsdokument voorheen aan hom uitgereik is, sodanige identiteitsdokument saam met die aansoek instuur, tensy bevredigende redes waarom sodanige identiteitsdokument nie teruggestuur kan word nie, skriftelik verstrek word."

4. Regulasie 5 van die Regulasies word hierby deur die volgende regulasie vervang:

"5. (1) Behoudens die bepalings van artikel 15 van die Wet, moet die Sekretaris indien iemand se identiteitsdokument weggeraak het of gesteel of beskadig is, of indien 'n bestuurderslisensie ingetrek of gekanselleer of opgeskort is, of indien 'n lisensie om 'n wapen te besit wat in die dokument opgeneem is, gekanselleer is, of indien die persoon 'n eerste of 'n verdere huwelik aangegaan het, of 'n eerste of 'n verdere bestuurderslisensie verkry het, of indien die persoon se besonderhede gewysig is ingevolge die Wet op die Registrasie van Geboortes, Huwelike en Sterfgevälle, 1963, of enige ander Wet, aan sodanige persoon 'n duplikaat- of gewysigde identiteitsdokument, al na gelang van die geval, uitreik by ontvangs van—

(a) 'n aansoek op vorm B-I 10 in die Bylae; en

(b) 'n bedrag van R2, tensy die vervanging nodig is weens 'n wysiging waarvoor 'n bedrag reeds betaal is ingevolge die Wet op die Registrasie van Geboortes, Huwelike en Sterfgevälle, 1963, of enige ander Wet, of weens die verandering van die persoon se nasionaliteit, of weens die feit dat die houer 'n eerste of 'n verdere huwelik aangegaan het of 'n eerste of verdere bestuurderslisensie verkry het, of weens die feit dat die persoon nie die identiteitsdokument wat die Sekretaris aan hom uitgereik het, ontvang het nie; en

(c) twee eksemplare van 'n onlangse foto van die persoon; en

(d) die identiteitsdokument wat voorheen aan die persoon uitgereik is, tensy bevredigende redes skriftelik verstrek word waarom die identiteitsdokument nie teruggegee kan word nie, in welke geval die aansoek in teenwoordigheid van 'n vrederegtter, kommissaris van ede of polisiebeampte beëdig of bevestig moet word.

(2) The Secretary may, notwithstanding the provisions of subregulation (1), order the reissue of an identity document or a certificate of particulars of birth as included in the Population Register, free of charge if he is satisfied that the loss of such document was not caused by negligence of the person referred to in subregulation (1) or any other person including any Government Department, in whose possession the document was at the time of such loss."

5. The following regulation is hereby substituted for regulation 6 of the Regulations:

"6. A certificate of particulars of birth as included in the Population Register shall be issued on Form B-I 1 in the Schedule and an identity document for a person of 16 years and older shall be issued on Form B-I 2 in the Schedule."

6. Regulation 8 of the Regulations is hereby amended by the substitution for subregulations (b) and (c), respectively, of the following subregulations:

(b) Digits 7 to 10, inclusive, are a serial number from 0001 to 9999. Serial numbers 0001 to 4999, inclusive, are allocated to female persons and numbers 5001 to 9999, inclusive, to male persons.

(c) Digits 11 and 12 represent the citizenship and the population group to which the person belongs, as follows:

7. The following regulation is hereby substituted for regulation 9 of the Regulations:

"9. (1) Any person referred to in section 10 (1) of the Act shall notify the Secretary on Form B-I 4 in the Schedule of any permanent change of his ordinary place of residence or postal address.

(2) After receipt of such notification the Secretary shall issue to such person an acknowledgement on Form B-I 3 in the Schedule on which his new place of residence and postal address are reflected as they appear in the Population Register.

(3) If such acknowledgement is not received within 14 days of the date on which the Secretary was notified of the change of address or if such acknowledgement is received but subsequently lost, the person referred to in subregulation (1) shall notify the Secretary in writing to this effect.

(4) The person referred to shall ensure that the acknowledgement is inserted in the relevant identity document, as indicated.

(5) Any person who has consented to the taking up of residence on any premises by a person of 16 years and older to whom an identity document has been issued shall, subject to section 10 (2) of the Act, either—

(a) furnish the Secretary with the following information on Form B-I 102 in the Schedule within 14 days after the taking up of such residence, namely:

(i) The identity number, surname and initial(s) and date of birth of the person to whom consent to the taking up of residence was given;

(2) Die Sekretaris kan ondanks die bepalings van subregulasie (1), die gratis heruitreiking van 'n identiteitsdokument of 'n sertifikaat van geboortebesonderhede soos opgeneem in die Bevolkingsregister, gelas indien hy oortuig is dat die verlies van sodanige dokument nie te wyte was nie aan die nalatigheid van die persoon bedoel in subregulasie (1) of enige ander persoon insluitende enige Staatsdepartement in wie se besit sodanige dokument was ten tye van die verlies daarvan."

5. Regulasie 6 van die Regulasies word hierby deur die volgende regulasie vervang:

"6. 'n Sertifikaat van geboortebesonderhede soos opgeneem in die Bevolkingsregister, moet op vorm B-I 1 in die Bylae uitgereik word en 'n identiteitsdokument vir 'n persoon van 16 jaar of ouer op vorm B-I 2 in die Bylae."

6. Regulasie 8 van die Regulasies word hierby gewysig deur subregulasies (b) en (c) deur onderskeidelik die volgende subregulasies te vervang:

(b) Die 7de tot en met die 10de syfer is 'n volgnummer, van 0001 tot 9999. Volgnommers 0001 tot en met 4999 word aan vroulike persone toegeken en nommers 5001 tot en met 9999 aan manlike persone.

(c) Die 11de en 12de syfer dui die burgerskap en bevolkingsgroep aan waaraan die persoon behoort, soos volg:

7. Regulasie 9 van die Regulasies word hierby deur die volgende regulasie vervang:

"9. (1) 'n Persoon bedoel in artikel 10 (1) van die Wet, moet die Sekretaris op vorm B-I 4 in die Bylae in kennis stel van enige permanente verandering van sy gewone verblyfplek of posadres.

(2) Ná ontvangs van sodanige kennisgewing moet die Sekretaris 'n ontvangsbewys aan die persoon uitreik op vorm B-I 3 in die Bylae, waarop sy nuwe woonadres en posadres soos dit in die Bevolkingsregister opgeneem is, getoon word.

(3) Indien sodanige ontvangsbewys nie ontvang word nie binne 14 dae vanaf die datum waarop kennis van verandering van adres aan die Sekretaris gegee is of indien dit ná die ontvangs daarvan verlore geraak het moet die persoon bedoel in subregulasie (1), die Sekretaris skriftelik daarvan in kennis stel.

(4) Bedoelde persoon moet toesien dat die ontvangsbewys op die aangewese plek in die betrokke identiteitsdokument geplaas word.

(5) Iemand wat aan 'n persoon wat 16 jaar of ouer is en aan wie 'n identiteitsdokument uitgereik is, toestemming verleen het om sy intrek op enige perseel te neem, moet, behoudens artikel 10 (2) van die Wet, of—

(a) die volgende besonderhede aan die Sekretaris verstrek op vorm B-I 102 in die Bylae binne 14 dae nadat aldus intrek geneem is, naamlik:

(i) Die identiteitsnommer, van, voorletter(s) en geboortedatum van die persoon aan wie toestemming verleen is om intrek te neem;

- (ii) the address of the premises; and
- (iii) the date of taking up of residence; or
- (b) after the expiration of 14 days from the taking up of such residence take the following steps, namely:

(i) Request the person to whom such consent was given to furnish him with his identity number, surname and initial(s) and date of birth and to produce to him the acknowledgement referred to in subregulation (2) in respect of himself;

(ii) ascertain whether the residential address which appears on the acknowledgement so produced is the same as the address of the premises on which the person concerned has taken up residence; and

(iii) if he has ascertained that the person who has taken up residence on the said premises has not notified the Secretary of the change of his place of residence, or if he cannot ascertain whether such person has done so or not, within 28 days after the taking up of such residence, subject to section 10 (3) of the Act, notify the Secretary on Form B-I 102 in the Schedule that those premises are the place of residence of that person.

(6) A person of 16 years and older to whom consent has been given to take up residence referred to in subregulation (5) shall, after receipt of the request referred to in subregulation (5) (b), without delay furnish the required information and produce the said acknowledgement to the person who consent to the taking up of residence.”.

8. The following regulation is hereby substituted for regulation 10 of the Regulations:

“10. The Secretary shall, when he is required to do so, affix the following certificates and licences in an identity document:

(a) Certificate of particulars of marriage as included in the Population Register, which indicates the following:

(c) A copy of a licence to possess an arm issued in terms of the Arms and Ammunition Act, 1969.

- (iii) die datum waarop intrek geneem is; of
- (b) na verloop van 14 dae nadat aldus intrek geneem is, die volgende stappe doen, naamlik:

(i) Die persoon aan wie sodanige toestemming verleen is, versoek om sy identiteitsnommer, van, voorletter(s) en geboortedatum aan hom te verskaf en die ontvangsbewys bedoel in subregulasie (2), aan hom voor te lê;

(ii) nagaan of die woonadres wat verskyn op die ontvangsbewys wat aldus voorgelê word, dieselfde is as die adres van die perseel waarop die betrokke persoon intrek geneem het; en

(iii) indien hy vasgestel het dat die persoon wat op genoemde perseel intrek geneem het, nie die Sekretaris van die verandering van sy woonadres in kennis gestel het nie, of indien hy nie kan vasstel of sodanige persoon dit gedoen het nie, al dan nie, die Sekretaris, behoudens artikel 10 (3) van die Wet, binne 28 dae nadat aldus intrek geneem is, op vorm B-I 102 in die Bylae in kennis stel dat daardie perseel die verblyfplek van sodanige persoon is.

(6) 'n Persoon, wat 16 jaar en ouer is en aan wie toestemming verleen is om intrek te neem soos in subregulasie (5) bedoel, moet onverwyld na ontvangs van die versoek bedoel in subregulasie (5) (b), die verlangde inligting verstrek en bedoelde ontvangsbewys voorlê aan die persoon wat toestemming verleen het om intrek te neem.”.

8. Regulasie 10 van die Regulasies word hierby deur die volgende regulasie vervang:

“10. Wanneer dit van hom verlang word, moet die Sekretaris die volgende sertifikate en lisensies in 'n identiteitsdokument aanbring:

(a) Sertifikaat van huweliksbesonderhede soos opgeneem in die Bevolkingsregister, wat die volgende aandui:

(b) Bestuurderslisensie(s), wat die volgende aandui:

(c) Afskrif van 'n lisensie om 'n wapen te besit uitgereik kragtens die Wet op Wapens en Ammunisie, 1969.

(d) An endorsement in respect of a change of marital status due to divorce or the death of the husband or wife."

9. The following regulation is hereby substituted for regulation 11 of the Regulations:

"11. Any person who, in terms of any road traffic ordinance, is authorised to issue driver's licences, shall issue a driver's licence on the appropriate form prescribed by regulation in terms of such ordinance and hand it to the person concerned, who must submit it to the Secretary, on receipt of which he shall affix it in the identity document of that person."

10. The following regulation is hereby substituted for regulation 13 of the Regulations:

"13. A marriage officer shall issue a marriage certificate, which must be affixed in an identity document, on Form B-I 27 in the Schedule to the regulations promulgated in terms of the Births, Marriages and Deaths Registration Act, 1963, and hand it to the person concerned, who must submit it to the Secretary, on receipt of which he shall affix it in the identity document of that person."

11. Regulation 14 of the Regulations is hereby repealed, and regulations 15, 16 and 17 are hereby renumbered "14", "15" and "16", respectively.

12. The following regulation is hereby substituted for regulation 16 (renumbered to 15) of the Regulations:

"15. The Secretary may in his discretion post a person's identity document to him or, if he is under the age of 16 years, post his certificate of particulars of birth as included in the Population Register, to his guardian, or hand such document to him or his guardian or a person authorised thereto in writing by the person or his guardian."

13. The following regulation is hereby substituted for regulation 17 (renumbered to 16) of the Regulations:

"16. Any person authorised thereto in writing by the Secretary may, when it comes to his notice that an identity document or a certificate of particulars of birth was issued to a person in error, seize such document, and the person to whom such document was issued or the guardian of a person under the age of 16 years or any person who is in possession of such document shall surrender it forthwith to the said authorised person."

14. Regulation 18 of the Regulations is hereby repealed, and regulations 19 and 20 are hereby renumbered "17" and "18", respectively.

15. (a) Forms B-I 1, B-I 2, B-I 3, B-I 4 and B-I 10 in the Schedule to the Regulations are hereby replaced by the following forms:

(b) Forms B-I 5, B-I 29, B-I 40, B-I 42, B-I 52 and B-I 101 in the Schedule to the Regulations are hereby deleted.

(d) Endossement ten opsigte van 'n huwelikstaatverandering by egskeiding of by die afsterwe van die eggenoot of eggenote."

9. Regulasie 11 van die Regulasies word hierby deur die volgende regulasie vervang:

"11. Iemand wat kragtens enige ordonnansie op padverkeer gemagtig is om bestuurderslisensies uit te reik, moet 'n bestuurderslisensie, wat in 'n identiteitsdokument aangebring moet word, op die toepaslike vorm wat by regulasie kragtens sodanige ordonnansie voorgeskryf is, uitreik en oorhandig aan die applikant, wat dit aan die Sekretaris moet voorlê, by ontvangs waarvan dit in die identiteitsdokument van die betrokke persoon aangebring word."

10. Regulasie 13 van die Regulasies word hierby deur die volgende regulasie vervang:

"13. 'n Huweliksbevestiger moet 'n huweliksertifikaat, wat in 'n identiteitsdokument aangebring moet word, op vorm B-I 27 in die Bylae van die regulasies uitgevaardig kragtens die Wet op die Registrasie van Geboortes, Huwelike en Sterfgevälle, 1963, uitreik en oorhandig aan die persoon, wat dit aan die Sekretaris moet voorlê, by ontvangs waarvan dit in die identiteitsdokument van die betrokke persoon aangebring word."

11. Regulasie 14 van die Regulasies word hierby herroep, en regulasies 15, 16 en 17 word hierby onderskeidelik hernommer tot "14", "15" en "16".

12. Regulasie 16 (hernommer tot 15) van die Regulasies word hierby deur die volgende regulasie vervang:

"15. Die Sekretaris kan na goeë dunde 'n persoon se identiteitsdokument aan hom pos of, indien hy onder die ouderdom van 16 jaar is, sy sertifikaat van geboortebesonderhede soos opgeneem in die Bevolkingsregister, aan sy voog pos, of aan hom of sy voog of iemand wat skriftelik deur hom of sy voog daartoe gemagtig is, oorhandig."

13. Regulasie 17 (hernommer tot 16) van die Regulasies word hierby deur die volgende regulasie vervang:

"16. Enigeen wat deur die Sekretaris skriftelik daartoe gemagtig is, kan, wanneer dit onder sy aandag kom dat 'n identiteitsdokument of sertifikaat van geboortebesonderhede verkeerdlik aan iemand uitgereik is, beslag lê op sodanige dokument, en die persoon aan wie sodanige dokument uitgereik is of die voog van iemand onder die ouderdom van 16 jaar of enigiemand wat in besit van sodanige dokument is, moet die dokument onverwyld aan bedoelde gemagtigde persoon oorhandig."

14. Regulasie 18 van die Regulasies word hierby herroep, en regulasies 19 en 20 word hierby onderskeidelik hernommer tot "17" en "18".

15. (a) Vorms B-I 1, B-I 2, B-I 3, B-I 4 en B-I 10 in die Bylae van die Regulasies word hierby deur onderskeidelik die volgende vorms vervang:

(b) Vorms B-I 5, B-I 29, B-I 40, B-I 42, B-I 52 en B-I 101 in die Bylae van die Regulasies word geskrap.
