No. R. 1180 9 June 1980

**TIME AND MANNER OF PAYMENT OF LEVIES AND SPECIAL LEVIES ON DAIRY PRODUCTS**

The Minister of Agriculture and Fisheries has, under the powers vested in him by section 89 of the Marketing Act (Act 59 of 1968), made the regulations set out in the Schedule hereto, in substitution of the regulations published by Government Notice R. 2003 of 29 October 1976.

**SCHEDULE**

1. In these regulations, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the Dairy Control Scheme, published by Proclamation R. 290 of 1978, as amended, shall have a corresponding meaning and—

“month” means the period extending from the first to the last day, both days inclusive, of any of the 12 months of a year.

2. A levy and special levy imposed under section 21 or 22 of the said Scheme shall be paid to Board not later than the fifteenth day of the month, immediately following the month in which—

- (a) the industrial milk or cream concerned had been acquired; or
- (b) the product concerned had been manufactured for sale.

3. Any payment to the Board in terms of regulation 2 shall be accompanied by a return indicating the total quantity of such industrial milk acquired and/or the quantity of such dairy product manufactured for sale during the month in respect of which such payment is effected.

**TYD EN WYSE VAN BETALING VAN HEFFINGS EN SPESIALE HEFFINGS OP SUIWELPRODUKTE**

Die Minister van Landbou en Visserye het, kragtens die bevoegdheid hom verleen by artikel 89 van die Bemarkingswet, 1968 (Wet 59 van 1968), die regulasies in die Bylae hiervan uiteengesit gemaak ter vervanging van die regulasies, aangekondig by Goewermenskennisgewing R. 2003 van 29 Oktober 1976.

**BYLAE**

1. In hierdie regulasies, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan in die Suiwelbeheerskema, aangekondig by Proklamasie R. 290 van 1978, soos gewysig, 'n betekenis geheg is, 'n ooreenstemmende betekenis, en beteken—

“maand” die tydperk wat strek van die eerste tot die laaste dag, albei dae ingesluit, van enige van die 12 maande van 'n jaar.

2. 'n Heffing en spesiale heffing opgelê ingevolge artikel 21 of 22 van genoemde Skema moet aan die Raad betaal word nie later nie as die vyftiende dag van die maand wat volg op die maand waarin die—

- (a) betrokke nywerheidsmelk of room verkry is;
- of

(b) betrokke suiwelproduk vir verkoop vervaardig is.

3. Enige betaling aan die Raad ingevolge regulasie 2 moet vergesel gaan van 'n opgawe waarin die totale hoeveelheid van sodanige nywerheidsmelk verkry en/of die hoeveelheid van die betrokke suiwelproduk vir verkoop vervaardig aangetaan word vir die maand ten opsigte waarvan daardie betaling geskied.

4. Whenever the Board has imposed a prohibition under section 44 of the said Scheme, he may recover the amount of any levy or special levy due to him, by deducting it from any amount payable to the butter manufacturer or cheese manufacturer concerned under section 45 (5) or 47 (5) of the said Scheme.

5. These regulations shall come into operation on the date of publication thereof and repeals Government Notice R. 2003 of 29 October 1976 with effect from the same date.

1. In this notice, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the Dairy Control Scheme, published by Proclamation R. 290 of 1978, as amended, shall have a corresponding meaning, and—

“Durban Area” means the area within a radius of 25 km from the City Hall, Durban, including Amanzimtoti, Hillcrest and Verulam;

“milk” excludes industrial milk and sterilised or UHT-pasteurised milk;

“Pietermaritzburg Area” means the area within the Borough of Pietermaritzburg.

**MAXIMUM PRICES OF MILK.—AMENDMENT**

I, Elias George de Beer, Price Controller, acting under the powers assigned to me in terms of section 4 of the Price Control Act, 1964 (Act 25 of 1964), do hereby further amend Government Notice R. 1027 (*Government Gazette* 4715) of 23 May 1975, as amended, as follows:

1. The following clause is hereby substituted for clause 1:

"1. (1) The maximum price at which fresh milk may be sold to a distributor within the municipal area of Kimberley by a producer or may be purchased by such a distributor from a producer is, 26,615c per litre.

(2) The maximum price at which fresh milk may be sold to a distributor in the Port Elizabeth area by a producer or may be purchased by such a distributor from a producer, is 25,795c per litre.

(3) The maximum price at which fresh milk may be sold to a distributor within the Orange Free State Goldfields by a producer or may be purchased by such a distributor from a producer, is 26,104c per litre."

2. The definition of "Durban" and "Pietermaritzburg" where it appears in clause 6 is hereby deleted.

#### TIME AND MANNER OF PAYMENT OF LEVIES AND SPECIAL LÉVIES ON FRESH MILK

#### SCHEDULE

1. In these regulations, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the Dairy Control Scheme, published by Proclamation R. 290 of 1978, as amended, shall have a corresponding meaning and—

“month” means the period extending from the first to the last, both days inclusive, of any of the twelve months of the year.

2. A levy and special levy on fresh milk produced for sale, imposed under section 21 or 22 of the said Scheme, shall be paid to the Dairy Control Board at the times and in the manner as set out hereunder:

(a) In the case of a producer, producer-distributor or producer to whom a permit has been issued in terms of section 36 of the said Scheme, who delivers fresh milk to distributors, producer-distributors or the surplus pool mentioned in section 37 of the said Scheme, payment of such levy shall be made by means of a set-off by the Board against any amount of money that may be due by the Board to such person;

(b) in the case of a producer-distributor or a producer to whom a permit has been issued in terms of section 36 of the said Scheme, who delivers fresh milk to persons other than distributors, producer-distributors or the Surplus Pool mentioned in section 37 of the said Scheme, payment of such levy and special levy shall be made direct to the Board on or before the seventh day of each month following the month in which such fresh milk had been sold, and which payment must be accompanied by a return which shall be furnished as prescribed by the Board in terms of the provisions of section 29 of the said Scheme;

(c) in the case of a person in an area other than a controlled area who purchases fresh milk from a producer for the purpose of resale in such an area or for use of milk so purchased in the manufacture of fresh milk products payment of such levy and special levy shall be made direct to the Board on or before the 15th day of each month following the month in which such fresh milk had been purchased; and

(d) in the case of a producer who sells fresh milk directly to consumers in an area other than a controlled area payment of such levy or special levy shall be made direct to the Board on or before the 15th day of each month following the month in which such fresh milk had been sold.

#### BYLAE

1. In hierdie regulasies, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan in die Suiwelbeheerskema, aangekondig by Proklamasie R. 290 van 1978, soos gewysig, 'n betekenis geheg is, 'n ooreenstemmende betekenis en beteken—

“maand die tydperk wat strek van die eerste tot die laaste dag, albei dae ingesluit, van enige van die twaalf maande van 'n jaar.

2. 'n Heffing en spesiale heffing opgelê ingevolge artikel 21 of 22 van genoemde Skema op Varsmelk wat geproduceer is vir verkoop, moet aan die Suiwelbeheerraad betaal word op dié tye en wyse soos hieronder uiteengesit:

(a) In die geval van 'n produsent, produsent-distribueerder of produsent aan wie 'n permit kragtens artikel 36 van die genoemde Skema uitgereik is, wat varsmelek aan distribueerders, produsent-distribueerders of die surpluspoel genoem in artikel 37 van die genoemde Skema lewer, geskied die betaling van sodanige heffing en spesiale heffing by wyse van 'n verrekening deur die Suiwelbeheerraad teen enige bedrag geld wat deur die Raad aan so 'n persoon verskuldig mag wees;

(b) in die geval van 'n produsent-distribueerder of 'n produsent aan wie 'n permit kragtens artikel 36 van die genoemde Skema uitgereik is wat varsmelek aan persone anders as distribueerders, produsent-distribueerders of die surpluspoel genoem in artikel 37 van die genoemde Skema lewer, geskied die betaling van genoemde heffing en spesiale heffing regstreeks aan die Raad voor of op die sewende dag van die maand wat volg op die maand waarin sodanige varsmelek verkoop is, en welke betaling vergesel moet gaan van 'n opgaat wat verstrek moet word soos voorgeskryf deur die Raad kragtens die bepalings van artikel 29 van die genoemde Skema;

(c) in die geval van 'n persoon in 'n gebied anders as 'n beheerde gebied wat varsmelek van 'n produsent koop met die oog op herverkope in so 'n gebied of wat die varsmelek aldus aangekoop gebruik by die vervaardiging van varsmelekprodukte, geskied die betaling van genoemde heffing en spesiale heffing regstreeks aan die Raad voor of op die 15de dag van die maand wat volg op die maand waarin sodanige varsmelek aangekoop is;

(d) in die geval van 'n produsent wat varsmelek direk aan verbruikers in 'n gebied anders as 'n beheerde gebied verkoop, geskied die betaling van genoemde heffing en spesiale heffing regstreeks aan die Raad voor of op die 15de dag van die maand wat volg op die maand waarin sodanige varsmelek verkoop is.

3. Each payment to the Board in terms of regulation 2 (c) shall be accompanied by a statement indicating the volume fresh milk (in litre) which such person purchased from producers for—

(i) resale;

(ii) use in the manufacture of fresh milk products, also indicating which fresh milk products were manufactured.

4. Each payment to the Board in terms of regulation 2 (d) shall be accompanied by a statement indicating the volume fresh milk (in litre) which the producer has sold.

5. These regulations shall come into operation on the date of publication thereof and repeals Government Notice R. 1036 of 18 May 1979 with effect from the same date.

#### LEVY AND SPECIAL LEVY ON CERTAIN DAIRY PRODUCTS

In terms of section 79 (a) of the Marketing Act, 1968 (Act 59 of 1968), I, Hendrik Stephanus Johan Schoeman, Minister of Agriculture and Fisheries hereby make known that the Dairy Control Board, referred to in section 6 of the Dairy Control Scheme, published by Proclamation R. 290 of 1978, as amended, has in terms of sections 21 and 22 of that Scheme, with my approval, imposed the levy and special levy set out in the Schedule hereto, in substitution for the special levies published by Government Notice R. 2036 of 29 October 1976, as amended.

#### SCHEDULE

1. In this notice, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the Dairy Control Scheme, published by Proclamation R. 290 of 1978, as amended, shall have a corresponding meaning and—

“Class C milk” means industrial milk which, in the application of the Methylene Blue Test, discolours within a period of 30 minutes;

“cream” excludes cream supplied by a cheese or condensed milk manufacturer to a butter manufacturer;

“industrial milk”, milk contemplated in sections 21 (4) and 22 (5) of the said Scheme, excluding milk in respect of which a levy or special levy in terms of the said sections 21 and 22 of the said Scheme, has already been paid.

2. A levy and special levy at the rates set out below are hereby imposed on the following dairy products:
