BETREFFENDE VERVOER EN TOELAES

Dit het die Staatspresident behaag om kragtens die bevoegdheid hom verleen by artikel 2 van die Wet op Besoldiging van Regters, 1978 (Wet 91 van 1978), die Regulasies afgekondig by Goewermenskennisgewing R.15 van 7 Januarie 1972, soos gewysig, te wysig soos in die Bylae hiervan uiteengesit.

BYLAE

1. Regulasie 9 word gewysig—
 - (a) deur in subregulasie (1) die uitdrukking „25c” deur die uitdrukking „30c” te vervang; en
 - (b) deur in subregulasie (2A) die uitdrukking „25c” deur die uitdrukking „30c” te vervang.
2. Regulasie 10 word gewysig—
 - (a) deur in subregulasie (1) die uitdrukings „R30”, „R40” en „R20” deur onderskeidelik die uitdrukings „R43”, „R55” en „R28” te vervang; en
 - (b) deur in subregulasie (3) die uitdrukings „R30” en „R40” deur onderskeidelik die uitdrukings „R43” en „R55” te vervang.
3. Regulasie 11 word gewysig deur die uitdrukings „R270”, „R35” en „R1,25” deur onderskeidelik die uitdrukings „R330”, „R50” en „R1,75” te vervang.
4. Regulasie 11B word gewysig deur die uitdrukking „R10” deur die uitdrukking „R17,50” te vervang.

JUDGES—AMENDMENT OF REGULATIONS IN
RESPECT OF TRANSPORT AND ALLOWANCES

THE State President has, under and by virtue of the powers vested in him by section 2 of the Judges' Remuneration Act, 1978 (Act 91 of 1978), been pleased to amend the Regulations published under Government Notice R.15 of 7 January 1972, as amended, as set out in the Schedule hereto.

SCHEDULE

1. The amendment of regulation 9—
 - (a) by the substitution in subregulation (1) for the expression “25c” of the expression “30c”; and
 - (b) by the substitution in subregulation (2A) for the expression “25c” of the expression “30c”.
2. The amendment of regulation 10—
 - (a) by the substitution in subregulation (1) for the expressions “R30”, “R40” and “R20” of the expressions “R43”, “R55” and “R28”, respectively; and
 - (b) by the substitution in subregulation (3) for the expressions “R30” and “R40” of the expressions “R43” and “R55”, respectively.
3. The amendment of regulation 11 by the substitution for the expressions “R270”, “R35” and “R1,25” of the expressions “R330”, “R50” and “R1,75”, respectively.
4. The amendment of regulation 11B by the substitution for the expression “R10” of the expression “R17,50”.
