Volkoringbrood	28,5c".

BREAD PRICES.—AMENDMENT

In terms of section 79 (b) of the Marketing Act, 1968 (Act 59 of 1968), I, Jacob Johannes Greyling Wentzel, Minister of Agriculture, hereby make known that I have, under section 37 of the Winter Cereal Scheme, published by Proclamation R. 162 of 1974, as amended, read with section 60 (2A) of the said Act, further amended the prohibition published by Government Notice R. 704 of 26 April 1974, as amended, as set out in the Schedule hereto.

SCHEDULE

1. The Annexure to Government Notice R. 704 of 26 April 1974, as amended, is hereby further amended as follows:

(a) Clause 2 (1) is hereby amended—

(i) by the substitution for the table in paragraph (a) of the following table:

"Class of bread	Per 900 g
White bread	38c
Brown bread	25c
Whole-wheat bread	25c";

(ii) by the substitution for the table in paragraph (b) of the following table:

"Class of bread	Per 900 g
White bread	40c
Brown bread	27c
Whole-wheat bread	27c".

(b) Clause 3 (1) is hereby amended by the substitution for the table in paragraph (a) of the following table:

"Class of bread	Per 900 g
White bread	41,5c
Brown bread	28,5c
Whole-wheat bread	28,5c".

2. This notice shall come into operation on 1 September 1982.
