BREAD PRICES.—WALVIS BAY—AMENDMENT

In terms of section 79 (b) of the Marketing Act, 1968 (Act 59 of 1968), I, Jacob Johannes Greyling Wentzel, Minister of Agriculture, hereby make known that I have, under section 37 of the Winter Cereal Scheme, published by Proclamation R. 162 of 1974, as amended, read with section 60 (2A) of the said Act, further amended the prohibition published by Government Notice R. 2335 of 30 October 1981, as set out in the Schedule hereto.

SCHEDULE

1. The Annexure to Government Notice R. 2335 of 30 October 1981, is hereby amended as follows:

(a) Clause 4 is hereby amended—

(i) by the substitution for the table in paragraph (a) of the following table:

"Class of bread	Per 900 g
White bread	42,25
Brown bread	31,25
Whole-wheat bread	31,25"

(ii) by the substitution for the table in paragraph (b) of the following table:

"Class of bread	Per 900 g
White bread	44
Brown bread	33
Whole-wheat bread	33"

(b) Clause 5 (1) is hereby amended by the substitution for the table of the following table:

"Class of bread	Per 900 g
White bread	45,5
Brown bread	34,5
Whole-wheat bread	34,5"
