1. In this Schedule the expression "the Regulations" means the Regulations Regarding the Investigation of Aircraft Accidents, 1973, promulgated under Government Notice R. 120 of 26 January 1973, and amended by Government Notice R. 1003 of 16 May 1980.

(a) a person is fatally or seriously injured as a result of—

(i) being in the aircraft;

(ii) direct contact with any part of the aircraft, including parts which have become detached from the aircraft; or

(iii) direct exposure to jet blast;

except when the injuries are from natural causes, self-inflicted or inflicted by other persons, or when the injuries are to stowaways hiding outside the areas normally available to passengers and crew; or

(b) the aircraft sustains damage or structural failure which—

(i) adversely affects the structural strength, performance or flight characteristics of the aircraft; and

(ii) would normally require major repair or replacement of the affected component;

except for engine failure or damage when the damage is limited to the engine, its cowlings or accessories, or for damage limited to propellers, wing tips, antennae, tyres, brakes, fairings, small dents or puncture holes in the aircraft skin; or

(c) the aircraft is still missing after an official search has been terminated; or

(d) the aircraft is in a place where it is completely inaccessible";

(b) the insertion of the following definition after the definition of "flight":

"'incident' means an occurrence, other than an accident, associated with the operation of an aircraft, which affects or could affect the safety of operation";

(c) the substitution in the definition of "Investigator-in-Charge" in the English text of the term "CCA" for the term "DCA";

(d) the insertion of the following definition after the definition of "Investigator-in-Charge":

"'major repair' means a repair which, if improperly done, might appreciably affect mass, balance, structural strength, performance, power plant operation, flight characteristics or other qualities affecting airworthiness"; and

(e) the deletion of the definition of "substantial damage".

3. Regulation 7 of the Regulations is hereby amended by—

(a) the insertion of the words "or incident" after the word "accident" wherever it occurs in this regulation;

(b) the substitution in subregulations (1) (a) and (2) (b) respectively of the words "Commissioner for Civil Aviation" for the words "Secretary for Transport (DCA)"; and

(c) the substitution in the English text of subregulation (5) of the term "CCA" for the term "DCA".

REGULATIONS RELATING TO THE PLACE WHERE AND THE MANNER IN WHICH PUBLICATIONS REFERRED TO IN SECTION 56 (4) OF THE INTERNAL SECURITY ACT, 1982, SHALL BE KEPT, THE CONTROL TO BE EXERCISED OVER SUCH PUBLICATIONS AND THE SUPERVISION OVER THE USE THEREOF

The Minister of Law and Order has, in terms of section 56 (5) of the Internal Security Act, 1982 (Act 74 of 1982), made the regulations set out in the Schedule.

SCHEDULE

1. In these regulations, unless the context otherwise indicates, "the Act" means the Internal Security Act, 1982 (Act 74 of 1982), and a word or expression to which a meaning has been assigned in the Act shall bear that meaning and—

(i) "library" means a library as referred to in section 56 (4) of the Act; and

(ii) "publications" means publications as referred to in section 56 (4) of the Act.

2. The publications shall at all times when not being used for purposes of bona fide study or research in the library be locked in a separate book-case or room in the library, which is suitable for the safe custody of the publications and to which only the head of the library or a senior library official authorised by him in writing has access.

3. The head of the library or another senior library official designated by him in writing shall enter the publications kept in the library in a separate catalogue indicating—

(a) the title of each publication;

(b) the name of the person in respect of whom every such publication contains or consists of any speech, utterance, writing or statement or any extract from or reproduction of any speech, utterance, writing or statement, to which the provisions of section 56 (1) (p) of the Act are applicable; and

(c) the number of copies of every such publication kept in the library.

4. Publications shall be used in the library only, and shall be used under the supervision of the head of the library or another senior library official designated by him in writing.

5. The head of the library or another senior library official designated by him in writing shall keep a register in which the following particulars regarding the use of each publication shall be entered:

(a) The date of use;

(b) the title of the publication;

(c) die naam, adres en identiteitsnommer van die persoon wat die betrokke publikasie gebruik het, asook die doel waarvoor en die hoedanigheid waarin hy die publikasie gebruik het; en

(d) die naam van die persoon onder wie se toesig die publikasie gebruik is.

6. Die hoof van die biblioteek of 'n ander senior biblioteekbeampte skriftelik deur hom aangewys, moet die publikasies met tussenpose van nie langer nie as ses maande nagaan en op die katalogus of in 'n afsonderlike register sertifiseer dat die publikasies nagegaan is en dat dit met die katalogus ooreenstem. Die hoof van die biblioteek of bedoelde ander biblioteekbeampte moet enige tekorte of verliese onverwyld by die naaste polisiestasie aanmeld en ook skriftelike kennis daarvan aan die Direkteur van Veiligheidswetgewing gee.

7. Die hoof van die biblioteek of die ander biblioteekbeampte in regulasie 5 of 6 bedoel, moet die register in regulasie 5 bedoel en die katalogus of ander register in regulasie 6 bedoel te alle tye in die biblioteek hou en op aanvraag deur 'n lid van die Suid-Afrikaanse Polisie aan sodanige lid ter insae voorlê. Sodanige lid moet ook op sy versoek toegang tot die publikasies verleen word om dit met die katalogus te kontroleer.

(c) the name, address and identity number of the person who used the publication as well as the purpose for, and capacity in which, he used the publication; and

(d) the name of the person under whose supervision the publication was used.

6. The head of the library or another senior library official designated by him in writing shall inspect the publications at intervals not exceeding six months and certify in the catalogue or a separate register that the publications have been inspected and that the publications correspond to the catalogue. The head of the library or such other library official shall report any shortage or loss immediately to the nearest police station and notify the Director of Security Legislation in writing thereof.

7. The head of the library or the other library official referred to in regulation 5 or 6 shall at all times keep the register referred to in regulation 5 and the catalogue or other register referred to in regulation 6 in the library and at the request of a member of the South African Police make them available for inspection by such member. Any such member shall also at his request be granted access to the publications to verify them against the catalogue.
