TARIFFS.—KIMBERLEY NATIONAL FRESH PRODUCE MARKET

It is hereby made known that the Minister of Agriculture has, under the powers vested in him by section 19 of the Commission for Fresh Produce Markets Act, 1970 (Act 82 of 1970), made the requirements set out in the Schedule hereto.

SCHEDULE

1. In this notice, unless inconsistent with the context, any word or expression to which a meaning has been assigned in the Commission for Fresh Produce Markets Act, 1970 (Act 82 of 1970), shall have a corresponding meaning and—

“week”, in relation to the storage of fresh produce or other articles in cold-storage rooms and the ripening of fresh produce in ripening rooms, means any continuous period of seven days commencing on and including the day on which such fresh produce is placed in a cold-storage or ripening room.

2. The following tariffs shall be payable to the City Council of Kimberley as owner of the Kimberley National Fresh Produce Market situate at Cecil Susman and Church Roads, within the municipal area of Kimberley, in respect of the use of, or the performance of services at the said market.

Item 1.—Tariffs for the storage of fresh produce or other articles:

(a) Storage of fresh produce or other articles (excluding bananas) in cold-storage rooms and the ripening of fresh produce in ripening rooms per week or part of a week as indicated hereunder: Provided that the tariff shall not be less than R1,50 per consignment per week or part of a week:

(i) Packed into containers (other than bags or pockets), the size of which shall be calculated per cubic centimetre and such calculation shall be based on the outer dimensions of the container:

(aa) 4c per container not exceeding 15 000 cm³;

(bb) 5c per container exceeding 15 000 cm³ but not exceeding 20 000 cm³;

(cc) 6c per container exceeding 20 000 cm³ but not exceeding 40 000 cm³;

(dd) 8c per container exceeding 40 000 cm³ but not exceeding 60 000 cm³;

(ee) 10c per container exceeding 60 000 cm³ but not exceeding 80 000 cm³;

(ff) 20c per container exceeding 80 000 cm³ but not exceeding 100 000 cm³;

(gg) 50c per container exceeding 100 000 cm³ but not exceeding 500 000 cm³;

(hh) R1,50 per container exceeding 500 000 cm³.

(ii) Packed into bags or pockets or similar containers:

(aa) 3c per bag or pocket with a net mass not exceeding 6 kg;

(bb) 6c per bag or pocket with a net mass exceeding 6 kg, but not exceeding 11 kg;

(cc) 8c per bag or pocket with a net mass exceeding 11 kg but not exceeding 16 kg;

(dd) 10c per bag or pocket with a net mass exceeding 16 kg but not exceeding 36 kg;

(ee) 20c per bag or pocket exceeding 36 kg.

(iii) Unpacked loose fresh produce or other articles: 20c per unit.

TARIEWE.—KIMBERLEY NASIONALE VARSOPRODUKTEMARK

Hierby word bekendgemaak dat die Minister van Landbou, kragtens die bevoegdheid hom verleen by artikel 19 van die Wet op die Kommissie vir Varsproduktemarke, 1970 (Wet 82 van 1970), die voorskrifte in die Bylae hiervan uiteengesit, gemaak het.

BYLAE

1. In hierdie kennisgewing, tensy uit die samehang anders blyk, het 'n woord of uitdrukking waaraan in die Wet op die Kommissie vir Varsproduktemarke, 1970 (Wet 82 van 1970), 'n betekenis geheg is, 'n ooreenstemmende betekenis en beteken—

“week”, met betrekking tot die koelopbergung van varsprodukte of ander artikels in koelkamers en die rypmaak van varsprodukte in rypmaakkamers, enige aaneenlopende tydperk van sewe dae wat 'n aanvang neem op en met inbegrip van die dag waarop sodanige varsprodukte in 'n koel- of rypmaakkamer geplaas word.

2. Die volgende tariewe is betaalbaar aan die Stadsraad van Kimberley as eienaar van die Kimberley Nasionale Varsproduktemark geleë aan Cecil Susman- en Churchweg, binne die munisipale gebied van Kimberley, ten opsigte van die gebruik van, of verrigting van dienste by genoemde mark.

Item 1.—Tariewe vir die opbergung van varsprodukte of ander artikels:

(a) Opbergung van varsprodukte of ander artikels (uiteenanderd piesangs) in koelkamers en die rypmaak van varsprodukte in rypmaakkamers per week of gedeelte van 'n week soos hieronder aangedui: Met dien verstande dat die tarief nie minder as R1,50 per besending per week of gedeelte van 'n week sal wees nie:

(i) Verpak in houers (behalwe sakke of sakkies) waarvan die groote per kubieke sentimeter bereken sal word, welke berekening op die buitemate van die houers gebaseer sal word:

(aa) 4c per houer van nie meer as 15 000 cm³ nie;

(bb) 5c per houer van nie meer as 15 000 cm³ maar nie meer as 20 000 cm³ nie;

(cc) 6c per houer van meer as 20 000 cm³ maar nie meer as 40 000 cm³ nie;

(dd) 8c per houer van meer as 40 000 cm³ maar nie meer as 60 000 cm³ nie;

(ee) 10c per houer van meer as 60 000 cm³ maar nie meer as 80 000 cm³ nie;

(ff) 20c per houer van meer as 80 000 cm³ maar nie meer as 100 000 cm³ nie;

(gg) 50c per houer van meer as 100 000 cm³ maar nie meer as 500 000 cm³ nie;

(hh) R1,50 per houer van meer as 500 000 cm³.

(ii) Verpak in sakke of sakkies of soortgelyke houers:

(aa) 3c per sak of sakkie met 'n netto massa van nie meer as 6 kg nie;

(bb) 6c per sak of sakkie met 'n netto massa van meer as 6 kg, maar nie meer as 11 kg nie;

(cc) 8c per sak of sakkie met 'n netto massa van meer as 11 kg, maar nie meer as 16 kg nie;

(dd) 10c per sak of sakkie met 'n netto massa van meer as 16 kg maar nie meer as 36 kg nie;

(ee) 20c per sak of sakkie van meer as 36 kg.

(iii) Onverpakte los varsprodukte of ander artikels: 20c per eenheid.

(b) If fresh produce or other articles (excluding bananas) are to be placed on pallets by municipal personnel for purposes of cold-storage or ripening: 1c per container, bag, pocket or unit of unpacked produce in addition to the tariffs fixed above of purposes of cold-storage or ripening.

(c) Ripening of bananas in ripening rooms per week or part of a week: 30c per 20-kg container.

Item 2.—Double the tariffs fixed in item 1 (a), (i), (ii), (iii) and (b) shall be payable in respect of cold storage or ripening of fresh produce or other articles not purchased on the market or sold through the market: Provided that such double tariffs shall not apply in respect of such types of produce or articles which are not normally sold on the market.

Item 3.—General tariffs.

Supplying out-of-hand sales docket books, per book: 50 per cent of the total printing cost thereof as charged by the printer of such docket books.

Miscellaneous provisions

This notice shall come into operation on 1 November 1982 and repeals Government Notice R. 96 of 16 January 1981 and Government Notice R. 97 of 16 January 1981 with effect from 1 November 1982.

CUSTOMS AND EXCISE ACT, 1964

DETERMINATIONS OF TARIFF CLASSIFICATION AND FURNISHING THEREOF ON BILLS OF ENTRY (LIST TAR/67)

1. The following determinations (Part A)/amendments to determinations (Part B) are published in terms of section 47 (9) of the Customs and Excise Act, 1964 (Act 91 of 1964).

2. In terms of section 39 (1) (c) of the aforementioned Act, importers are required to furnish the determination number on bills of entry at the time of entry of such goods.

D. ODENDAL, Commissioner for Customs and Excise.

Notes:

1. The description of the goods is given for determination purposes only and should not be construed as correct, complete or binding for any other purpose.

2. Goods which are packed for or put up for retail sale are in all instances classified under the appropriate tariff sub-heading where such provision exists.

3. Tariff subheadings which depend upon the mass, dimensions, form, value, packing, etc., of goods are not necessarily indicated.

4. In order to avoid possible confusion trade names and in certain instances trade descriptions have not been translated.

5. Separate serial numbers have been allocated to determinations under each tariff heading.

1. Regulation 30 of Chapter V is hereby amended—

MUNICIPALITY OF PIETERMARITZBURG.—THIRD SMOKE CONTROL ZONE ORDER

The Municipality of Pietermaritzburg hereby, under and by virtue of the powers vested in it by section 20 of the Atmospheric Pollution Prevention Act, 1965, makes the following Order:

1. The area defined in the Schedule hereto is hereby declared to be a Smoke Control Zone.

2. In this Smoke Control Zone no owner or occupier of any premises referred to in clause 3 shall cause or permit the emanation or emission from such premises of smoke of such a density or content as will obscure light to an extent greater than 20 per cent.

3. This Order shall apply to—

(a) all premises or buildings in use zones classified as special residential, restricted general residential, general residential, general business and special business zones and zones for special, undetermined, agricultural, institutional, educational and municipal purposes: Provided that, where industrial buildings are situated in these use zones, any person may apply in writing to the City Council of Pietermaritzburg for exemption from the provisions of this Order, and that, if the Council is satisfied that there are adequate reasons for such exemption, it may by notice in writing to the applicant grant such exemption upon such conditions as the Council may deem fit;

(b) dwelling-houses, residential buildings, shops, business premises, warehouses, social halls, places of amusement, places of public worship, places of instruction, parking garages, public garages, institutions, sports grounds and special buildings in use zones classified as special industrial zones.

4. The City Council of Pietermaritzburg may from time to time exempt from the provisions of clause 2 hereof any make, type, class or model of household fuel burning appliance designed to burn any solid or liquid fuel, on condition that—

(a) such appliance is installed, maintained and operated in accordance with the manufacturer's instructions supplied with the appliance;

(b) such appliance is operated so as to minimise the emission of smoke; and

(c) the exemption may be withdrawn at any time at the sole discretion of the City Council of Pietermaritzburg.

5. This Order shall come into effect on 13 June 1983.

6. This Order shall be called the Third Smoke Control Zone Order.

The area bounded in the north-west by Church Street, in the north-east by Boshoff Street, in the south-east by Prince Alfred Street (the boundary including a straight line joining the two portions of Prince Alfred Street), and in the south-west by a straight line joining the south-western corner of Lot ABCD of Gaol and the north-western corner of Lot ABCDEFGH of Training College.

During the next year of employment	58,83

Thereafter he shall be paid the prescribed wage for the operation on which he is employed: Provided that nothing in this clause shall operate to prevent a shorter period than two years being permitted: Provided further that where it is not possible to obtain prior approval of the Council or the Executive Committee, an employee in respect of whom an application has been made for permission to work as an unqualified male adult in terms of this subclause, shall be paid at not less than the rates laid down by the District Committee from the date he commences on such operation.

If the Council or the Executive Committee specifies a higher rate than the rate laid down by the District Committee, such higher rate shall apply from the date of the Council's or the Executive Committee's decision.

In the event of the Council or the Executive Committee refusing the application, arrear wages may be assessed only for the period in excess of six weeks from the date of commencement of the operation.

(2) A licence to employ an unqualified male adult employee in terms of subclause (1) shall be issued in respect of every application approved by the Council or the Executive Committee, and a copy shall be furnished to the employee.

(3) *Ratio of employees.*—(a) The number of unqualified male adults employed in terms of subclause (1) in an establishment shall not at any time exceed one such employee to each 20 or part of 20 other employees (excluding learners) receiving more than R52,70 per week on operations referred to in clause 1 (B), (D), (E) and (F) of Annexure A to this Part.

(b) Employers shall not be taken into account in computing the ratio.”.

SIEKEFONDSREGULASIES

WYSIGINGSLYS

(Van krag van 1 Julie 1981)

Dit het die Staatspresident behaag om kragtens artikel 32 van die Wet op Spoorweg- en Hawediens, 1960 (Wet 22 van 1960), goedkeuring daaraan te verleen dat die

South African Transport Services, published in Government Notice R. 635 of 8 September 1961, as amended, being further amended as follows:

REGULATION 20

Substitute the following for this regulation:

COMPULSORY MEMBERSHIP

(20) (1) Except as otherwise provided for in these regulations, membership shall be compulsory and operate from the date of employment and, in the case of employees who were employed in a casual capacity prior to 1 July 1981, from the date of registration.

EMPLOYEE EMPLOYED IN A CASUAL CAPACITY FOR INTERMITTENT PERIODS

(2) An employee employed in a casual capacity for intermittent periods shall not be eligible for membership.

PERSON DEBARRED FROM MEMBERSHIP

(3) A person who is debarred from membership in terms of any regulation or instruction issued by the General Manager shall not be admitted to membership.

TRANSFER OF AN EMPLOYEE FROM A GOVERNMENT DEPARTMENT, PROVINCIAL ADMINISTRATION OR THE SOUTH AFRICAN IRON AND STEEL INDUSTRIAL CORPORATION, LIMITED, TO RAILWAY EMPLOYMENT

(4) An employee transferred from a Government Department or Provincial Administration or who was transferred from the South African Iron and Steel Industrial Corporation, Limited, without a break in service, on 1 July 1977 in consequence of the purchase of the Sishen-Saldanha Bay Project in terms of the Railway and Harbour Purchase Act, 1977 (Act 47 of 1977), shall be admitted to membership under the provisions of this regulation.

WHEN MEMBERSHIP IS NOT COMPULSORY

(5) Membership is not compulsory for—

(a) a married female employee provided acceptable evidence is furnished that her husband is a member of a registered medical scheme and that she is entitled to the benefits of such a scheme; and

(b) an employee employed in a casual capacity who is a member of another registered medical scheme.

REGULATION 24

Delete paragraph (g) and change paragraph (h) to (g).

REGULATION 45

Substitute the following for paragraph (1):

(1) Subject to the provisions of regulations 60 and 61, a member and his wife and children who are normally resident with him may, subject to the provisions of regulation 45A, be granted benefits prescribed in this regulation.

(4) 'n Werknemer wat van 'n staatsdepartement of 'n provinsiale administrasie oorgeplaas word of van die Suid-Afrikaanse Yster- en Staal- Industriële Korporasie, Beperk, sonder diensonderbreking op 1 Julie 1977 oorgeplaas is ten gevolge van die aankoop van die Sishen-Saldanhabaaiprojek kragtens die Spoorweg- en Haweaankoopwet, 1977 (Wet 47 van 1977), word ingevolge die bepalings van hierdie regulasie as lid toegelaat.

WANNEER LIDMAATSKAP NIE VERPLIGTEND IS NIE

(5) Lidmaatskap is nie verpligtend nie vir—

(a) 'n getroude werkneemster, mits aanvaarbare bewys gelewer word dat haar eggenoot lid van 'n geregistreerde mediese skema is en dat sy op die voordele van sodanige skema geregurgig is; en

(b) 'n werkneemster wat in 'n los hoedanigheid werksaam is en wat lid is van 'n ander geregistreerde mediese skema.

Skrap paragraaf (g) en verander paragraaf (h) na (g).

REGULASIE 45

Vervang paragraaf (1) deur die volgende:

(1) Onderworpe aan die bepalings van regulasies 60 en 61 kan die voordele wat in hierdie regulasie voorgeskryf word, onderworpe aan die bepalings van regulasie 45A, toegestaan word aan 'n lid en sy eggenote en kinders wat gevoonlik by hom woon.
