**ALGEMENE STRANDREGULASIES.—PROVINSIE
NATAL**

Ek, Benjamin Hugh Wilkens, Adjunk-minister van Ontwikkeling en van Grondsake, handelende namens en in opdrag van die Minister van Gemeenskapsontwikkeling, verklaar hierby ingevolge artikel 10 (3) (b) van die Strandwet, 1935 (Wet 21 van 1935), dat die regulasies wat kragtens artikel 10 (1) van gemelde Wet gepubliseer is in *Buitengewone Staatskoerant* 169 van 2 Februarie 1962 (*Regulasiekoerant* 62), soos gewysig by Korreksiekennisgewing R. 261 van 23 Februarie 1962 gepubliseer in *Buitengewone Staatskoerant* van dieselfde datum en uitgevaardig by Goewermenskennisgewing R. 424 van 16 Maart 1962, van toepassing is op daardie gedeelte Staatsgrond (algemeen bekend as admiraleitsreservé), geleë tussen die hoogwatermerk van die Indiese Oseaan en die oostelike grense van Onderverdeling KZ van Reservaat 14 (7638) en die resterende gedeelte van Reservaat 14 (7638), beide geleë in die distrik Um bombo, provinsie Natal.

**GENERAL SEA-SHORE REGULATIONS.—PROVINCE
OF NATAL**

I, Benjamin Hugh Wilkens, Deputy Minister of Development and of Land Affairs, acting on behalf and by direction of the Minister of Community Development, do hereby in terms of section 10 (3) (b) of the Sea-shore Act, 1935 (Act 21 of 1935), declare that the regulations published in terms of section 10 (1) of the said Act in *Gazette Extraordinary* 169 of 2 February 1962 (*Regulation Gazette* 62), as amended by Correction Notice R. 261 of 23 February 1962, published in the *Gazette Extraordinary* of the same date and promulgated by Government Notice R. 424 of 16 March 1962, are applicable to that portion of State-owned land (generally known as admiralty reserve), situate between the high-water mark of the Indian Ocean and the eastern boundaries of Subdivision KZ of Reserve 14 (7638) and the remaining extent of Reserve 14 (7638), both situate in the district of Um bombo, Province of Natal.
