(d) undertake any community speech or hearing work unless under the direction, where possible, regard being had to geographical proximity, of a speech therapist or speech therapist and audiologist or audiologist or, where this is not possible, in consultation with a speech therapist or speech therapist and audiologist or audiologist.

1. In these regulations 'the Act' shall mean the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), and any expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates—

"professional board" shall mean the Professional Board for Medical Science established under Government Notice R. 1736 of 9 August 1985;

"member" shall mean a member of the Professional Board for Medical Science; and

"section" shall mean a section of the Act.

**CONSTITUTION OF THE PROFESSIONAL BOARD**

2. The professional board shall consist of 13 members and shall comprise—

(1) two persons designated in terms of section 15 (6) (a) and (c);

(2) ten persons that are registered medical scientists, elected by the persons whose names appear on the register of medical scientists kept under section 32, in such a manner that the persons registered in each of the categories elect one person that is registered in that particular category to be a member; and

(3) one person that is a registered medical physicist, elected to be a member by the persons whose names appear on the register of medical physicists kept under section 32.

3. Subject to regulation 4, the period of service of members of the professional board shall be five years, reckoned from the date of election referred to in regulations 2 (2) and 2 (3); Provided that such members shall be eligible for re-election or redesignation, as the case may be.

4. (1) A member shall vacate office—

(a) if he becomes insolvent or assigns his estate for the benefit of or compounds with his creditors; or

(b) if he is absent from more than two consecutive ordinary meetings of the professional board without the professional board's leave; or

(c) if he has been disqualified under the Act from practising his profession; or

(d) if, as an elected member, he notifies the professional board, in writing, of his resignation; or

(e) if, as a designated member, he ceases to be eligible for designation or gives notice, in writing, to the council of his desire to resign from office and his resignation is accepted.

(2) Every such vacancy and every vacancy caused by the death of a member shall be filled by designation or election according as the member vacating office was designated or elected, and every member so designated or elected shall hold office only for the unexpired portion of that period for which the member vacating such office was designated or elected.

**POWERS OF THE PROFESSIONAL BOARD**

5. The professional board may—

(1) make representations to or through the council for the making, amendment or withdrawal of any regulation or rule that applies to the professional board or to medical science or to medical physics;

(2) submit representations through the council to the Minister in regard to the definition of the scope of the profession of medical scientist or medical physicist should the council recommend to the Minister, in terms

#### FUNCTIONS AND DUTIES OF THE PROFESSIONAL BOARD

6. It shall be the duty of the professional board to—

(1) promote high standards of professional education and professional conduct among medical scientists and medical physicists;

(2) report to the council on any matter affecting medical scientists or medical physicists referred to it by the council;

(3) advise the council on the removal under the provisions of section 19 or section 32 (2) of the name of any person from the registers of medical scientists or medical physicists kept under section 32; and

(4) make recommendations to the council in regard to the recognition of institutions for the prescribed practical training of medical scientists or medical physicists and in regard to the recognition of qualifications of medical scientists or medical physicists whose names are placed on the register in terms of section 32.

#### THE SOUTH AFRICAN MEDICAL AND DENTAL COUNCIL

#### REGULATIONS RELATING TO THE QUALIFICATIONS ENTITLING MEDICAL PRACTITIONERS AND DENTISTS TO REGULATION

In terms of sections 24 and 25 of the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), the Minister of Health and Welfare has, on the recommendation of the South African Medical and Dental Council, made the regulations set out in the Schedule hereto in substitution for the regulations published under Government Notice R. 2273 of 3 December 1976, as amended.

#### DEFINITION

In this Schedule "the Act" means the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), and any expression to which a meaning has been assigned in the Act shall bear such meaning and, unless the context otherwise indicates—

(1) "Annexure" means an annexure to these regulations; and

(2) "Council" means the South African Medical and Dental Council.

#### SCHEDULE

1. (1) Any of the qualifications mentioned in Annexures A and B entitles the holder thereof to registration as a medical practitioner, if he has, before or in connection with or after the obtaining of the said qualification, complied with the conditions and requirements prescribed in subregulations (2) to (5).

(2) No persons shall be registered as a medical practitioner unless the qualification held singly or conjointly with any other qualification by him shows that he has passed qualifying examinations in the clinical disciplines.

(3) A qualification shall be recognised for registration only if the course of study in professional subjects covered a period of at least five academic years of which the last three

#### WOORDOMSKRYWING

(1) "Aanhangsel" 'n aanhangsel van hierdie regulasies; en

#### BYLAE

1. (b) the requirement pertaining to the last three years of professional study shall not apply to a qualification recognised by the council on 1 January 1950.

(4) A qualification obtained subsequent to 1 November 1948 will be recognised for registration purposes if the holder thereof furnishes proof to the satisfaction of the council that he has, before or in connection with or after the obtaining of the said qualification, undergone training as an intern or training of a like nature for a total period of at least 12 months.

(5) The holder of a qualification mentioned in Annexure B must pass an examination set by the council on one of the official languages and the ethical/legal requirements of practice in the Republic of South Africa.

2. (1) Any of the qualifications mentioned in Annexures C and D entitles the holder thereof to registration as a dentist, provided that he has, before or in connection with or after the obtaining of the relevant qualification, complied with the conditions and requirements prescribed in subregulations (2) to (4).

(2) No person shall be registered as a dentist unless the qualification held singly or conjointly with any other qualification by him shows that he has passed qualifying examinations in the clinical disciplines.

(3) A qualification shall be recognised for registration only if the course of study in professional subjects covered a period of at least four academic years of which the last two years of professional study for admission to the examination for such qualification were taken at a university or medical school in the country or state in which the qualification was granted: Provided that this paragraph shall not apply to a qualification held by a person who, at the commencement of his professional studies for the relevant qualification, was a South African citizen.

(4) The holder of a qualification mentioned in Annexure D must pass an examination set by the council on one of the official languages and the ethical/legal requirements of practice in the Republic of South Africa.

3. The regulations published under Government Notice R. 2273 of 3 December 1976, as amended by Government Notices R. 1827 of 16 September 1977, R. 1033 of 26 May 1978, R. 1866 of 15 September 1978 and R. 460 of 9 March 1979, are hereby repealed.

**No. R. 1769****9 August 1985****FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972 (Act 54 of 1972)****REGULATIONS.—SOFT DRINKS**

The Minister of Health and Welfare has, in terms of section 15 (1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act 54 of 1972), made the regulations appearing in the Schedule hereto, which shall become effective from the date of publication hereof, save regulation 4 (1), which shall become effective two months after such date of publication.

**SCHEDULE**

1. In these regulations "the Act" shall mean the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act 54 of 1972), and any expression to which a meaning has been assigned in the Act shall bear such meaning, and, unless inconsistent with the context—

"additive" shall mean a substance which is specially prepared for use in foodstuffs and intentionally added to soft drinks for one or more of the following purposes:

- (a) To retain the nutritional properties;
- (b) to enhance the keeping quality or stability;

**No. R. 1769****9 Augustus 1985****WET OP VOEDINGSMIDDELS, SKOONHEIDSMIDDELS EN ONTSMETTINGSMIDDELS, 1972 (WET 54 VAN 1972)****REGULASIES.—KOELDRANKE**

Die Minister van Gesondheid en Welsyn het kragtens artikel 15 (1) van die Wet op Voedingsmiddels, Skoonheidsmiddels en Ontsmettingsmiddels, 1972 (Wet 54 van 1972), die regulasies wat in die Bylae hiervan verskyn, uitgevaardig, wat met ingang van die datum van afkondiging hiervan in werking tree, uitgesonderd regulasie 4 (1), wat twee maande na die datum van afkondiging in werking tree.

**BYLAE**

1. In hierdie regulasies beteken "die Wet" die Wet op Voedingsmiddels, Skoonheidsmiddels en Ontsmettingsmiddels, 1972 (Wet 54 van 1972), en het 'n uitdrukking waaraan daar in die Wet 'n betekenis geheg is, dieselfde betekenis, en, tensy uit die samehang anders blyk, beteken—

"additief" 'n stof wat spesiaal berei is vir gebruik in voedingsmiddels en opsetlik by koeldranken gevoeg word vir een of meer van die volgende doeleindes:

- (a) Om die voedingseienskappe te behou;
- (b) om die houvermoë of stabiliteit te verhoog;

(c) to make the soft drink more attractive to the consumer;

(d) to act as an adjuvant in the manufacture, packaging, treatment or transport;

(e) to provide essential constituents for dietetic soft drinks;

and which complies with any such standard of purity or quality as may be prescribed in respect of the substance concerned;

"soft drink" shall mean any powder or liquid intended for sale as a drink for human consumption, either without or after preparation or dilution, and shall include—

(a) any fruit or vegetable drink;

(b) soda water, Indian or quinine tonic water, natural spring water and any sweetened artificially carbonated water, whether flavoured or unflavoured;

(c) ginger beer and any herbal or botanical beverage; but shall not include—

(i) water (except as aforesaid);

(ii) fruit juice, sweetened or unsweetened, controlled under the Marketing Act, 1968 (Act 59 of 1968), whether sweetened or unsweetened, and whether concentrated or frozen or not;

(iii) milk or any preparation of milk;

(iv) tea, coffee, cocoa or chocolate, or any preparation thereof;

(v) any egg product;

(vi) any cereal product, except—

(aa) flavoured barley water and liquid products used in the preparation of barley water; and

(bb) any liquid produced from cereal and containing alcohol, which does not fall within one of the following categories:

(aaa) drinks referred to in subparagraph (viii) hereof;

(bbb) drinks falling within the provisions of the Sorgum-Bier Act, 1962 (Act 63 of 1962);

(ccc) drinks traditionally known as maheu with a maximum total alcohol content of 1 % by volume;

(vii) meat or yeast extracts, soup or soup mixtures;

(viii) any drink falling within the provisions of the Liquor Act, 1928 (Act 30 of 1928);

(ix) any other unsweetened drink; or

(x) any drink falling within the provisions of the Wine, Other Fermented Beverages and Spirits Act, 1957 (Act 25 of 1957); and

"sweetened" shall mean containing any added permitted sweetener, and "unsweetened" shall mean containing no added permitted sweetener.

2. No soft drink shall contain any foreign substance: Provided that the additives named in column I of the following table may, unless prohibited or further limited by any other law, be present in a soft drink or, in the case of a soft drink which is to be diluted with water, in such soft drink when diluted in accordance with the instructions on the label, in a proportion not exceeding that indicated in the corresponding line of column II:

(b) sodawater, Indiese of kinientonikumwater, natuurlike fonteinwater en enige versoete kunsmatig gekarbonneerde water, hetsy gegeur of ongegeur;

(c) gemmerbier en enige kruie- of botaniiese drank; maar nie—

(i) water (behalwe soos voormeld);

(ii) vrugtesap, versoet of onversoet, hetsy gekonsentreer of bevrore of nie, wat ingevolge die Bemaringswet, 1968 (Wet 59 van 1968), beheer word;

(iii) melk of enige melkpreparaat;

(iv) tee, koffie, kakao of sjokolade, of enige preparaat daarvan;

(v) enige eierproduk;

(vi) enige graanproduk uitgesonderd—

(aa) gegeurde gortwater en vloeibare produkte wat by die bereiding van gortwater gebruik word; en

Box 23080, Port Elizabeth, 6009, or such other place as the Management Committee may determine, together with a statement in such form as the Management Committee may from time to time determine: Provided that, in the case of employees who are members of the Fund by virtue of the provisions of subclause (6) (l) (i) or subclause (12) (a), the weekly deductions shall be subject to such maximum amount as the Management Committee may determine from time to time.

(ii) Should any amount due in terms of this clause not be received by the Council by the 15th day of the month following the month in respect of which it is payable, the employer shall pay interest on such amount or on such lesser amount as remains unpaid, calculated at a rate of interest of 2 per cent per month or part thereof from such 15th day until the day upon which payment is actually received by the Council: Provided that the Council shall be entitled in its absolute discretion to waive the payment of such interest or part thereof.

(2) Ondanks subklosule (1), is hierdie Ooreenkoms egter van toepassing slegs op dié werkneemers vir wie lone in enige ooreenkoms van die Raad voorgeskryf word.

**2. KLOUSULE 4.—VOORSORGFONDS**

(ii) Indien die Raad 'n bedrag wat ingevolge hierdie klosule betaalbaar is, nie ontvang teen die 15de dag van die maand wat volg op die maand ten opsigte waarvan dit betaalbaar is nie, moet die werkgewer rente op sodanige bedrag betaal of op sodanige mindere bedrag as wat nog nie betaal is nie, bereken teen 2 persent per maand of gedeelte daarvan vanaf die 15de dag tot die dag waarop die betaling werlik deur die Raad ontvang word: Met dien verstaande dat die Raad die reg het om na goedunke betaling van die rente van 'n gedeelte daarvan kwyt te skeld.

(iii) Die bedrag ooreenkomsdig subparagraaf (i) afgetrek, moet opwaarts tot die volgende sent afgerond word: Met dien verstaande dat 'n werkgewer vir die toepassing van hierdie subparagraaf 'n breuk van minder as 'n halfsent kan verontgaam.

(iv) Dit is die werkgewers se verantwoordelikheid om toe te sien dat aftrekkings gedoen word van die lone van alle werkneemers wat vir lidmaatskap van die Fonds in aanmerking kom, en die werkgewer is daarvoor verantwoordelik om aan die Fonds rekenskap te gee van sowel sy eie as die werkneemers se bydraes."

(2) Vervang klosule 4 (7) (b) (i) deur die volgende:

"(b) (i) Indien 'n lid die Nywerheid by of na bereiking van die aftree-ouderdom verlaat, of indien 'n lid verplig is om uit die diens te tree as gevolg van ongeskiktheid voordat hy die aftree-ouderdom bereik, en die Bestuurskomitee daarvan oortuig is dat die ongeskikte lid glad nie in staat is om 'n bestaan in die Nywerheid te maak nie, moet hy aan sodanige lid

retiral or at the date on which such incapacitation occurred: Provided that the Management Committee shall have the right to pay moneys due in terms of this paragraph either in a lump sum or in such instalments as it may deem fit: Provided further that the Management Committee shall not be required to consider a claim for incapacitation benefits if it is not satisfied within a period of six months of the date on which the member leaves the Industry, that such member is totally unfit to earn his living in the Industry.'.'


