COMING INTO OPERATION OF AMENDMENTS OF SCHEDULE 1 TO THE NATIONAL STATES CONSTITUTION ACT, 1971

By virtue of the powers vested in me by section 37A (2) of the National States Constitution Act, 1971 (Act 21 of 1971), I, Gerrit van Niekerk Viljoen, Minister of Co-operation, Development and Education, hereby determine that the amendment by Proclamation R. 112 of 1985, of Schedule 1 to the National States Constitution Act, 1971 (Act 21 of 1971), shall come into operation on the date of publication hereof in the area for which—

- (i) the Gazankulu Legislative Assembly was declared a self-governing territory by Proclamation R. 15 of 1973;
- (ii) the Lebowa Legislative Assembly was declared a self-governing territory by Proclamation R. 225 of 1972;
- (iii) the KwaZulu Legislative Assembly was declared a self-governing territory by Proclamation R. 11 of 1977;
- (iv) the QwaQwa Legislative Assembly was declared a self-governing territory by Proclamation R. 203 of 1974;
- (v) the KaNgwane Legislative Assembly was declared a self-governing territory by Proclamation R. 148 of 1984; and
- (vi) the KwaNdebele Legislative Assembly was declared a self-governing territory by Proclamation R. 60 of 1981.
