27 (c) van genoemde Proklamasie R. 72 van 1972,

 - (a) ek kragtens die bevoegdheid my verleen by artikel
8 (2) van genoemde Proklamasie R. 72 van 1972,
die registrasie van burgers van KwaZulu as kiesers
ten opsigte van die kiesafdelings Mpumalanga en
Emnambithi opskort met ingang van 25 Oktober
1985; en
 - (b) ek kragtens die bevoegdheid my verleen by artikel
23 (1) van genoemde Proklamasie R. 72 van 1972,

ELECTION OF MEMBERS OF THE KWAZULU LEGIS-
LATIVE ASSEMBLY.—ELECTORAL DIVISIONS OF
MPUMALANGA AND EMNAMBITHI

Under and by virtue of the powers vested in me by sec-
tion 23 (1) of Proclamation R. 72 of 1972; I hereby—

- (i) (a) fix Monday, 11 November 1985, as the day on
which nomination courts shall sit to receive nomi-
nations of candidates for election as members of
the KwaZulu Legislative Assembly in respect of
the electoral divisions of Mpumalanga and
Emnambithi; and
- (b) determine that the nomination courts shall sit be-
tween the hours of 09h00 and 12h00 in the office
of the Magistrate, Mpumalanga for the electoral
division of Mpumalanga and in the office of the
Magistrate, Ezakheni for the electoral division of
Emnambithi;
- (ii) if, in accordance with the provisions of section 27 (c)
of Proclamation R. 72 of 1972, poll is to take place—
 - (a) under and by virtue of the powers vested in me by
section 8 (2) of the said Proclamation R. 72 of
1972, I hereby suspend the registration of citizens
of KwaZulu as voters in respect of the electoral
divisions of Mpumalanga and Emnambithi with
effect from 25 October 1985; and
 - (b) under and by virtue of the powers vested in me by
section 23 (1) of the said Proclamation R. 72 of
1972, I hereby fix the following periods during
which poll shall take place for the election of a
candidate as a member of the KwaZulu Legislative
Assembly in respect of each of the electoral divi-
sions of Mpumalanga and Emnambithi and the
hours at which poll shall commence and close on
each polling day;
 - (i) within the electoral divisions of Mpumalanga
and Emnambithi on Tuesday, 14th January
1986 and Wednesday, 15th January 1986 be-
tween 07h00 and 19h00; and

(ii) buite die gebiede in (i) genoem, by die setels van kiesbeampes, op 14 Januarie 1986 gedurende die normale kantoorure nagekom by die kantore van sodanige kiesbeampes.
