REGULATIONS IN TERMS OF THE PUBLIC SAFETY
ACT, 1953

By virtue of the powers vested in me by section 3 (1) (a) of the Public Safety Act, 1953 (Act 3 of 1953), I hereby make with effect from 26 October 1985, in the magisterial districts mentioned in the Schedule, in which the existence of a state of emergency has been declared in terms of section 2 of the said Act as from 26 October 1985, the regulations published by Proclamation R. 121 of 1985, and in terms of section 3 (1) (b) of the said Act I hereby declare regulation 11 of the said regulations to apply also in all the other magisterial districts in the Republic of South Africa with effect from 26 October 1985.

Given under my Hand the Seal of the Republic of South Africa at Pretoria this Twenty-fifth day of October, One thousand Nine hundred and Eighty-five.
