BYLAE

1. Die Regulasies afgekondig by Proklamasie R. 109 van 12 Junie 1986, word hierby gewysig—

(a) deur in regulasie 1—

(i) die omskrywing van "Mag" deur die volgende omskrywing te vervang:

"'Mag' die Suid-Afrikaanse Polisie bedoel in die omskrywing van 'die Mag' in artikel 1 van die Polisiewet, 1958 (Wet 7 van 1958), en ook enige deel van genoemde Polisie waarvan die beheer, organisasie en administrasie deur die Minister aan die Regering van 'n selfregrende gebied oorgedra is; 'n polisiemag ingestel kragtens 'n wet van die wetgewende vergadering van 'n selfregrenderende gebied; die Suid-Afrikaanse Spoerwegpolisiemag ingestel kragtens artikel 43 van die Suid-Afrikaanse Vervoerdienstewet, 1981 (Wet 65 van 1981); die Suid-Afrikaanse Weermag bedoel in artikel 5 van die Verdedigingswet, 1957 (Wet 44 van 1957), of

REGULATIONS IN TERMS OF THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by section 3 (1) (a) of the Public Safety Act, 1953 (Act 3 of 1953), I hereby make the regulations contained in the Schedule.

SCHEDULE

1. The Regulations promulgated by Proclamation R. 109 of 12 June 1986, are hereby amended—

(a) in regulation 1—

(i) by the substitution for the definition of "Force" of the following definition:

"'Force' means the South African Police referred to in the definition of 'the Force' in section 1 of the Police Act, 1958 (Act 7 of 1958), and includes any part of the said Police of which the control, organisation and administration have been transferred by the Minister to the Government of a self-governing territory; a police force established under any law of the legislative assembly of a self-governing territory; the South African Railways Police Force established under section 43 of the South African Transport Services Act, 1981 (Act 65 of 1981); the South African Defence Force referred to in section 5 of the Defence Act, 1957

die Gevangenisdiens ingestel by artikel 2 (1) van die Wet op Gevangenis, 1959 (Wet 8 van 1959);”;	(Act 44 of 1957), or the Prisons Service established by section 2 (1) of the Prisons Act, 1959 (Act 8 of 1959);”;
(ii) in paragraaf (c) van die omskrywing van “ondermynende verklaring”, na die woord “Republiek” die woorde “of van 'n selfregerende gebied” in te voeg;	(ii) by the insertion after the definition of “publication” of the following definition:
(iii) na die omskrywing van “publikasie” die volgende omskrywing in te voeg:	“‘selfregerende gebied’ ‘n gebied wat kragtens artikel 26 van die Grondwet van die Nasionale State, 1971 (Wet 21 van 1971), tot ‘n selfregerende gebied binne die Republiek verklaar is;”;
(b) deur in subregulasie (10) van regulasie 3 na die woord “Staat” die woorde “of van die Regering van 'n selfregerende gebied” in te voeg;	(iii) by the insertion, in paragraph (c) of the definition of “subversive statement”, after the word “Republic” of the words “or of a self-governing territory”;
(c) deur paragraaf (a) van regulasie 8 deur die volgende paragraaf te vervang:	(b) by the insertion in subregulation (10) of regulation 3, after the word “State”, of the words “or of the Government of a self-governing territory”;
(d) deur aan die einde van regulasie 11 die volgende woorde by te voeg:	(c) by the substitution for paragraph (a) of regulation 8 of the following paragraph:
“en met enige eksemplare waarop kragtens hierdie regulasie beslag gelê is, word gehandel ooreenkomsdig opdragte wat van tyd tot tyd, in die algemeen of met verwysing na 'n bepaalde geval, deur die Minister of iemand deur hom daartoe gemagtig, uitgereik word.”;	“(a) publication of the order by notice in the <i>Government Gazette</i> or, where applicable, the <i>Official Gazette</i> of a self-governing territory;”;
(e) deur in subregulasie (1) van regulasie 16—	(d) by the addition at the end of regulation 11 of the following words:
(i) paragraaf (a) deur die volgende paragraaf te vervang:	“and any copies which have been seized under this regulation shall be dealt with in accordance with directions issued from time to time, either generally or with reference to any particular case, by the Minister or a person authorized thereto by him.”;
(ii) paragraaf (c) deur die volgende paragraaf te vervang:	(e) by the substitution in subregulation (1) of regulation 16—
(iii) paragraaf (e) deur die volgende paragraaf te vervang:	(i) for paragraph (a) of the following paragraph:
(iv) paragraaf (f) deur die volgende paragraaf te vervang:	(a) the State or the Government of a self-governing territory;”;
(v) paragraaf (g) deur die volgende paragraaf te vervang:	(ii) for paragraph (c) of the following paragraph:
(vi) paragraaf (h) deur die volgende paragraaf te vervang:	(c) any member of the Cabinet of the Republic or the Cabinet of a self-governing territory;”;
(vii) paragraaf (i) deur die volgende paragraaf te vervang:	(iii) for paragraph (e) of the following paragraph:
(viii) paragraaf (j) deur die volgende paragraaf te vervang:	(e) any person in the service of the State or of the Government of a self-governing territory; or”; and
(f) deur in subregulasie (4) van regulasie 16 na die woord “Staat” die volgende woorde in te voeg:	(f) by the insertion after the word “State” in subregulation (4) of regulation 16, of the words:
(g) deur in subregulasie (4) van regulasie 16 na die woord “Regering van 'n selfregerende gebied” die volgende woorde in te voeg:	(or the Government of a self-governing territory).
2. Regulasie 1 word geag op 12 Junie 1986 in werking te getree het.	2. Regulation 1 shall be deemed to have come into operation on 12 June 1986.
