## BYLAE

1. Regulasie 3 van die Regulasies aangekondig by Proklamasie R. 109 van 12 Junie 1986, soos gewysig deur Proklamasies R. 110 van 17 Junie 1986 en R. 121 van 27 Junie 1986, word hierby gewysig deur na subregulasie (3) die volgende subregulasie in te voeg:

"(3A) 'n Telegrafiese of dergelike geskrewe of gedrukte mededeling wat van die Minister of 'n beampte wat op sy gesag handel, afkomstig heet te wees en waarin gemeld word dat 'n kennisgewing ten opsigte van 'n bepaalde persoon kragtens subregulasie (3) uitgevaardig is, het die uitwerking van bedoelde kennisgewing: Met dien verstande dat indien so 'n telegrafiese of dergelike geskrewe of gedrukte mededeling in plaas van die betrokke kennisgewing gebruik word, die Minister of bedoelde beampte die kennisgewing so spoedig doenlik moet stuur aan die in subregulasie (3) bedoelde hoof van die gevangenis waar die persoon op wie die kennisgewing van toepassing is, kragtens die kennisgewing aangehou moet word."

### AMENDMENT OF REGULATIONS UNDER THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by section 3 (1) (a) of the Public Safety Act, 1953 (Act 3 of 1953), I hereby make the regulation contained in the Schedule.

## SCHEDULE

1. Regulation 3 of the Regulations promulgated by Proclamation R. 109 of 12 June 1986, as amended by Proclamations R. 110 of 17 June 1986 and R. 121 of 27 June 1986, is hereby amended by the insertion, after subregulation (3), of the following subregulation:

"(3A) A telegraphic or similar written or printed communication purporting to be from the Minister of any officer acting under his authority, stating that a notice has under subregulation (3) been issued in respect of a particular person shall have the effect of such notice: Provided that if any such telegraphic or similar written or printed communication is used in lieu of the notice in question, the Minister or the said officer shall as soon as possible forward the notice to the head of the prison referred to in subregulation (3) where the person to whom the notice applies is to be detained under such notice."
