## BYLAE

1. (1) In hierdie Regulasies, tensy uit die samehang anders blyk, beteken—

“beampte” ’n beampte soos in die Wet omskryf;

“Departement” die Departement van Onderwys en Opleiding;

“die Wet” die Wet op Onderwys en Opleiding, 1979 (Wet 90 van 1979);

“Direkteur-generaal” die Direkteur-generaal: Onderwys en Opleiding;

“skool” ’n openbare primêre of sekondêre skool soos bedoel in artikel 5 (1) (a) van die Wet;

“streek” ’n streek van die Departement bedoel in artikel 2 (2) van die Wet.

(2) Die instelling van verpligte skoolbesoek in enige gebied kragtens die Wet, doen geen afbreuk aan die geldigheid van enige besluit of voorwaarde kragtens hierdie Regulasies geneem of bepaal nie.

### REGULATIONS IN TERMS OF THE PUBLIC SAFETY ACT, 1953

By virtue of the powers vested in me by section 3 (1) (a) of the Public Safety Act, 1953 (Act 3 of 1953), I hereby make with effect from 14 July 1986 the regulations contained in the Schedule.

## SCHEDULE

1. (1) In these Regulations, unless the context otherwise indicates—

“Act” means the Education and Training Act, 1979 (Act 90 of 1979);

“Department” means the Department of Education and Training;

“Director-General” means the Director-General: Education and Training;

“officer” means an officer as defined in the Act;

“region” means a region of the Department as referred to in section 2 (2) of the Act;

“school” means a public primary or secondary school as referred to in section 5 (1) (a) of the Act.

(2) The institution of compulsory school attendance in any area in terms of the Act, does not detract from the validity of any decision or condition made or imposed in terms of these Regulations.

2. (1) Niemand ontvang vanaf 14 Julie 1986 onderwys aan 'n skool nie tensy hy ingevolge hierdie Regulasies as 'n leerling by die betrokke skool ingeskryf is.

(2) Subregulasie (1) geld ondanks die feit dat iemand reeds ten opsigte van die 1986-skooljaar as 'n leerling by die betrokke skool ingeskryf is.

3. (1) Iemand wat vanaf 14 Julie 1986 onderwys aan 'n skool wil ontvang, moet om inskrywing as 'n leerling by daardie skool aansoek doen.

(2) Die Direkteur-generaal of 'n beampete deur hom daar-toe gemagtig, kan sonder opgaaf van redes en sonder om enigiemand aan te hoor, 'n persoon wat ingevolge subregulasie (1) om inskrywing as 'n leerling by 'n skool aansoek doen, toelating as 'n leerling tot die skool weier of sy toelating onderworpe stel aan die voorwaardes wat hy bepaal.

4. (1) Iemand wat ingevolge hierdie Regulasies as 'n leerling ingeskryf is, word deur die prinsipaal van die betrokke skool in 'n standerd of klas geplaas na gelang van sy vorige bewese skoolprestasie: Met dien verstande dat as 'n beampete in bevel van 'n streek of 'n ander beampete deur hom daar-toe gemagtig daarvan oortuig is dat so 'n plasing soutif is, hy te eniger tyd daardie plasing kan wysig.

(2) 'n Leerling wat weier of versuim om 'n plasing in subregulasie (1) bedoel te aanvaar, word geag die skool vrywillig te verlaat het.

5. Geen interdik of ander prosesstuk word uitgereik vir die opskorting of tersydestelling van 'n besluit of voorwaarde kragtens hierdie Regulasies geneem of bepaal nie.

2. (1) As from 14 July 1986 no person shall receive education at a school unless he is registered in terms of these Regulations as a pupil at the school concerned.

(2) Subregulation (1) shall apply notwithstanding the fact that a person has already been registered as a pupil at the school concerned in respect of the 1986 school year.

3. (1) Any person who wishes to receive education at a school as from 14 July 1986, shall apply for registration as a pupil at that school.

(2) The Director-General or an officer authorised thereto by him, may, without furnishing reasons and without hearing any person, refuse any person applying for registration as a pupil at a school in terms of subregulation (1), admission as a pupil to that school or make his admission subject to such conditions as he may determine.

4. (1) Any person registered as a pupil in terms of these Regulations shall be placed by the principal of the school concerned in a standard or class according to his previous proven scholastic achievement: Provided that if an officer in charge of a region or another officer authorised thereto by him is satisfied that such placement is erroneous, he may alter that placement at any time.

(2) Any pupil who refuses or fails to accept a placement referred to in subregulation (1), shall be deemed to have left the school voluntarily.

5. No interdict or other process shall issue for the staying or setting aside of a decision or condition made or imposed under these Regulations.
