SEA FISHERIES ACT, 1973 (ACT 58 OF 1973)

AMENDMENT OF REGULATIONS

The Minister of Environment Affairs and Tourism has in terms of section 13 of the Sea Fisheries Act, 1973 (Act 58 of 1973), amended the Regulations promulgated in terms of the said Act, as set out in the Schedule hereto.

SCHEDULE

WET OP SEEVISSERYE, 1973 (WET 58 VAN 1973)

WYSIGING VAN REGULASIES

Die Minister van Omgewingsake en Toerisme het kragtens artikel 13 van die Wet op Seevisserye, 1973 (Wet 58 van 1973), die Regulasies uitgevaardig kragtens die genoemde Wet, gewysig soos in die Bylae hierby uiteengesit.

BYLAE

1. By the deletion of the following definitions in regulation 1 of the Regulations:

- "(iii) 'Baleen whale'
- (vii) 'blue whale'
- (viii) 'bryde's whale'
- (xi) 'complete treatment'
- (xiii) 'dauhval'
- (xviii) 'fin whale'
- (xix) 'gray whale'
- (xxi) 'humpback whale'
- (xxiv) 'land station'
- (xxvii) 'minke whale'
- (xxxviii) 'right whale'
- (xliv) 'sei whale'
- (xlvi) 'sperm whale'
- (liv) 'whale catcher'
- (lv) 'whales taken'

2. By the substitution for regulation 19 of the Regulations of the following regulation:

"19. (1) No person shall catch, attempt to catch or disturb any of the following species of fish during the period specified for each species:

- (a) shad (*Pomatomus saltatrix*)—1 September up to and including 30 November in any year;
- (b) galjoen (*Coracinus capensis*), in the Republic, with the exception of the harbour and settlement Walvis Bay—15 October up to and including 28 February in the following year;
- (c) oysters—1 December up to and including 15 January in the following year;
- (d) East coast rock lobster—1 November up to and including 31 January in the following year;
- (e) (i) pelagic fish, in the Republic, with the exception of the harbour and settlement Walvis Bay and the islands mentioned in paragraph (iii) of subregulation (3)—16 December up to and including 14 January in the following year;
 (ii) pelagic fish, in the harbour and settlement Walvis Bay—1 September up to and including 28 February in the following year;
- (f) perlemoen—1 August up to and including 31 October in any year;
- (g) red-steenbras, (*Petrus rupestris*)—1 September up to and including 30 November in any year;
- (h) south coast rock lobster,—1 July up to and including 31 October in any year;
- (i) squid (chokka) (*Loligo reynaudii*), in the area with as western boundary a line (180° true) drawn from the centre of the lighthouse at Cape St. Blaize, and with as eastern boundary a similar line drawn from the mouth of the Great Fish River, as from 1 December up to and including 15 January of the following year: Provided that this prohibition is not applicable to—
 (i) a vessel which is not registered and licensed as a fishing boat in terms of the provisions of the Act;
 (ii) a rock or surf angler or a speargun or boat-fisherman contemplated in regulation 48A;

2. Deur regulasie 19 van die Regulasies deur die volgende regulasie te vervang:

"19. (1) Niemand mag enige van die volgende soorte vis gedurende die tydperk genoem vir elke soort, vang, probeer vang of steur nie:

- (a) elf (*Pomatomus saltatrix*)—1 September tot en met 30 November van elke jaar;
- (b) galjoen, (*Coracinus capensis*) in die Republiek, uitgesonderd die hawe en nedersetting Walvisbaai—15 Oktober tot en met 28 Februarie van die daaropvolgende jaar;
- (c) oesters—1 Desember tot en met 15 Januarie van die daaropvolgende jaar;
- (d) ooskuskreel—1 November tot en met 31 Januarie van die daaropvolgende jaar;
- (e) (i) pelagiese vis, in die Republiek, uitgesonderd die hawe en nedersetting Walvisbaai en die eilande genoem in paragraaf (iii) van subregulasie (3)—16 Desember tot en met 14 Januarie van die daaropvolgende jaar;
 (ii) pelagiese vis, in die hawe en nedersetting Walvisbaai—1 September tot en met 28 Februarie van die daaropvolgende jaar;
- (f) perlemoen—1 Augustus tot en met 31 Oktober van elke jaar;

 (ii) 'n rots-, strand-, spiesgeweer- of boothengelaar bedoel in regulasie 48A;

- (iii) a fishing boat which, in terms of the provisions of the Act had been registered and licensed within the area defined above prior to 1 September 1985, as a fishing boat to catch line fish; and
- (iv) a trawlboat which is registered and licensed as an inshore or deepsea trawler in terms of the provisions of the Act; and
- (j) seventy-four (*Polysteganus undulosus*)—1 September up to and including 30 November in any year.
- (2) Notwithstanding the provisions in subregulation (3), no person shall, in terms of the provisions of regulations 34, catch, attempt to catch or disturb any rock lobster during the period 16 May up to and including 14 November in any year.
- (3) No person on any fishing boat who has been authorised to catch the rock lobster for delivery to a factory in terms of the provisions of regulation 25A, shall catch, attempt to catch or disturb any rock lobster during the period specified and within the specified area, where applicable:
- (i) in the area bounded in the south by a line, 270° true, drawn through a wooden beacon marked YF, situated on the high-water mark approximately 11 kilometres northwards of Yzerfontein opposite the farm Abrahamskraal, and in the north by a similar line, drawn from the southern bank of the mouth of the Orange River, during the period from 1 July up to and including 31 October in any year;
 - (ii) in the area bounded in the north by a line 270° true, drawn through the wooden beacon marked YF, situated on the high-water mark approximately 11 kilometres northwards of Yzerfontein opposite the farm Abrahamskraal, and in the south by a line, 180° true, drawn from the lighthouse at Cape Agulhas, during the period 1 July up to and including 14 November in any year;
 - (iii) in the harbour and settlement of Walvis Bay and the sea surrounding the islands known as Seal, Penguin, Halifax, Long, Possession, Albatros, Pomona, Plumpudding, Ichaboe, Mercury, Hollams Bird, Sinclair and Little Roastbeef, during the period 1 May up to and including 31 October in any year.
- (4) Notwithstanding the provisions of paragraph (e) (i) of subregulation (1), the Director may authorise the owner of a fishing boat licensed to catch pelagic fish, to catch pelagic fish or certain species of pelagic fish for use other than for canning or for the production of fish meal or fish oil, during the periods mentioned.
3. By the substitution for subregulation (2) and (3) of regulation 23 of the Regulations of the following sub-regulations:
- “(2) Catch or disturb any of the following along the sea-shore within a distance of one nautical mile seawards in the area between the eastern boundary of Portion 1 of the farm Walker's Point and the western boundary of the Buffalo Bay Nature Reserve, situated in the Division of Knysna, except for use as bait within the boundaries of the area defined in this subregulation and subject to the condition that no supplies of such bait shall be removed from this area for any purpose whatsoever:
- (a) Perlemoen
 - (b) Red bait
 - (c) White mussels
- (iii) 'n vissersboot wat ingevolge die bepalings van die Wet voor 1 September 1985 binne die gebied hierbo om skryf, as 'n vissersboot vir die vang van lynvis geregistreer en gelisensieer is; en
- (iv) 'n treilboot wat ingevolge die bepalings van die Wet as 'n kustreiler of diepsee-reiler geregistreer en gelisensieer is; en
- (j) vier-en-sewentig (*Polysteganus undulosus*)—1 September tot en met 30 November van elke jaar.
- (2) Ondanks die bepalings van subregulasie (3), mag niemand ingevolge die bepalings van regulasie 34, gedurende die tydperk 16 Mei tot en met 14 November van enige jaar, enige kreef vang, probeer vang of steur nie.
- (3) Niemand op enige vissersboot wat gemagtig is om kreef te vang vir lewering aan 'n fabriek ingevolge die bepalings van regulasie 25A, mag gedurende die tydperk genoem en in die genoemde gebied waarvan toepassing, enige kreef vang, probeer vang of steur nie:
- (i) In die gebied begrens in die suide deur 'n lyn, geografiese ligging 270°, getrek vanaf 'n houtbaken gemerk YF, geleë op die hoogwatermerk ongeveer 11 kilometer noordwaarts vanaf Yzerfontein teenoor die plaas Abrahamskraal, en in die noorde deur 'n soortgelyke lyn getrek vanaf die suidelike oewer van die monding van die Oranjerivier, gedurende die tydperk vanaf 1 Julie tot en met 31 Oktober van elke jaar;
 - (ii) in die gebied begrens in die noorde deur 'n lyn, geografiese ligging 270°, getrek vanaf die houtbaken gemerk YF, geleë op die hoogwatermerk ongeveer 11 kilometer noordwaarts vanaf Yzerfontein teenoor die plaas Abrahamskraal, en in die suide deur 'n lyn, geografiese ligging 180°, getrek vanaf die vuurtoring te Kaap Agulhas, gedurende die tydperk vanaf 1 Julie tot en met 14 November van elke jaar; en
 - (iii) in die hawe en nedersetting van Walvisbaai en die see om die eilande bekend as Seal, Penguin, Halifax, Long, Possession, Albatros, Pomona, Plumpudding, Ichaboe, Mercury, Hollams Bird, Sinclair en Little Roastbeef, gedurende die tydperk vanaf 1 Mei tot en met 31 Oktober van elke jaar.
- (4) Ondanks die bepalings van paragraaf (e) (i) van subregulasie (1), kan die Direkteur die eienaar van 'n vissersboot wat gelisensieer is vir die vang van pelagiese vis, magtig om gedurende die tydperk genoem, pelagiese vis of sekere soorte pelagiese vis te vang vir gebruik uitgesondert vir inmaak of vir die vervaardiging van vismeel en -olie.”
3. Deur subregulasies (2) en (3) van regulasie 23 van die Regulasies deur die volgende subregulasies te vervang:

(3) Catch or disturb any of the following along the sea-shore within a distance of one nautical mile seawards in the Robbeberg Nature Reserve situated in the Division of Knysna as described in Official Gazette 2374 of 17 September 1948, of the Cape of Good Hope, except for use as bait within the boundaries of the Robbeberg Nature Reserve and subject to the condition that no supplies of such bait shall be removed from the said reserve for any purpose whatsoever:

- (a) Oysters
- (b) Perlemoen
- (c) Red bait
- (d) White mussels
- (e) Black mussels
- (f) Polychaete worms
- (g) Sea Crabs
- (h) Octopus."

4. By deleting regulation 23A of the Regulations.
5. By the insertion of the following regulation after regulation 23C of the Regulations.

"23D No person shall, in a manner for any purpose whatsoever within a distance of three nautical miles seaward from the low-water mark—

- (i) in the area between, as southern limit, a line (145° true) drawn from Nahoon Point, and as northern limit, a similar line drawn from Gonubie Point;
- (ii) in the area between, as southern limit, a line (145° true) drawn from Christmas Rock, and as northern limit, a similar line drawn from the southern bank of the Gxulu River mouth; and
- (iii) in the area between, as southern limit, a line (145° true) drawn from the southern bank of the Nyara River mouth, and as northern limit, a similar line drawn from the southern bank of the Great Kei River mouth, catch, attempt to catch or disturb any fish: Provided that the provisions of this regulation shall not apply to anglers fishing from the shore with rods and lines or to any person collecting other marine organisms for bait or human consumption."

6. By the insertion of the following regulation after regulation 24A of the regulations:

"24B No person shall use any trawl net for fishing within the area landwards from a straight line drawn from—

- (i) Robberg Point to the southern bank of the Bloukrans River mouth; and
- (ii) Cape St Francis Point to the lighthouse at Cape Recife."

7. By the substitution for subregulation (3) of regulation 35 of the Regulations of the following subregulation:

"(3) Subject to the provisions of regulation 34, no person shall without the written authority of the Director and subject to such conditions as he may determine, transport or remove from one place to another any rock lobster or rock lobster tails not packed in accordance with the standard specifications of the South African Bureau of Standards, promulgated under Government Notice R. 3964 of 19 December 1969 and/or Government Notice

- (d) Swartmossels
- (e) "Polychaete"-wurms
- (f) Seekrappe
- (g) Seekatte.

- (i) in die gebied tussen, as suidelike grens, 'n lyn (geografiese ligging 145°) getrek vanaf Nahoonpunt, en as noordelike grens, 'n soortgelyke lyn getrek vanaf Gonubiepunt;
- (ii) in die gebied tussen, as suidelike grens, 'n lyn (geografiese ligging 145°) getrek vanaf Christmasrots, en as noordelike grens, 'n soortgelyke lyn getrek vanaf die suidelike wal van die Gxuluviermonding; en
- (iii) in die gebied tussen, as suidelike grens, 'n lyn (geografiese ligging 145°) getrek vanaf die suidelike wal van Nyaraviermonding, en as noordelike grens, 'n soortgelyke lyn getrek vanaf die suidelike wal van die groot Keiriviermonding, enige vis vang, probeer vang of steur nie: met dien verstande dat die bepalings van hierdie regulasie nie op hengelaars wat vanaf die strand met stokke en lyne visvang of op enige persoon wat ander mariene organismes vir aas of menslike verbruik versamel, van toepassing is nie."

"24B Niemand mag binne die gebied landwaarts vanaf 'n reguit lyn getrek vanaf—

- (i) Robbergpunt tot by die suidelike wal van die Bloukransriviermonding; en
- (ii) Kaap St Francispunt tot by die vuurtoring te Kaap Recife,

enige treilnet vir visvang gebruik nie."

7. Deur subregulasie (3) van regulasie 35 van die regulasies met die volgende subregulasie te vervang:

"(3) Behoudens die bepalings van regulasie 34, mag niemand sonder die skriftelike magtiging van die Direkteur en onderhewig aan die voorwaardes wat hy bepaal, enige kreef of kreefsterte wat nie ooreenkomsdig die bepalings van die standaardspesifikasies van die Suid-Afrikaanse Buro vir Standaarde, afgekondig by Goewermentskennisgewing R. 3964 van 19 Desember 1969 en/of Goewermentskennisgewing R. 357 van 10 Maart 1972, kragtens die Wet op Standaarde, 1982

- R. 357 of 10 March 1972, in terms of the Standards Act, 1982 (Act 30 of 1982) or packed in live form in a licensed rock lobster packing factory.”
8. By deleting regulation 43 of the Regulations.
 9. By the insertion of the following words at the end of subregulation (1) of regulation 45 of the Regulations:
“White steenbras (*Lithognathus aureti*): 40 cm.”
 10. By the insertion of the following subregulation in regulation 45 of the Regulations:
“(3) No person shall sell or offer for sale any broadbill swordfish (*Xiphias gladius*): Provided that the provisions of this subregulation shall not apply to the selling or offering for sale of broadbill swordfish caught as a by-catch by means of longlines or trawlnets.”.
 11. By deleting the words “for own use” where it appears in subregulation (1) of regulation 57 of the Regulations.
 12. By the substitution for Schedule B of the Regulations of the following Schedule B:
