460.07	By the substitution for paragraph (2) of tariff heading No. 39.01 of the following: “(2) Plates, sheets, film, foil and strip, of polyethylene terephthalates, pressure-sensitive, with removable protective substances, in such quantities, at such times and subject to such conditions as the Director-General: Trade and Industry, on the recommendation of the Board of Trade and Industries, may allow by specific permit	Full duty”

Note.—The provision for a rebate of the duty on pressure-sensitive plates, sheets, film, foil and strip, of polyethylene terephthalates, with disposable backing, in such quantities, at such times and subject to such conditions as the Director-General: Trade and Industry, on the recommendation of the Board of Trade and Industries, may allow by specific permit, is extended to also include those products with removable protective substances.
