CUSTOMS AND EXCISE ACT, 1964

AMENDMENT OF SCHEDULE 2 (No. 2/2)

Under section 56 of the Customs and Excise Act, 1964—

- (1) Part 1 of Schedule 2 to the said Act is hereby amended, with retrospective effect to 18 December 1987, to the extent set out in the Schedule hereto; and
- (2) the anti-dumping duty now imposed supersedes the provisional charge to anti-dumping duty promulgated in Government Notice R. 2831 of 18 December 1987.
