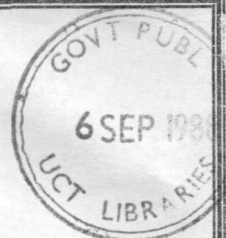

Any rate of surcharge specified in this Part in respect of live animals of headings Nos. 01.01, 01.02, 01.03 and 01.04 of Part 1 shall not apply to any such animals entered for home consumption on or before 30 September 1988, in such numbers as the Commissioner may allow by specific permit after proof has been furnished that the importer was in possession of a permit issued on or before 31 August 1988 by the Director-General: Agriculture Economics and Marketing in terms of the Livestock Improvement Act, 1977 (Act No. 25 of 1977)."
