PUBLIC SAFETY ACT, 1953

ORDERS UNDER THE UNREST REGULATIONS,
1991

I, Johannes Velde van der Merwe, Commissioner of the South African Police, hereby under regulation 7 of the Unrest Regulations, 1991, promulgated under section 5A of the Public Safety Act, 1953 (Act No. 3 of 1953), in Government Notice No. R. 1082 of 11 May 1991, issue the orders contained in the Schedule.

SCHEDULE

Interpretation

1. In this Schedule any word or expression to which a meaning has been assigned in the Unrest Regulations, 1991, has the meaning so assigned to it.

Application

2. These orders shall apply in any area (in this Schedule referred to as "an area"), mentioned in Column 2 of the Addendum to this Schedule, and which is situated in an unrest area mentioned in Column 1 of that Addendum.

Prohibition on holding of certain gatherings

3. (1) With effect from the date of publication of the notice whereby these orders are published, until 23 May 1991, the holding of any gathering in any area in the open air, excluding any *bona fide* sports meeting, a *bona fide* religious meeting, or a burial, is, except where such gathering is held in accordance with the condition mentioned in subparagraph (2), hereby prohibited.

Ek, Johannes Velde van der Merwe, Kommissaris van die Suid-Afrikaanse Polisie, reik hierby kragtens regulasie 7 van die Onrusregulasies, 1991, afgekondig kragtens artikel 5A van die Wet op Openbare Veiligheid, 1953 (Wet No. 3 van 1953), by Goewermenskennisgewing No. R. 1082 van 11 Mei 1991, die bevel vevat in die Bylae uit.

BYLAE

Uitleg

1. In hierdie Bylae dra enige woord of uitdrukking waaraan 'n betekenis in die Onrusregulasies, 1991, geheg word, die betekenis aldus daaraan geheg.

Toepassing

2. Hierdie bevel is van toepassing in enige gebied (in hierdie Bylae " 'n gebied" genoem), vermeld in Kolom 2 van die Aanhangsel by hierdie Bylae, en wat geleë is in 'n onrusgebied vermeld in Kolom 1 van daardie Aanhangsel.

Verbod op hou van sekere byeenkomste

3. (1) Met ingang vanaf die datum van publikasie van die kennisgewing waarby hierdie bevel gepubliseer word, tot 23 Mei 1991, word die hou in enige gebied van enige sportbyeenkoms, 'n *bona fide*-sportbyeenkoms, 'n *bona fide*-godsdienstige byeenkoms of 'n begrafnis, behalwe waar so 'n byeenkoms gehou word ooreenkomstig die voorwaarde vermeld in subparagraaf (2), hierby verbied.

(2) A gathering in the open air, referred to in subparagraph (1), may only be held if the prior approval of the Commissioner has been obtained for the time, date and place of the gathering.

Prohibition on certain actions

4. No person shall attend any gathering in the open air, referred to in paragraph 3 (1), or remain present there, if the condition mentioned in paragraph 3 (2) has not been complied with.

(2) 'n Byeenkoms in die ope lug, bedoel in subparagraaf (1), mag slegs gehou word indien die goedkeuring van die Kommissaris vir die tyd, datum en plek van die byeenkoms vooraf verkry is.

Verbod op sekere handeling

4. Geen persoon mag 'n byeenkoms in die ope lug, bedoel in paragraaf 3 (1), bywoon of daarby aanwesig bly, indien daar nie voldoen is aan die voorwaarde vermeld in paragraaf 3 (2) nie.
