INDIANS EDUCATION ACT, 1965

AMENDMENT OF THE REGULATIONS RELATING
TO THE ESTABLISHMENT OF PARENT TEACHER
ASSOCIATIONS AT STATE AND STATE-AIDED
PRIMARY AND SECONDARY SCHOOLS

The Minister of Education and Culture has, under
section 31 of the Indians Education Act, 1965 (Act No.
61 of 1965), made the regulations contained in the
Schedule hereto.

SCHEDULE

1. In this Schedule "the Regulations" means the
regulations published under Government Notice No.
R. 1224 of 30 May 1991.

2. Regulation 7 of the Regulations is hereby
amended by the substitution in subregulation (1) (a) for
the expression "one month" of the expression "three
months".

3. Regulation 8 of the Regulations is hereby
amended by the substitution in subregulation (2) for the
expression "seven" of the expression "30".

4. Regulation 13 of the Regulations is hereby
amended by the substitution for subregulation (5) (c) of
the following:

"(c) after consultation with the members of the asso-
ciation concerned, decide on and publicly declare the
date, time and place for the first meeting of the asso-
ciation, which date shall not be later than 30 days after
the date of the inaugural meeting; and".

BYLAE

1. In hierdie Bylae beteken "die Regulasies" die
regulasies afgekondig by Goewermentskennisgewing
No. R. 1224 van 30 Mei 1991.

2. Regulasie 7 van die Regulasies word hierby
gewysig deur in subregulasie (1) (a) die uitdrukking
"een maand" deur die uitdrukking "drie maande" te
vervang.

3. Regulasie 8 van die Regulasies word hierby
gewysig deur in subregulasie (2) die uitdrukking
"sewe" deur die uitdrukking "30" te vervang.

4. Regulasie 13 van die Regulasies word hierby
gewysig deur subregulasie (5) (c) deur die volgende te
vervang:

"(c) na oorlegpleging met die lede van die betrokke
vereniging, die datum, tyd en plek vir die eerste ver-
gadering van die vereniging bepaal en in die openbaar
bekendmaak, welke datum uiterlik 30 dae na die datum
van die stigtingsvergadering is; en".
