MEAT SCHEME: LEVIES AND SPECIAL LEVIES: AMENDMENT

(a) the Meat Board referred to in section 6 of the Meat Scheme published by Government Notice No. R. 237 of 7 February 1991, has under section 26 of the said Scheme amended the Schedule to Government Notice No. R. 1031 of 8 May 1991 to the extent set out in the Schedule hereto; and

(b) the said amendment has been approved by me and shall come into operation on 1 July 1991.
