ADMINISTRATION OF ESTATES ACT, 1965
(ACT No. 66 OF 1965)

AMENDMENT OF REGULATIONS

The Minister of Justice has, under section 103 of the Administration of Estates Act, 1965 (Act No. 66 of 1965), made the regulations in the Schedule.

SCHEDULE

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 473 of 24 March 1972, as amended by Government Notices Nos. R. 817 of 13 May 1977, R. 1209 of 13 June 1980, R. 2542 of 20 November 1981, R. 2482 of 1 November 1985, R. 655 of 11 April 1986, R. 2738 of 11 December 1987, R. 610 of 31 March 1989, R. 1208 of 9 June 1989 and R. 1921 of 17 August 1990.

2. Regulation 8 of the Regulations is hereby amended by—

(a) the substitution for subregulation (1) of the following subregulation:

"(1) The executor's remuneration referred to in section 51 (1) (b) of the Act shall be assessed according to the following tariff:

- (a) On the gross value of assets in an estate: 3,5 per cent;
- (b) on income accrued and collected after the death of the deceased: 6 per cent:

Provided that the remuneration in respect of any deceased estate shall not be less than R350.";

(b) the substitution for subregulation (3) of the following subregulation:

"(3) The remuneration of tutors and curators referred to in section 84 (1) (b) of the Act shall be assessed according to the following tariff:

- (a) On income collected during the existence of the tutorship or curatorship: 6 per cent;
- (b) on the value of capital assets on distribution, delivery or payment thereof on termination of the tutorship or curatorship: 2 per cent."

3. The provisions of regulation 2 (a) of these regulations shall apply only to the estate of a person who dies on or after the date of publication of these regulations in the *Gazette*.

BOEDELWET, 1965 (WET No. 66 VAN 1965)

WYSIGING VAN REGULASIES

Die Minister van Justisie het kragtens artikel 103 van die Boedelwet, 1965 (Wet No. 66 van 1965), die regulasies in die Bylae uitgevaardig.

BYLAE

1. In hierdie Bylae beteken "die Regulasies" die regulasies afgekondig by Goewermentskennisgewing No. R. 473 van 24 Maart 1972, soos gewysig by Goewermentskennisgewings Nos. R. 817 van 13 Mei 1977, R. 1209 van 13 Junie 1980, R. 2542 van 20 November 1981, R. 2482 van 1 November 1985, R. 655 van 11 April 1986, R. 2738 van 11 Desember 1987, R. 610 van 31 Maart 1989, R. 1208 van 9 Junie 1989 en R. 1921 van 17 Augustus 1990.

2. Regulasie 8 van die Regulasies word hierby gewysig deur—

(a) subregulasie (1) deur die volgende subregulasie te vervang:

"(1) Die eksekuteursvergoeding in artikel 51 (1) (b) van die Wet bedoel, word ooreenkomstig die volgende tarief bereken:

- (a) Op die bruto waarde van bates in 'n boedel: 3,5 persent;
- (b) op inkomste opgeloopt en ingevorder na die dood van die oorledene: 6 persent:

Met dien verstande dat die vergoeding ten opsigte van enige bestorwe boedel nie minder as R350 is nie.";

(b) subregulasie (3) deur die volgende subregulasie te vervang:

"(3) Die vergoeding aan voogde en kurators in artikel 84 (1) (b) van die Wet bedoel, word ooreenkomstig die volgende tarief bereken:

- (a) Op inkomste ingevorder tydens die bestaan van die voogdyskap of kuratorskap: 6 persent;
- (b) op die waarde van kapitaal bates by verdeling, oorhandiging of uitbetaling daarvan by beëindiging van die voogdyskap of kuratorskap: 2 persent."

3. Die bepalings van regulasie 2 (a) van hierdie regulasies is slegs van toepassing op die boedel van 'n persoon wat te sterwe kom op of na die datum van publikasie van hierdie regulasies in die *Staatskoerant*.
