WITHDRAWAL OF NOTICES UNDER THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by section 5A of the Public Safety Act, 1953 (Act No. 3 of 1953), I, Adriaan Johannes Vlok, Minister of Law and Order, hereby withdraw, with effect from 7 August 1991—

(a) Government Notice No. R. 1082 of 11 May 1991, whereby the Magisterial District of Westonaria, including the area known as Bekkersdal, and the Magisterial District of Krugersdorp, including the areas known as Kagiso, Munsieville and Swanesville Squatters' Settlement, were declared to be unrest areas;

(b) the declaration of the Magisterial District of Kempton Park, including the area known as Tembisa, which was declared to be an unrest area by Government Notice No. R. 529 of 11 March 1991.
