 Principal or Headmaster District in which school is situated.
 (b) School, training college, technical college and college of education established by or in terms of a law:
 Principal, Headmaster, Rector, Deputy Principal, Deputy Headmaster and Vice-Rector
 District in which school or college is situated.
 (c) Educational auxiliary services and professional components:
 Incumbent of a post at post level 6 and higher... Republic.;"

(c) by the insertion after item 19 of the following item:

"19A. Foundation for Research Development including the National Accelerator Centre, the South African Astronomical Observatory and the Hartebeesthoek Radio Astronomy Observatory:

President, Vice-President, Directors of divisions and of national research facilities, Financial Manager, Group Accountant, Accountant, Personnel Manager, Senior Personnel Officer, Programme Manager and Manager of a department

Republic."; and

(d) by the insertion after item 47 of the following item:

"47A. South African Housing Trust Limited:

Managing Director, General Manager, Assistant General Manager, Senior Manager and Quality Assurance Assistant Republic."
