1982 (Act No. 19 of 1982), made the regulations in the

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the
regulations published by Government Notice No.
R. 2085 of 1 October 1982, as amended by the regula-
tions published by Government Notices Nos. R. 1994
of 11 September 1987 (as corrected by Government
Notice No. R. 2199 of 2 October 1987), R. 397 of 4
March 1988, R. 1067 of 17 May 1991 and R. 11 of 3
January 1992.
