**Gelde aan registrator betaalbaar**

2. Die gelde wat vir 'n doel in kolom 1 van Tabel 1 vermeld, aan die registrator betaalbaar is, is soos in kolom 2 van genoemde Tabel daarteenoor aangedui.

**Gelde aan koöperasies betaalbaar**

3. Die gelde wat vir 'n doel in kolom 1 van Tabel 2 vermeld, aan 'n koöperasie betaalbaar is, is soos in kolom 2 van genoemde Tabel daarteenoor aangedui.

**Besoldiging van likwidateurs**

4. 'n Likwidateur is ingevolge artikel 198 (1) van die Wet, geregig op die besoldiging vir sy dienste volgens die skaal in Tabel 3 uiteengesit: Met dien verstande dat indien die totale besoldiging van 'n likwidateur, volgens die skaal bereken, minder as R1 000 is, die Minister 'n bedrag wat hy billik ag, as sodanige besoldiging kan bepaal.

CO-OPERATIVES ACT, 1981  
(ACT No. 91 OF 1981)

## PRESCRIBED FEES

The Minister of Agriculture has under section 240 of the Co-operatives Act, 1981 (Act No. 91 of 1981)—

- (a) made the regulations in the Schedule;
- (b) repealed Government Notices Nos. R. 2741 of 18 December 1981 and R. 1505 of 12 July 1985; and
- (c) determined that the said regulations and repeal shall come into operation on 1 May 1992.

**SCHEDULE****Definition**

1. Any word or expression in these regulations to which a meaning has been assigned in the Act shall have that meaning, and "the Act" means the Co-operatives Act, 1981 (Act No. 91 of 1981).

**Fees payable to registrar**

2. The fees payable to the registrar for a purpose specified in column 1 of Table 1 shall be as indicated in column 2 of the said Table opposite thereto.

**Fees payable to co-operatives**

3. The fees payable to a co-operative for a purpose specified in column 1 of Table 2 shall be as indicated in column 2 of the said Table opposite thereto.

**Remuneration of liquidators**

4. A liquidator shall in terms of section 198 (1) of the Act be entitled to the remuneration for his services in accordance with the scale set out in Table 3: Provided that if the total remuneration of a liquidator, calculated in accordance with the scale, is less than R1 000, the Minister may determine an amount which he regards as reasonable, as such remuneration.

- (vii) "Marpol 73/78" means the Convention;
- (viii) "proper officer" means the principal officer of the office of the Marine Division at Cape Town, Durban, Port Elizabeth, Walvis Bay, East London, Saldanha, Mossel Bay or Richards Bay;
- (ix) "The Act" means the International Convention for the Prevention of Pollution from Ships Act, 1986 (Act No. 2 of 1986);
- (x) "TGT" means the largest gross registered tonnage of a ship.

#### APPLICATION

2. These regulations shall apply to an inspection, survey, issue of a certificate or other function performed by a surveyor or other officer in the service of the Government of the Republic, in relation to the provisions of the Act or the Convention.

#### BY WHOM FEES SHALL BE PAYABLE

3. The fees prescribed by these regulations for the survey or inspection of a vessel shall be payable by the owner of such vessel or his agent, and the fees prescribed for any other service shall be payable by the person requesting such service.

#### WHEN FEES SHALL BE PAYABLE

4. The appropriate fee shall be payable at the time specified by the proper officer of each office of the Marine Division: Provided that no certificate contemplated in these regulations shall be issued unless the prescribed fee has been paid.

#### TO WHOM FEES SHALL BE PAYABLE

5. The fees prescribed by these regulations shall be payable to the proper officer, who shall issue a receipt for the amount paid.

#### ISSUE OF CERTIFICATES

6. (1) Subject to the provisions of subregulation (2), the fees prescribed by these regulations shall cover the issue of the certificate or other document mentioned in the respective regulations.
