Hierby word vir algemene inligting bekendgemaak dat die Staatspresident kragtens artikel 35 (1) van die Staatsdienswet, 1984 (Wet No. 111 van 1984), die volgende regulasies uitgevaardig het:

Die Staatsdiensregulasies gepubliseer by Goewermentskennisgewing No. 2047 van 11 Desember 1959, soos gewysig, word hierby verder gewysig deur—

- in regulasie A19.2 (a) die woord "aangewys" na die woorde " 'n geregistreerde geneesheer" te skrap en die woorde "saamgestel, deur die Direkteur-generaal: Gesondheid, Welsyn en Pensioene of 'n beampte deur hom daartoe gemagtig" te vervang deur die woorde "aangewys of saamgestel deur 'n beampte wat daartoe gemagtig is kragtens regulasie A5.1"; en
- in regulasie A19.2 (b) die woorde "geneesheer of 'n" in te voeg na die woorde "verslag van 'n".

For general information it is hereby notified that the State President has, under the powers vested in him by section 35 (1) of the Public Service Act, 1984 (Act No. 111 of 1984), issued the following regulations:

The Public Service Regulations, published under Government Notice No. 2047 of 11 December 1959, as amended, are hereby further amended by—

- the substitution in regulation A19.2 (a) of the words "indicated or constituted by an officer authorised thereto in terms of regulation A5.1" for the words "indicated or constituted by the Director-General: Health, Welfare and Pensions or an officer authorised thereto by him"; and
- the deletion in regulation A19.2 (b) of the word "the" after the words "the report of" and the insertion of the words "a medical practitioner or a" after the words "the report of".
