MARKETING ACT, 1968  
(ACT No. 59 OF 1968)

#### WOOL SCHEME: LEVY

I, André Isak van Niekerk, Minister of Agriculture, hereby make known under section 79 of the Marketing Act, 1968 (Act No. 59 of 1968), that—

- the South African Wool Board referred to in section 6 of the Wool Scheme published by Proclamation No. R. 155 of 1972, as amended, has under section 22 of the said Scheme imposed the levy set out in the Schedule;
- the said levy has been approved by me and shall come into operation on 1 July 1993; and
- Government Notice No. R. 1391 of 26 June 1987, as amended by Government Notices Nos. R. 2145 of 25 September 1987, R. 1274 of 1 July 1988, R. 944 of 12 May 1989, R. 1239 of 8 June 1990, R. 1467 of 28 June 1991 and R. 1843 of 30 June 1992 is repealed with effect from the said date of commencement.

**Imposition of levy**

2. A levy is hereby imposed on all wool—  
 (a) that is imported into the Republic;  
 (b) that is exported from the Republic;  
 (c) that is received by a processor of wool or a processor of wool on skins;  
 (d) that is sold through an agent at an auction.

**Amount of levy**

3. The amount of the levy referred to in clause 2 shall be 5 per cent—

- (a) of the gross selling price thereof; or  
 (b) in the case of wool on skins, the gross value thereof.

**MARKETING ACT, 1968**  
 (ACT NO. 59 OF 1968)

**PROHIBITION OF THE SALE OF WOOL EXCEPT THROUGH THE SOUTH AFRICAN WOOL BOARD OR TO CERTAIN REGISTERED PERSONS: REVOCATION**

I, André Isak van Niekerk, Minister of Agriculture, hereby make known in terms of section 79 of the Marketing Act, 1968 (Act No. 59 of 1968), that—

- (a) the South African Wool Board referred to in section 6 of the Wool Scheme published by Proclamation No. R. 155 of 1972, as amended, has under section 35 of the said Scheme revoked the prohibition set out in the Schedule to Government Notice No. R. 1406 of 11 August 1972;  
 (b) the said revocation has been approved by me and shall come into operation on 1 July 1993; and  
 (c) Government Notice No. R. 1406 of 11 August 1972 is revoked with effect from the said date of commencement.

 (d) deur bemiddeling van 'n agent op 'n veiling verkoop word.

**Bedrag van heffing**

3. Die bedrag van die heffing in klousule 2 bedoel, is 5 persent—

- (a) van die bruto verkoopprys daarvan; of  
 (b) in die geval van wol aan velle, van die bruto waarde van die wol.
