AMENDMENT OF REGULATIONS IN TERMS OF  
THE LAND SURVEY ACT, 1927 (ACT No. 9 OF 1927)

The Survey Regulations Board has, in terms of section 6 and 7 of the Land Survey Act, 1927 (Act No. 9 of 1927), and with the approval of the Deputy Minister of Land Affairs made the regulations set out in the Schedule.

### SCHEDULE

1. In this Schedule "the Regulations" means the Regulations promulgated by Government Notice No. R. 1814 of 2 November 1962, as amended by Government Notices Nos. R. 1395 of 11 September 1964, R. 533 of 21 April 1967, R. 1033 of 20 June 1969, R. 1126 of 4 July 1969, R. 2008 of 20 November 1970, R. 959 of 9 June 1972, R. 1804 of 13 October 1972, R. 2320 of 13 December 1974, R. 844 of 20 May 1977, R. 1817 of 24 August 1979, R. 1445 of 10 July 1981, R. 2562 of 27 November 1981, R. 178 of 28 January 1983, R. 291 of 24 February 1984, R. 1020 of 10 May 1985, R. 657 of 11 April 1986, R. 1577 of 17 July 1987, R. 1578 of 17 July 1987, R. 2018 of 18 September 1987, R. 829 of 28 April 1989, R. 2022 of 31 August 1990, R. 848 of 19 April 1991, R. 2430 of 4 October 1991, R. 664 of 28 February 1992 and R. 1696 of 26 June 1992.

WYSIGING VAN REGULASIES INGEVOLGE DIE  
OPMETINGSWET, 1927, (WET NO. 9 VAN 1927)

Die Opmetingsregulasieraad het kragtens artikel 6 en 7 van die Opmetingswet, 1927 (Wet No. 9 van 1927), en met die goedkeuring van die Adjunkminister van Grondsake, die regulasies in die Bylae uitgevaardig.

### BYLAE

1. In hierdie Bylae beteken "die Regulasies" die Regulasies afgekondig by Goewermentskennisgewings Nos. R. 1395 van 11 September 1964, R. 533 van 21 April 1967, R. 1033 van 20 Junie 1969, R. 1126 van 4 Julie 1969, R. 2008 van 20 November 1970, R. 959 van 9 Junie 1972, R. 1804 van 13 Oktober 1972, R. 2320 van 13 Desember 1974, R. 844 van 20 Mei 1977, R. 1817 van 24 Augustus 1979, R. 1445 van 10 Julie 1981, R. 2562 van 27 November 1981, R. 178 van 28 Januarie 1983, R. 291 van 24 Februarie 1984, R. 1020 van 10 Mei 1985, R. 657 van 11 April 1986, R. 1577 van 17 Julie 1987, R. 1578 van 17 Julie 1987, R. 2018 van 18 September 1987, R. 829 van 28 April 1989, R. 2022 van 31 Augustus 1990, R. 848 van 19 April 1991, R. 2430 van 4 Oktober 1991, R. 664 van 28 Februarie 1992 en R. 1696 van 26 Junie 1992.

2. Regulation 7 of the Regulations is hereby amended by the addition of the following subregulation after subregulation (2A):

"(2B) Equipment systems which make use of signals from earth satellites to fix relative positions shall, before being used in a survey for the first time and thereafter when required by the Surveyor-General, be tested by the land surveyor on a test network approved by the Chief Surveyor-General. Test results shall be submitted to the Surveyor-General without delay."

3. The heading of regulation 14 of the Regulations is hereby substituted by the following heading:

"Adoption of Data for Alignment Purposes".

4. Regulation 59 of the Regulations is hereby amended by the substitution for the proviso to paragraph (e) of the subregulation (1) by the following proviso:

"Provided that when the original and new survey are based on the same system of co-ordinates, a comparison of the original, surveyed and adopted co-ordinates shall also be furnished;".

5. Regulation 64 of the Regulations is hereby deleted.

6. Regulation 67 of the Regulations is hereby deleted.

7. Regulation 68 of the Regulations is hereby deleted.

8. Annexure A of the Regulations is hereby deleted.

2. Regulasie 7 van die Regulasies word hierby gewysig deur die byvoeging van die volgende subregulasie na subregulasie (2A):

"(2B) Apparatuurstelsels wat seine van aardsatelliete vir die bepaling van relatiewe posisies gebruik moet, voordat hulle vir die eerste maal vir 'n opmeting gebruik word en daarna wanneer die Landmeter-generaal dit vereis deur die landmeter op 'n toetsnetwerk wat deur die Hooflandmeter-generaal goedgekeur is, getoets word. Toetsresultate moet onverwyld aan die Landmeter-generaal voorgelê word."

3. Die opskep by regulasie 14 van die Regulasies word hierby deur die volgende opskep vervang:

"Aanvaarding van Gegewens vir Inlynstellingsdoeleindes".

4. Regulasie 59 van die Regulasies word hierby gewysig deur die voorbehoudbepaling by paraagraaf (e) van subregulasie (1) deur die volgende voorbehoudbepaling te vervang:

"Met dien verstande dat wanneer die oorspronklike en die nuwe opmeting op dieselfde koördinaatstelsel gebaseer is, 'n vergelyking van die oorspronklike, die opgemete en die aanvaardde koördinaatwaardes ook verskaf moet word;".

5. Regulasie 64 van die Regulasies word hierby geskrap.

6. Regulasie 67 van die Regulasies word hierby geskrap.

7. Regulasie 68 van die Regulasies word hierby geskrap.

8. Aanhangesel A by die Regulasies word hierby geskrap.
