WITHDRAWAL OF NOTICE UNDER THE PUBLIC SAFETY ACT, 1953

Under the powers vested in me by section 5A of the Public Safety Act, No. 3 of 1953, I, Hermanus Jacobus Kriel, Minister of Law and Order, hereby withdraw, with effect from 21 September 1993, the declaration of the area mentioned in the Schedule, which area was declared by Government Notice No. R. 1130 of 23 June 1993 to be an unrest area.
