(WET No. 12 VAN 1988)

WYSIGING VAN REGULASIES

Die Minister van Omgewingsake het, na oorleg met die Seevisseraadskomitee, kragtens artikel 45 van die Wet op Seevisserij, 1988 (Wet No. 12 van 1988), die regulasies uitgevaardig kragtens genoemde Wet, gewysig soos in die Bylae uiteengesit.

BYLAE

1. "Die Regulasies" beteken die regulasies afgekondig by Goewermentskennisgewing No. R. 2934 gedateer 23 Oktober 1992, soos gewysig by Goewermentskennisgewings Nos. R. 3248 van 27 November 1992, No. R. 5 van 8 Januarie 1993, No. R. 1052 van 18 Junie 1993 en No. R. 2003 van 15 Oktober 1993.

2. Regulasie 73 van die Regulasies word hierby gewysig deur—

- (a) onderskeidelik subparagrafe (cc) en (dd) van paragraaf (b) (i) van subregulasie (2) met die volgende subparagrafe te vervang:

"(cc) die gaping tussen aangrensende stange gemeet by enige punt, moet minstens 41,6 mm en hoogstens 42,4 mm wees;

(dd) die wydte van die gapings tussen die laaste stang en die raam, mag hoogstens 42,4 mm wees;"

- (b) deur in subregulasie (6) die woorde—

"Met dien verstande dat indien weskuskeef kommersieel in die gebied tussen 'n lyn (ware peiling ongeveer 234°) in die noorde getrek vanaf die monding van die Oranjerivier en 'n lyn (ware peiling 270°) in die suide, getrek vanaf die monding van die Brakrivier gevang word, die maasgroottes

SEA FISHERY ACT, 1988
(ACT No. 12 OF 1988)

AMENDMENT OF REGULATIONS

The Minister of Environment Affairs has, after consultation with the Sea Fishery Advisory Committee, under section 45 of the Sea Fishery Act, 1988 (Act No. 12 of 1988), amended the regulations promulgated in terms of the said Act, as set out in the Schedule.

SCHEDULE

1. "The Regulations" means the regulations published under Government Notice No. R. 2934 dated 23 October 1992 and amended by Government Notices Nos. R. 3248 of 27 November 1992, No. R. 5 of 8 January 1993, No. R. 1052 of 18 June 1993 and No. R. 2003 of 15 October 1993.

2. Regulation 73 of the Regulations is hereby amended by—

- (a) the substitution in subregulation (2), paragraph (b) (i) subparagraphs (cc) and (dd) of the following subparagraphs respectively:

"(cc) the gap between adjoining rods, measured at any point shall be at least 41,6 mm but shall not exceed 42,4 mm;

(dd) the width of the gaps between the last rod and the frame shall not exceed 42,4 mm;"

- (b) by the substitution in subregulation (6) for the words—

"Provided that if west coast rock lobster is commercially caught in the area between a line in the north (approximately 234° true bearing), drawn from the mouth of the Oranje River, and a line in the south (270° true bearing) drawn from the mouth of the Brak River, the mesh of a ringnet shall not

met die volgende woorde te vervang:

“Met dien verstande dat indien wesuskreef kommersieel gevang word die maasgrootte van 'n ringnet nie kleiner nie as 62 mm (gemeet van binnekant van knoop of lasplek tot binnekant van knoop of lasplek) wanneer dit gespan is of met skakels van nie kleiner nie as 31 mm, wees.”

3. Regulasie 78 van die Regulasies word hierby gewysig deur paragraaf (a) met die volgende paragraaf te vervang:

“(a) wesuskreefstert wat van die lyf geskei is, indien die tweede segment van sodanige kreefstert, getel vanaf die aansluiting van die lyf met die stert, minder as 19 mm breed is: Met dien verstande dat wesuskreef wat kommersieel gevang word, die tweede segment van sodanige kreefstert, getel vanaf die aansluiting van die lyf met die stert, nie minder as 18 mm breed mag wees nie.”

4. Regulasie 79 van die Regulasies word hierby gewysig deur paragraaf (a) met die volgende paragraaf te vervang:

“(a) wesuskreef waarvan die kopborsstuk, gemeet volgens die voorgeskrewe metode, kleiner is as 80 mm: Met dien verstande dat in die landdrosdistrik Walvisbaai sodanige kopborsstuk nie kleiner as 65 mm mag wees nie en dat vir kreef wat kommersieel gevang word, sodanige kopborsstuk nie kleiner as 75 mm mag wees nie.”

be less than 62 mm stretched (measured from inside of knot or joint to inside a knot or joint) or 31 mm bar.”

of the following words:

“Provided that if west coast rock lobster is commercially caught the mesh of a ringnet shall not be less than 62 mm stretched (measured from inside of knot or joint to inside of knot or joint) or 31 mm bar.”

3. Regulation 78 of the Regulations is hereby amended by the substitution for paragraph (a) of the following paragraph:

“(a) West coast rock lobster tail which has been severed from the body, if the second segment or such rock lobster tail, counted from the junction of the tail with the body, is less than 19 mm in width: Provided that if west coast rock lobster is commercially caught the second segment of such rock lobster tail, counted from the junction of the tail with the body, shall not be less than 18 mm in width.”

4. Regulation 79 of the Regulations is hereby amended by the substitution for paragraph (a) of the following paragraph:

“(a) West coast rock lobster of which the carapace, measured in the prescribed manner is smaller than 80 mm: Provided that in the Walvis Bay Magisterial District, such carapace may not be smaller than 65 mm and in the case of rock lobster which is commercially caught the carapace shall not be less than 75 mm.”
