3. ANNUAL SERVICE BONUS

The service bonus of a magistrate is the service bonus, including the requirements, conditions and circumstances, which is applicable to a deputy director in the Public Service. Provided that the basis of calculation shall be on the magistrate's gross annual salary at the date on which he qualifies for payment.

4. MOTOR CAR FINANCING BENEFIT FOR REGIONAL COURT PRESIDENT, CHIEF MAGISTRATE AND SPECIAL GRADE CHIEF MAGISTRATE

4. (1) The motor car financing benefit of a chief magistrate is the motor car financing benefit, including the requirements, conditions, circumstances and basis of calculations, which is applicable to a director in the Public Service.

(2) The motor car financing benefit of a regional court president and a special grade chief magistrate is the motor car financing benefit, including the requirements, conditions, circumstances and basis of calculations, which is applicable to a chief director in the Public Service.

5. HOME OWNER'S ALLOWANCE

The home owner's allowance of a magistrate is the home owner's allowance, including the requirements, conditions, circumstances and basis of calculations, which is applicable to a deputy director in the Public Service.

3. JAARLIKSE DIENSBONUS
