No. R. 238

9 February 1996

REGULATIONS UNDER THE PROMOTION OF NATIONAL UNITY AND RECONCILIATION ACT, 1995  
(ACT NO. 34 OF 1995)

The President has under section 40 of the Promotion of National Unity and Reconciliation Act, 1995 (Act No. 34 of 1995), made the regulations in the Schedule.

### SCHEDULE

#### *Definition*

1. In these regulations any word or expression to which a meaning has been assigned in the Act shall bear that meaning and, unless the context otherwise indicates—

“the Act” means the Promotion of National Unity and Reconciliation Act, 1995 (Act No. 34 of 1995).

#### *Application for amnesty*

2. (1) An application for amnesty in terms of section 18 of the Act shall be made in the form of Form 1 of the Annexure.
- (2) The notification referred to in section 19 (4) of the Act shall be given in the form of Form 2 of the Annexure.


