PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

AMENDMENT OF REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

The Minister of Mineral and Energy Affairs has, under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), made the regulations set out in the Schedule.

SCHEDULE

Definition

1. In these regulations "the Regulations" means the regulations published by Government Notice No. R. 130 of 30 January 1996, R. 207 of 6 February 1996 and R. 553 of 1 April 1996.
