PROCLAMATION

by the

President of the Republic of South Africa

No. R. 25, 1996

IMMUNITIES TO BE CONFERRED ON REPRESENTATIVES OF CERTAIN STATES AND INTERNATIONAL ORGANISATIONS PARTICIPATING IN THE INFORMATION SOCIETY AND DEVELOPMENT (ISAD) CONFERENCE TO BE HELD FROM 13 TO 15 MAY 1996 IN THE REPUBLIC OF SOUTH AFRICA

Under section 4 (c) (i) of the Diplomatic Immunities and Privileges Act, 1989 (Act No. 74 of 1989), I hereby confer upon the representatives of certain States and international organisations mentioned in the Schedule, while participating in the Information Society and Development (ISAD) Conference, the immunities mentioned in the Schedule.

SCHEDULE
