MARKETING ACT, 1968 (ACT NO. 59 OF 1968)

MAIZE MARKETING SCHEME: LEVY AND SPECIAL LEVY ON MAIZE: AMENDMENT

I, André Isak van Niekerk, Minister of Agriculture hereby make known in terms of section 79 of the Marketing Act, 1968 (Act No. 59 of 1968), that—

- (a) the Maize Board referred to in section 6 of the Maize Marketing Scheme published by Proclamation No. R. 45 of 1979, as amended, has under sections 23 and 24 of the said Scheme imposed the levy and special levy set out in the Schedule;
- (b) the said levy and special levy have been approved by me and shall come into operation on the date of publication hereof; and
- (c) Government Notice No. R. 654 of 28 April 1995 is amended with effect from the said date of commencement.

SCHEDULE**Definitions**

1. In this Schedule "the Notice" means Government Notice No. R. 654 of 28 April 1995.

Amendment of clause 1 of the Notice

2. Clause 1 of the Notice is hereby amended by the substitution for the definition of "production area" of the following definitions:

"'production area' means the Magisterial Districts of Bergville, Dannhauser, Dundee, Estcourt, Glencoe, Klip River, Newcastle, Paullpietersburg, Piet Retief, Utrecht and Vryheid in the Province of KwaZulu-Natal, the Magisterial Districts of Gordonia, Hartswater, Hay, Herbert, Hopetown, Kenhardt, Kimberley, Philipstown, Prieska and Warrenton in the Province of the Northern Cape, the Magisterial Districts of Ellisras, Letaba, Messina, Phalaborwa, Pietersburg, Potgietersrus, Soutpansberg, Thabazimbi, Warmbaths and Waterberg in the Northern Province, the Magisterial Districts of Amersfoort, Balfour, Barberton, Belfast, Bethal, Carolina, Delmas, Ermelo, Groblersdal, Hoëveldrif, Lydenburg, Middelburg, Moutse, Nelspruit, Pelgrimsrus, Piet Retief, Standerton, Volksrust, Wakkerstroom, Waterval-Boven, Witbank and Witrivier in the Province of Mpumalanga, the Magisterial Districts of Bethlehem, Bethulie, Bloemfontein, Boshof, Bothaville, Botshabelo, Brandfort, Bultfontein, Clocolan, Dewetsdorp, Edenburg, Excelsior, Fauresmith, Ficksburg, Fouriesburg, Frankfort, Harrismith, Heilbron, Hennenman, Hoopstad, Jacobsdal, Jagersfontein, Koffiesfontein, Koppies, Kroonstad, Ladybrand, Lindley, Marquard, Odendaalsrus, Parys, Petrusburg, Philippolis, Reddersburg, Reitz, Rouxville, Sasolburg, Senekal, Smithfield, Theunissen, Trompsburg, Ventersburg, Viljoenskroon, Virginia, Vrede, Vrededorf, Welkom, Wepener, Wesselsbron, Winburg and Zaalon in the Province of the Free State and the Magisterial Districts of Alberton, Benoni, Boksburg, Brakpan, Bronkhorstspruit, Cullinan, Germiston, Heidelberg, Johannesburg, Kempton Park, Krugersdorp, Nigel, Oberholzer, Pretoria, Randburg, Randfontein, Roodepoort, Soshanguve, Springs, Vanderbijlpark, Vereeniging, Westonaria and Wonderboom in the Province of Gauteng: Provided that the following farms situated in the Magisterial District of Kimberley in the Province of the Northern Cape, will not be included in the production area:

- (a) Farm 193 (Rivermead);
- (b) Remaining Extent of Portion 1 of the farm Droogfontein 62;
- (c) Portion 14, Tipperary, of the farm Zoutpansfontein 34;
- (d) Portion 15 of the farm Zoutpansfontein 34 (Madavale);
- (e) Portion 6 (Riverside) of the farm Slyklip North 32;
- (f) Portion 3 of the farm Slyklip North 32;
- (g) Remaining Extent of the farm Nootgedacht 66;
- (h) Portion 6 of the farm Nootgedacht 66; and
- (i) Farm Pax 195."

Amendment of clause 3 of the Notice

3. The following clause is hereby substituted for clause 3 of the Notice:

"Amount of levy and special levy

3. (1) The amount of the levy referred to in clause 2 (1) and 2 (2) shall be R6,31 (R5,53 + 14% VAT) per ton of maize, which amount is made up as follows (VAT excluded):

- (a) Board's administration cost and capital expenditure: R3,38;
- (b) promotional services: R0,36;
- (c) product development and maize grain research: R0,04;
- (d) foreign visits and entertainment of foreign visitors: R0,17;
- (e) legal costs: R0,08;
- (f) operational budget of National Maize Producers Organisation: R0,69;
- (g) contribution to Summer Grain Centre by National Maize Producers Organisation: R0,70; and
- (h) recovery commission: R0,11.

- (2) The amount of the special levy referred to in clause 2 (2) shall be R22,80 (R20,00 + 14% VAT) per ton of maize".

- (a) Plaas 193 (Rivermead);
- (b) Resterende Gedeelte van Gedeelte 1 van die plaas Droogfontein 62;
- (c) Gedeelte 14, Tipperary, van die plaas Zoutpansfontein 34;
- (d) Gedeelte 15 van die plaas Zoutpansfontein 34 (Madavale);
- (e) Gedeelte 6 (Riverside) van die plaas Slyklip North 32;
- (f) Gedeelte 3 van die plaas Slyklip North 32;
- (g) Resterende Gedeelte van die plaas Nooitgedacht 66;
- (h) Gedeelte 6 van die plaas Nooitgedacht 66; en
- (i) Plaas Pax 195."

3. (1) Die bedrag van die heffing in klousule 2 (1) en 2 (2) bedoel, is R6,31 (R5,53 + 14% BTW) per ton mielies, welke bedrag soos volg saamgestel is (BTW uitgesluit):

- (a) Raad se administrasiekoste en kapitaaluitgawes: R3,38;

- (b) promosiedienste: R0,36;
 - (c) produkontwikkeling en mieliegraannavorsing: R0,04;
 - (d) buitelandse reise en onthaal van buitelandse besoekers: R0,17;
 - (e) regskoste: R0,08;
 - (f) bedryfsbegroting van Nasionale Mielieproduente-organisasie: R0,69;
 - (g) bydrae tot Somergraansentrum deur Nasionale Mielieproduente-organisasie: R0,70; en
 - (h) invorderingskommissie: R0,11.
- (2) Die bedrag van die spesiale heffing in klousule 2 (2) bedoel, is R22,80 (R20,00 + 14% BTW) per ton mielies.”.
