PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)

AMENDMENT OF THE REGULATIONS IN RESPECT OF PETROLEUM PRODUCTS

The Minister of Mineral and Energy Affairs has, under section 2 (1) (c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), made the regulations set out in the Schedule.

SCHEDULE

Definition

1. In these regulations "the Regulations" mean the regulations published by Government Notices Nos. R. 130 of 30 January 1996, R. 207 of 6 February 1996, R. 553 of 1 April 1996, R. 734 of 30 April 1996, R. 946 of 4 June 1996 and R. 1088 of 2 July 1996.
