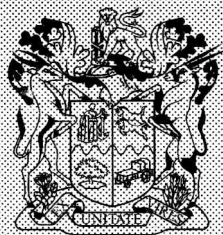

LIVESTOCK BRANDS ACT, 1962 (ACT No. 87 OF 1962)

#### **COMPULSORY BRANDING OF LIVESTOCK\***

I, Angela Thokozile Didiza, Deputy Minister of Agriculture, acting on behalf of the Minister of Agriculture under section 5A of the Livestock Brands Act, 1962 (Act No. 87 of 1962), hereby declare that—

- (a) the branding of cattle and small stock shall be compulsory from 1 December 1996 for the purpose of the said Act in the Magisterial Districts of Albert, Bethlehem, Bloemfontein, Boshof, Bultfontein, Clocolan, Dewetsdorp, Edenburg, Excelsior, Fauresmith, Ficksburg, Frankfort, Harrismith, Heilbron, Hennenman, Hofmeyr, Hoopstad, Jacobsdal, Jagersfontein, Koffiefontein, Koppies, Kroonstad, Ladybrand, Lindley, Marquard, Parys, Petrusburg, Philippolis, Reddersburg, Reitz, Rouxville, Sasolburg, Senekal, Smithfield, Thaba Nchu, Trompsburg, Ventersburg, Viljoenskroon, Virginia, Vrede, Vredefort, Welkom, Wepener, Wesseisbron, Winburg, Witsieshoek and Zastron; and
- (b) the branding of small stock shall be compulsory from 1 December 1996 for the purpose of the said Act in the Magisterial Districts of Bothaville, Fouriesburg, Odendaalsrus and Theunissen.
