**PROCLAMATION UNDER SECTION 20 OF THE PROMOTION OF NATIONAL UNITY
AND RECONCILIATION ACT, 1995
(ACT NO. 34 OF 1995)**

Notice is hereby given that amnesty in terms of section 20(1) of the Promotion of National Unity and Reconciliation Act, 1995 (Act No. 34 of 1995), was granted-

- i) trespassing; and

The Nonprofit Organisations Act, 1997 (Act No. 71 of 1997), makes provision for the establishment of a Panel of Arbitrators to consider appeals against any decision by the Director not to register an organisation or any interested person is invited to forward nominations for consideration by the Minister of Welfare and Population Development for persons to serve on the Panel of Arbitrators.

ROLE OF THE PANEL

The Panel of Arbitrators must consider, in the prescribed manner, any appeal against a decision by the Director not to register an organisation or to remove the name of an organisation from the Register of Nonprofit Organisations.

ROLE OF MEMBERS

Members will be obliged to serve in their individual capacity on a part-time basis. The Terms of conditions for the operation of the Panel have been prescribed by the Minister. Members will be expected to set aside time to consider appeals at the request of the Chairperson. A member will be designated Chairperson by the Minister.

CRITERIA FOR MEMBERSHIP

Candidates should be persons of repute and integrity; have experience and expertise in any of the following areas: dispute resolution, mediation and arbitration; institutional and financial management; nonprofit and development work; legal issues in relation to the nonprofit sector; an understanding of the current developments and challenges of the nonprofit sector in South Africa.
