VETERINARY AND PARA-VETERINARY PROFESSIONS ACT, 1982
(ACT No. 19 OF 1982)

REGULATIONS RELATING TO VETERINARY AND PARA-VETERINARY
PROFESSIONS: AMENDMENT*

The Minister of Agriculture, has under of section 43 of the Veterinary and Para-Veterinary Professions Act, 1982 (Act No. 19 of 1982), -

- (a) made the regulations in the Schedule; and

(b) determined that the said regulations shall come into operation on 1 April 1999.

- * To increase fees payable to the Council in order to provide for the expansion of its activities, and to provide for the registration of veterinary specialist ethologist.

SCHEDULE

Definition

1. In this Schedule "the Regulations" means the regulations published by Government Notice No. R. 2085 of 1 October 1982, as amended by the regulations published by Government Notices Nos. R. 1994 of 11 September 1987 (as corrected by Government Notice No. R. 2199 of 2 October 1987), R. 397 of 4 March 1988, R. 1067 of 17 May 1991, R. 11 of 3 January 1992, R. 976 of 27 March 1992, R. 1477 of 23 September 1994, R. 47 of 20 January 1995, R. 701 of 12 May 1995, R. 561 of 1 April 1996, R. 256 of 14 February 1997, R. 96 of 16 January 1998, R. 501 of 1 April 1998 and R. 751 of 5 June 1998.
