FILMS AND PUBLICATIONS ACT, 1996 (ACT No. 56 OF 1996)

REGULATIONS ON FILMS AND PUBLICATIONS (FEES)

The Minister of Home Affairs has, in terms of section 31 (1) (a) of the Films and Publications Act, 1996 (Act No. 65 of 1996), made the regulations in the Schedule.

SCHEDULE

Definition

In these Regulations "the Act" means the Films and Publications Act, 1996 (Act No. 65 of 1996).

Fees

The fees that shall be payable in respect of any application, exemption, permit or review under this Act, as set out in the Annexure.

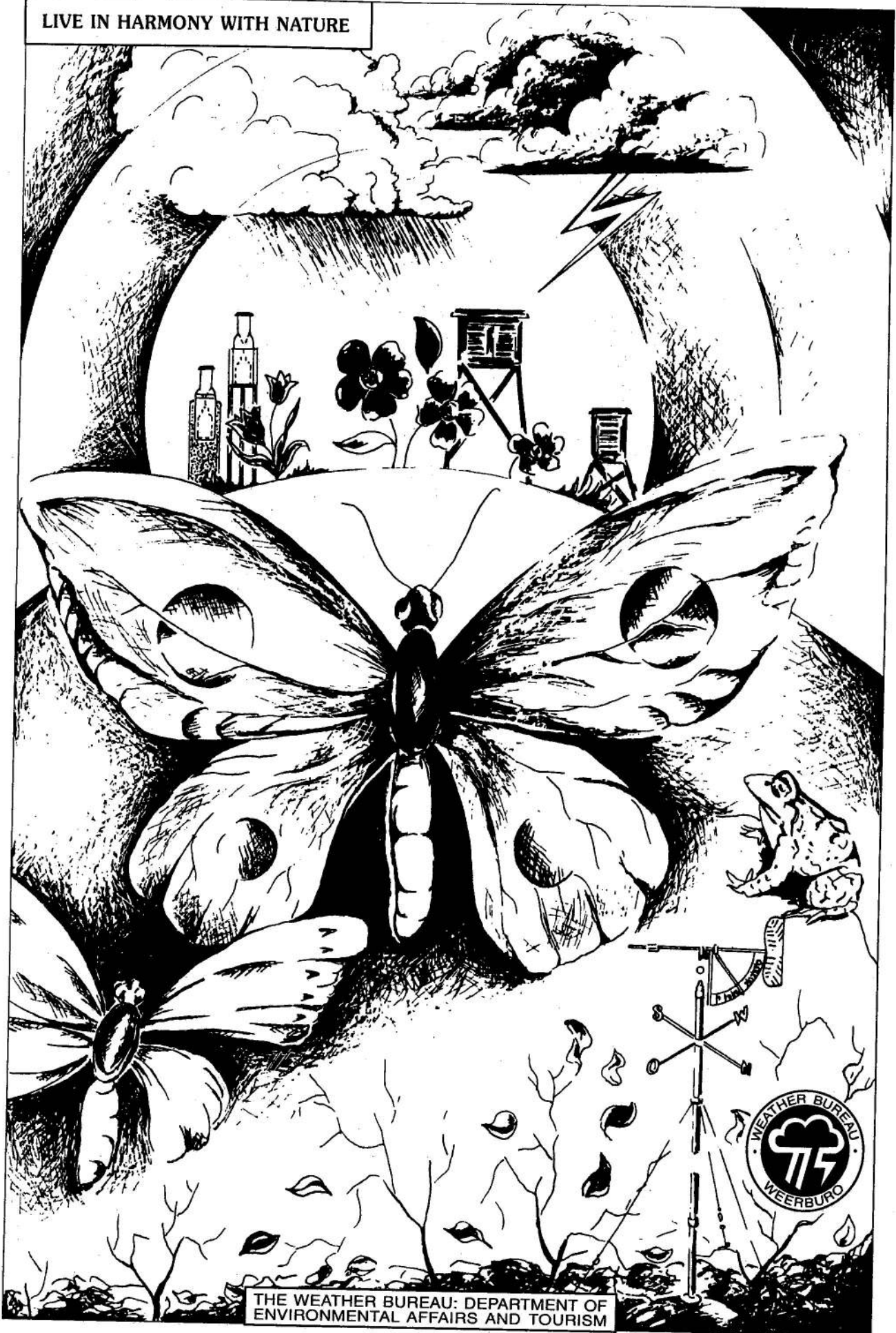
Short title

These Regulations shall be called the Film and Publications Regulations (Fees), 1999, and shall come into operation on 1 June 1999.

1.	Classification of publication following complaint in terms of section 16 (1) of the Act	No fee
2.	Reclassification of publication in terms of section 16 (2) of the Act.....	R110,00
3.	Classification of English language films in 35 mm format	R1 100,00
4.	Classification of films other than in the English language in 35 mm format	R275,00
5.	Classification of English films in video or DVD format	R11,00 per minute of running time
6.	Classification of "adult" films in any format	R8,00 per minute of running time
7.	Classification of films not in English in video or DVD format	R5,50 per minute of running time for the first 90 minutes and R1,10 per minute for running time thereafter
8.	Classification of a trailer, in any format, in any language	R11,00 per minute of running time
9.	Application for a more lenient classification of a film or trailer of a film.....	The fee shall be double the relevant fee set out in items 2, 3, 4, 5, 6, 7 and 8 above, as the case may be
10.	Appeal to the Review Board	The fee shall be as set out in item 9 above
11.	Application for an Exemption	Up to R275,00 in respect of each application at the discretion of the Executive Committee of the Board
12.	Fee for registration of a distributor and/or exhibitor of films	R550,00 in respect of each separate premises to be registered
13.	Classification of a video or DVD wrapper or cover	R11,00 per item
14.	Reclassification of a video or DVD wrapper or cover	R22,00 per item
15.	Copy of certificate	R55,00
16.	Review in terms of section 32 of the Act.....	R10,00 per minute of running time where there have been changes to the version originally classified. Otherwise, no fee is payable
17.	List of all titles classified to date of application	R500,00
18.	List of particular titles classified by the Board.....	R1,00 per title for the first 100 titles and R0,50 per title thereafter
19.	Copy of report of Review Board.....	R100,00 per copy
